Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the accompanying financial statements of Lakeview Christian Home's 403(b) Tax Deferred Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of July 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended July 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lakeview Christian Home's 403(b) Tax Deferred Annuity Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), my audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of July 31, 2022 and 2021, and for the year ended July 31, 2022, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Qualified Opinion

In my opinion, except for the omission of the information described in the Basis for Qualified Opinion section of my report, based on my audit and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all

material respects, in accordance with accounting principles generally accepted in the United States of America.

The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or derived from, in all respects, the information prepared and certified by and institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Qualified Opinion

I have conducted my audits in accordance with auditing standards generally accepted in the United States of America. My responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of my report. I am required to be independent of Lakeview Christian Home 403(b) Tax Deferred Annuity Plan and to meet my other ethical responsibilities, in accordance with the relevant ethical requirements relating to my audits. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my qualified ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Lakeview Christian Home's 403(b) Tax Deferred Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

A. Description of the Plan

The following description of Lakeview Christian Home (the Organization) 403(b) Tax Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Organization established the Plan to provide employees with a systematic means of savings and investing for the future. All permissible employees of the Organization, as defined in accordance with the universal availability standards are eligible to enroll on their date of hire. Deferrals begin on the first day of the month subsequent to enrollment. Participants are eligible to receive employer matching contributions after six months of service. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Contributions – Participants may contribute from 1% to 100% of their base pay by means of payroll deductions, subject to certain discrimination tests prescribed by the Internal Revenue Code and other limitations specified in the Plan. The Organization matches 100% of employee contributions not to exceed 5% of their compensation.

Participant Accounts – Each participant's account is credited with the participant's contributions, allocations of the Organization's matching contributions, and Plan gains or losses. The benefit to which a participant is entitled is the vested benefit that can be provided from the participants' accounts.

Investment Options – Upon enrollment in the Plan, participants may direct the investment of their contributions and the Organization's contributions into various investment contracts and annuity options offered by the plan.

Vesting – Vesting in Organization matching contributions is based on years of service. Prior to normal retirement age, a participant's interest in the contributions of the employer becomes 100% vested after six years of service.

Distributions – Upon retirement age of 59 1/2, disability or death, a participant or beneficiary receives the entire amount credited to the participant's account in either a lump sum or, at the participant's election, in annual installments. Upon termination, other than by retirement, disability, or death, a participant becomes eligible to receive the current value of the participants' vested account in a lump-sum.

A. Description of the Plan (continued)

Participant Investment Rollovers – Participants are allowed to transfer or rollover funds into the Plan from a 403(b), 401(a)/(k), 457(b) governmental, Traditional IRA, or after-tax contributions from other 403(b) plans only.

Forfeitures –Forfeitures are the non-vested portion of a participant’s account that are lost upon termination of employment. Forfeitures are retained in the Plan and will first be used to pay plan administrative expenses, with any remaining amount used to reduce future Company contributions. As of July 31, 2022 and 2021, forfeited non-vested accounts totaled \$1,037 and \$2,441 respectively. For the year ended July 31, 2022, Company matching contributions were reduced by forfeited non-vested accounts by \$1,037.

Notes Receivable from Participants- Effective August 1, 2002, participants may no longer borrow from their fund accounts. Loans made prior to that date are secured by the balance in the participant’s account and bear interest at 4.5%. Principal and interest is paid directly to the Plan’s custodian who is responsible for the collection of loans.

B. Summary of Accounting Policies

Date of Management’s Review – Subsequent events were evaluated through February 15, 2024, which is the date the financial statements were available to be issued.

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America, except for distributions paid to participants which are prepared on the cash basis of accounting.

Use of Accounting Estimates – The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets, liabilities, and disclosures. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Investment Valuation and Income Recognition – At July 31, 2022 and 2021, the Plan’s investments were held in various insurance contracts and annuities and are stated at fair value or contract value which approximates fair value. The net appreciation in the fair value of investments included realized and unrealized gains and losses on the fair value of investments held by the Plan. Purchases and sales of investments are recorded on a settlement date basis. Interest income is accrued as it is earned and dividends are recorded as of the ex-dividend date.

B. Summary of Accounting Policies (continued)

Contributions – Contributions from employees and the Organization are recorded in the period in which the Organization makes the payroll deductions from participant earnings.

Distributions – Distributions are recorded when paid. At July 31, 2022 and 2021, there were no benefits processed and approved for payment, but not paid.

Expenses – Certain of the Plan’s administrative expenses are paid by the Organization. Other expenses such as legal and accounting are paid from plan assets and deducted from participant accounts in accordance with the plan document.

Note Receivable from Participants- Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

D. Tax Status

The plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The Plan Administrator intends to apply for a determination letter on the plan when the government opens such a program. The Plan is required to operate in the conformity with the Code to maintain its tax exemption. Plan management believes the Plan is currently designed and is operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

E. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

F. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

G. Party-in-Interest Transactions

The Plan invests in allocated insurance contracts and annuities sponsored by the plan's custodian, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Administrative fees related to the administration of the Plan are paid by the Plan. Other administrative fees are paid by the Plan sponsor on behalf of the Plan.

H. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are describe as follows:

- Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 31, 2022 and 2021.

Mutual funds: Valued at the net asset value ("NAV") of shares held by the plan at year end.

Fixed Account: Valued at contract value, which approximates fair value.
