## **INDEPENDENT AUDITOR'S REPORT**

### **Note 1: Description of Plan**

The following description of the Corbitt Enterprises, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan and Trust Agreement for more complete information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **General**

The Plan is a defined contribution plan which was adopted and effective July 1, 1998, by the employer, Corbitt Enterprises, Inc. (the “Employer”) and affiliated employers ABC Block, Inc., CB Masonry, Inc., and ABC Equipment, Inc. The Plan covers all employees of the Employer who have attained the age of eighteen or older with at least one year of service and worked 1,000 or more hours of service during that year. Employees will be eligible to participate in the 401(k) employee deferral contributions and Employer contributions on July 1 or January 1 following the satisfaction of the Plan’s eligibility requirements. Effective January 1, 2024, The Setting Every Community Up for Retirement Enhancement (SECURE) Act extended eligibility for participation in 401(k) plans to certain long-term part-time (LTPT) employees. LTPT employees must have three consecutive years of eligible service beginning in 2021 in order to make deferral contributions into the Plan. Eligible service is defined as at least 500 hours of service for each 12-month eligibility period. The eligibility service window applies for plan years beginning after December 31, 2020, and excludes service before that. The Plan Sponsor may still require the employee to satisfy any minimum age requirements, and can also decide whether LTPT employees will receive any portion of employer contributions.

#### **Contributions**

Participants are allowed to contribute up to 100% of their annual compensation not to exceed the limit set by the Internal Revenue Code, which was \$23,000 in 2024 and \$22,500 in 2023. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions of up to an additional \$7,500 in 2024 and 2023. Compensation is defined as total compensation, excluding bonuses, paid to the employee by the Employer that is subject to income tax withholdings, and increased by any compensation reduction election under Code Section 125, 401(k), 403(b), SEP, 414(h) pickup, and 457. The Plan also permits participant rollover contributions from other qualified retirement plans.

The Employer, in its discretion, may make a matching contribution to the Plan allocated in an amount equal to 50% of the Participant’s elective deferrals up to 6% of eligible compensation. The Employer made discretionary Employer matching contributions for Plan years ending December 31, 2024 and 2023. The Employer, in its discretion, may also make a profit sharing contribution to the Plan. No such Employer discretionary profit sharing contributions were made in 2024 or 2023.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s 401(k) contribution and allocations of the Employer’s contribution and Plan earnings. Participants’ accounts will also be charged with an allocation of the Plan’s administrative expenses that are paid by the Plan. Allocations are based on participants’ earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their contributions and any earnings thereon. Vesting in the portion of their account attributable to the Employer's contributions is based on each participant's years of service. Participants are 100% vested after six years of service. A participant will also become fully vested upon death, disability or retirement at age 65 or older.

**Payment of Benefits**

Upon termination of service, a participant may elect to receive payments of his or her vested account in a lump-sum distribution or direct transfer to an eligible retirement plan. Participants are entitled to receive in-service distributions of all or any portion of their fully vested account balances upon the attainment of age 59 ½. Upon proof to the Plan administrator of an immediate financial need permitted by the Plan documents, the participant's account balance may be withdrawn for a hardship purpose.

**Investment Options**

Participants direct the investment of 401(k) contributions into various investment options offered by the Plan through an employee election form. The Plan currently offers 7 Simmons First Trust Company investment fund models which are comprised of one money market fund and 12 mutual funds as investment options for participants.

**Plan Termination**

Although it has not expressed the intent to do so, the Employer has the right under this Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested with respect to the Employer contribution portion of their accounts. Employee contributions and their related earnings are always 100% vested.

**Forfeited Accounts**

Forfeiture account balances will be used to reduce future Employer matching contributions. Forfeitures attributable to nonelective contributions will be used to reduce any nonelective contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$3,871, respectively.

**Note 2: Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value. Under the accrual basis of accounting, revenues and expenses, other than benefit payments, together with the related assets and liabilities are recorded in the accounting period to which they apply, regardless of when the cash transaction occurred.

**Investment Valuation and Income Recognition**

The Plan's investments in money market and mutual funds are stated at fair value as determined by quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and additions and deductions during the reporting period. The Plan administrator's most significant estimate relates to the valuation of investments. It is reasonably possible that a change could occur in the near-term. Actual results could differ from those estimates.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net change in fair value of investments.

**Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Payment of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

The Plan has evaluated all subsequent events for potential recognition and disclosure through July 21, 2025, the date these financial statements were available to be issued.

**Note 3: Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any persons who provide services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such employee association or relatives of such persons and the Plan Employer.

Simmons Bank Trust Division is the Custodian for the Plan. They are by definition a party-in-interest and as a result, all investment transactions were with a party-in-interest. Fees incurred by the Plan for investment management services pursuant to a Master Plan Services Agreement (MSA) between the Employer and custodian are included in net change in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan made a direct payment to the third-party administrator and custodian of \$43,418 in 2024 and \$41,083 in 2023. All remaining administrative expenses were paid by the Employer.

#### **Note 4: Income Tax Status**

The IRS has informed the Employer by a letter dated November 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **Note 5: Fair Value**

Accounting standards define fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. They also establish a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. Following are the three levels of inputs that may be used to measure fair value:

**Level 1:** Quoted prices in active markets for identical assets or liabilities.

**Level 2:** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

**Level 3:** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The following section describes the valuation methodologies the Plan uses to measure financial instruments at fair value:

Money Market Funds: Valued at the net asset value of shares held by the Plan at year end.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses (realized and unrealized) included in changes in net assets for the years ended December 31, 2024 and 2023, are reported in the net changes in fair value of investments in the Statements of Changes in Net Assets Available for Benefits. The Plan's investments (including realized gains and losses on investments bought, sold, and held during the year as well as unrealized appreciation of the investments held at the end of the year) appreciated in value by \$627,370 and \$760,028 in 2024 and 2023, respectively.

#### **Note 6: Information Prepared and Certified by Custodian**

All of the Plan's assets were held by Simmons Bank Trust Division, the Custodian. The amounts set forth in the accompanying financial statements for investments and investment income and the information shown in the supplemental schedules were summarized from information furnished by the Custodian. The Plan administrator has received from the Custodian certification that information furnished by the Custodian is complete and accurate for the years ending December 31, 2024 and 2023. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the information certified by the Custodian was not subjected to any audit procedures except for comparing the information with the related information included in the financial statements and supplemental schedules.
