Opinion

Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

NOTES TO FINANCIAL STATEMENTS YEARS ENDED DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

General – The California Bankers Association Group Insurance Trust (the “Trust”) makes insurance and other benefits available to the California-based members of the California Bankers Association.

Benefits – The Trust generally provides educational scholarships, long-term disability, employee assistance and death benefits to substantially all full-time employees and their dependents. During 2024, the Trust ceased to provide benefits for long-term disability, employee assistance and death benefits to the members of the California Bankers Association.

Contributions – Member contributions varied depending on requirements of various applicable group plans, prior to the termination of the certain member benefits.

Trust Termination – Under certain conditions, the Trust may be terminated. Upon termination, any assets remaining after the payment of all liabilities would be distributed at the discretion of the California Bankers Association ERISA Trust Committee in accordance with applicable laws and regulations.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The Trust’s financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Receivables – The Trust records member contributions at their net realizable values, providing an allowance for doubtful accounts, when necessary, for contributions deemed uncollectible by the Trust’s management based on analysis of specific member accounts and other relevant economic risks and conditions.

Investments – The Trust invests in marketable securities consisting of equity securities and debt securities consisting of investment grade fixed income securities having maturity dates ranging from one to seven years. Investments in equity securities and U.S. Treasury debt securities are reported at fair value, as quoted by US Bank, the Trust’s custodian and Trustee, based on reported market prices obtained from a national exchange or a quoted price. Investments consisting of corporate debt securities are reported at fair value, as quoted by U.S. Bank based on valuations using various market and industry inputs.

Cash and Cash Equivalents – The Trust considers all highly-liquid investments with an original maturity from date of purchase of three months or less to be cash and cash equivalents.

Scholarship Commitments – Scholarship commitments represent future obligations for educational scholarships awarded, which are estimated and recorded when approved by the

Trust's Scholarship Committee. Commitment amounts may be adjusted, if necessary, in subsequent periods based on known facts and circumstances.

Investment Income Recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as well as held during the year.

Tax-exempt Status – The Trust has been granted tax-exempt status by the Internal Revenue Service and the California Franchise Tax Board under section 501(c)(9) of the Internal Revenue Code ("IRC") and section 23701(i) of the California Revenue and Taxation Code, respectively. However, the Trust is taxable on its unrelated business income. For IRC section 501(c)(9) organizations, unrelated business income includes all gross income from nonmembers, which generally includes investment income. The Trust may set aside its investment income for the payment of life, sick, accident or other benefits. The amount allowed as a set aside may not exceed a limit determined by IRC section 419A.

Use of Estimates – In preparing financial statements in conformity with GAAP, Trust management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements, as well as revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events – The Trust's management evaluates events or transactions occurring after the statement of net assets for available for plan benefits date but before the financial statements are available to be issued for potential recognition or disclosure. The financial statements include all subsequent events considered necessary for a fair presentation.

3. FAIR VALUE HIERARCHY

The Trust records its investments in accordance with Accounting Standards Codification ("ASC") 820, *Fair Value Measurement* ("ASC 820"). ASC 820 defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. ASC 820 also establishes a fair value hierarchy, which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

ASC 820 describes the three levels of inputs that may be used to measure fair value:

Level 1: Quoted prices in active markets for identical assets or liabilities.

Level 2: Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3: Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets and liabilities.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The Trust's method of valuing investments may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Trust's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

California Bankers Insurance Services (dba “Banker Benefits”), a wholly owned subsidiary of the California Bankers Association and a party-in-interest, entered into an agreement with the Trust which stipulates that Banker Benefits is to perform program administrative and consulting services for the Trust.

Pursuant to the service agreement with Banker Benefits, California Bankers Association agreed to transfer proceeds from commissions earned from the sale of insurance products to the Trust. During 2024 and 2023, commissions earned from California Bankers Association totaled \$1,530 and \$3,221, respectively, and are presented as a reduction of “Insurance premiums” on the accompanying statements of changes in net assets available for benefits.

US Bank performs trustee services for the Trust and is a party-in-interest. During 2024 and 2023, the Trust paid trustee fees totaling \$14,647 and \$14,514, respectively.

6. CONCENTRATIONS OF CREDIT RISK

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market value, interest rates or other factors in the near term would materially affect investment balances and the amounts reported on the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

7. SCHOLARSHIP PROGRAM COMMITMENTS

The Trust offers scholarship awards and other benefits to employees of member banks each calendar year. Pursuant to an amendment approved in May 2024, the annual amount available for these benefits increased from \$400,000 to \$650,000. Certain scholarships awarded relate to educational programs that extend over a period of up to three years.
