Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ***Isabella Bank Corporation Employee Retirement Plan*** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, 2023, and 2022, the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, the statements of accumulated plan benefits as of December 31, 2023 and 2022, and the related statements of changes in accumulated plan benefits for the years then ended, and the related notes to the financial statements (the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024, 2023, and 2022, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.



Opinion

In our opinion, based on our audits and on the procedures performed as described in the Independent Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Independent Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. DESCRIPTION OF THE PLAN

The following description of the *Isabella Bank Corporation Employee Retirement Plan* (the "Plan") is provided for general information purposes only. Additional information about the Plan agreement, vesting and benefit provisions, and the Pension Benefit Guarantee Corporation's ("PBGC") benefit guarantee is contained in the pamphlet *Employee Retirement Plan - Summary Plan Description*. Copies of this pamphlet are available from the Plan Administrator.

General

The Plan is a defined benefit, non-contributory plan which provides pension, death, and disability benefits to all employees, including leased employees, of Isabella Bank Corporation and Subsidiaries, (the "Corporation") who were 21 years of age or older and who had completed six months of service prior to March 1, 2007. In December 2006, the Board of Directors of the Corporation voted to curtail the defined benefit plan effective March 1, 2007. As a result, current participants' stopped accruing benefits as of March 1, 2007, and participation in the Plan was limited to eligible employees as of December 31, 2006. A participant became fully vested after five years of service; all participants are fully vested. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is governed and operated by Plan Trustees and a Plan administrator, respectively, appointed by the Board of Directors of the Corporation.

Funding Policy

The Plan's funding policy is for the Corporation to contribute such amounts that are greater than or equal to the amounts that are necessary to provide assets sufficient to meet the benefits to be paid to Plan participants. The Corporation's present intention is to make contributions sufficient to annually fund the Plan's current service cost over the period through liquidation of the Plan. The Plan has met the minimum funding requirements prescribed by ERISA. The minimum funding requirement, which is determined by an independent actuary, is equal to the sum of the annual current service contribution attributable to a year's cost for continuous service and the prior service obligation.

Pension Benefits

Employees with five or more years of service on or before March 1, 2007, are entitled to annual pension benefits beginning at normal retirement age (65). The Plan permits early retirement at age 55 for employees with five years of credited service with reduced benefits for each month in excess of 60 months prior to normal retirement. Benefits are based on average compensation and years of service. Average compensation is based on the highest five consecutive years in the last 10 years of service, prior to March 1, 2007. Employees may elect to receive the value of their accumulated plan benefits as a lump sum distribution upon retirement or termination or they may elect to receive their benefits as a life annuity payable monthly from retirement (if the value of the vested benefit is greater than \$5,000).

Death and Disability Benefits

If an active employee dies at pre-retirement age with at least 5 years of service, a benefit is payable to the beneficiary equal to 50% of the vested portion of the employee's accrued normal retirement benefit, reduced for payments prior to age 65 and for election of the joint annuitant option. Active employees who become totally and permanently disabled receive a benefit equal to their accrued benefit actuarially reduced from normal retirement, with payment commencing six months after the date of disability.

Administrative Expenses

The Plan's administrative expenses are paid either by the Plan or the Corporation, as provided by the Plan document. Certain administrative expenses, including an allocation of salaries related to Plan administration, trustee, legal costs, and certain actuarial services, are paid by the Corporation and qualify as party-in-interest transactions, which are exempt from prohibited transaction rules. Expenses that are paid directly by the Corporation are excluded from these financial statements. Fees for investment and Plan administration services are paid by the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, disclosures of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. The net change in fair value of investments includes the Plan's aggregate gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in common collective trusts are deducted from income earned on a daily basis and are not separately reflected. Consequently, such management fees and operating expenses are reflected as a reduction of net appreciation or an addition of net depreciation in the aggregate fair value of such investments.

Cash and Cash Equivalents

Cash and cash equivalents consist of a money market account at Isabella Bank, a subsidiary of the Corporation. The Plan's deposit account may at times exceed the federally insured limits. Plan management does not believe the Plan is exposed to any significant interest rate or other financial risk on this deposit.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the services employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries.

Benefits under the Plan are based on employees' average compensation during the highest five consecutive years in the last ten years of service prior to March 1, 2007. The accumulated plan benefits for active employees are based on their average compensation during the highest five consecutive years in the last ten years of service prior to March 1, 2007. Benefits payable under all circumstances, retirement, death, disability, and termination of employment, are included to the extent such benefits are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by Pentegra Retirement Services, the Plan's actuary, and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuations as of December 31, 2023 and 2022, are as follows:

The interest rate used to discount the obligation for 2023 and 2022 was 5.74% and 5.92%, including a reduction of 0.73% and 0.79%, respectively, to reflect anticipated administrative expenses associated with providing benefits. These actuarial assumptions are based on the presumption that although benefit accruals were frozen as of March 1, 2007, the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

Contributions

Contributions are recorded in the period in which they become an obligation of the Corporation.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

In preparing these financial statements, Plan management has evaluated, for potential recognition or disclosure, significant events or transactions that occurred during the period subsequent to the most recent statement of net assets available for benefits presented herein, through the date these financial statements were available to be issued.

3. CERTIFIED INVESTMENTS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Isabella Bank, the Plan Trustee, has certified the completeness and accuracy of all investment information reflected in (1) the accompanying statements of net assets available for benefits as of December 31, 2024, 2023, and 2022, (2) the supplemental schedules of assets (held at end of year) and reportable transactions as of and for the year ended December 31, 2024, and (3) the related investment activity reflected in the statements of changes in net assets available for benefits during 2024 and 2023. The trustee has also certified the cash and cash equivalents as of December 31, 2024, 2023, and 2022, and the related interest income during 2024 and 2023.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. For financial assets recorded at fair value, the description includes an indication of the level of the fair value hierarchy in which the assets are classified. There have been no changes in the methodology used at December 31, 2024, 2023, and 2022.

Common collective trusts: Valued at the net asset value ("NAV") of units of a bank collective trust. The NAV, as provided by Pentegra Retirement Services, is used as a practical expedient to estimate fair value and, as a result, are not assigned a level in the fair value hierarchy. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As the Plan's investments are measured at NAV per share or a non-active market, they have not been classified in the fair value hierarchy.

The following is a description of the investment strategy used for these investments that calculate NAV per share (or its equivalent) at December 31, 2024, 2023 and 2022:

Common collective trusts: These funds include investments that seek to provide long-term capital appreciation and reasonable current income by investing in corporate bonds and stocks of medium and large-sized companies. The asset allocation for these funds for 2024, 2023, and 2022, was 32% US Fixed Income, 28% US Large Cap Equity, 10% Real Asset, 18% Global Equities, 5% High Yield Bonds, and 7% US Small Cap Equity.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Pentegra Retirement Services ("Pentegra") provides the actuarial present value information for the Plan. Additionally, certain assets of the Plan are common collective trusts managed by Pentegra; therefore, transactions with Pentegra qualify as party-in-interest. Fees paid to Pentegra by the Plan were approximately \$31,000 and \$40,000 in 2024 and 2023, respectively.

Interest income related to interest earned on cash and cash equivalents that is held by Isabella Bank, a related party, amounted to \$7,316 and \$5,854 in 2024 and 2023, respectively. Investment administration salaries and legal fees for the Plan are paid by the Corporation.

6. TAX STATUS

The Plan has received a favorable determination letter dated December 9, 2013, from the IRS, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. While the Plan may be subject to routine audits by taxing jurisdictions, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although it has not expressed any intention to do so, the Corporation has the right under the Plan to discontinue such contributions at any time and to terminate the Plan subject to certain provisions set forth in ERISA. In the event the Plan is terminated, the net assets of the Plan will be allocated for payment of Plan benefits to the participants in order of priority determined in accordance with ERISA, applicable regulations thereunder and the Plan document.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some further time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations, and may also depend on the financial condition of the Plan Sponsor and the level of benefits guaranteed by the PBGC.

8. RISKS AND ECONOMIC UNCERTAINTIES

The Plan invests in various investment securities with the underlying assets consisting of any combination of stocks, bonds, fixed income securities, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of interest rate, market, and credit risks inherent with certain of the Plan's investment securities, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes in net assets available for benefits.
