### 1. Description of the Plan

The following description of the Montgomery Child Care Association, Inc. (the Organization) 403(b) DC Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

- A. General - The Plan is a defined contribution plan covering all employees of the Organization who have two years of service (at 1,000 hours per year) and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Organization's management oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.
- B. Contributions - Each month, participants may contribute up to \$50, and the Organization will match it with an employer contribution up to a maximum of \$50 per month, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers one fixed annuity, one pooled separate account, and several variable annuities as investment options for participants.
- C. Participant Accounts - Each participant's account is credited with the participant's contributions, employer matching contributions, and plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. Vesting - Participant and employer contributions are vested immediately as well as actual earnings thereon. Contributions are non-forfeitable.
- E. Notes Receivable from Participants – Participant loans are not permitted by the Plan.
- F. Payment of Benefits - On termination of service, death, disability, retirement, or any other reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in the form of one of various annuity options offered by the Plan as outlined in the plan document.

### 2. Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

### 2. Significant Accounting Policies (continued)

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Organization's management determines the Plan's valuation policies. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Organization and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used if Level 1 or Level 2 inputs are not available.

Fixed Annuity Contracts: Valued at fair value by plan management by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. The contracts held by the Plan are non-benefit responsive. See Note 5.

Variable Annuity Contracts: The variable annuity contracts invest principally in equity securities, fixed income instruments, and short-term investments in accordance with each portfolio's investments objectives. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments including matrix pricing. CREF Money Market Account holdings are generally valued at amortized cost. Each account determines its unit value each day.

Pooled Separate Account: The pooled separate account generally invests in real estate properties and real estate-related investments. The account value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources.

Gains and losses included in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Level 1 and Level 2 and into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers between Level 1 and Level 2 and into or out of Level 3. Certain amounts in the fair value hierarchy table at December 31, 2023 were reclassified to conform with the December 31, 2024 presentation.

In substantiating the reasonableness of the pricing data provided by third parties, plan management evaluates a variety of factors, including review of methods and assumptions used by external sources, recently executed transactions, existing contracts, economic conditions, industry and market developments, and overall credit ratings.

5. Guaranteed Investment Contract with TIAA and CREF

The Plan has a non-benefit-responsive guaranteed investment contract with TIAA and CREF. TIAA and CREF maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

6. Tax Status

The Plan is qualified under Section 403(b) of the Internal Revenue Code (IRC). The plan administrator and the Organization believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Related Party and Party-In-Interest Transactions

Plan investments are managed by TIAA and CREF. TIAA and CREF are the trustees and recordkeeper as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. As described in Note 2, the Organization pays certain plan expenses. The Plan also has a number of service providers. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, and the level of uncertainty related to changes in the values of such investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **9. Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the balance of the individual accounts of each participant would be distributed in a lump sum or by delivery of a fully paid annuity contract, as permitted by Treasury Regulation 1.403(b)-10(a).

### **10. Subsequent Events**

The Plan has evaluated subsequent events through July 18, 2025, the date the financial statements were available to be issued.
