### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Oakley Transportation Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Oakley Transportation Group 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

### Opinion

## NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

### Note A - Description of Plan

The following description of the Oakley Transportation Group 401(k) Plan (the Plan) provides only general information. Plan participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**General.** The Plan is a defined contribution 401(k) plan covering all full-time employees of Oakley Groves, Inc. and Oakley Transport, Inc. Employees are eligible to participate in the Plan after the first of the month following sixty days of employment and attained the age of twenty-one. The primary purpose of the Plan is to provide employees of the Company with financial benefits upon retirement. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974 (ERISA)*.

**Contributions.** Each year participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (i.e. rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company, in its discretion, may make matching and discretionary contributions to the Plan. For 2024 and 2023, the Company's matching contribution net of forfeitures was \$125,780 and \$127,061, respectively. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts.** Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's discretionary contribution, Plan earnings or losses, and any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting.** Participants are immediately vested in their contributions, plus the earnings thereon. Vesting in the Company's matching and discretionary contributions portion of their accounts is based on years of continuous service. A participant is vested 25% at year one, 50% at year two, and fully vested at year three. Upon attaining normal retirement age, death, or permanent disability while a participant is employed, their entire account balance becomes fully vested.

**Payments of Benefits.** On termination of service due to death, disability, retirement, or for other reasons a participant's account is distributed as a lump sum distribution if the vested balance does not exceed \$5,000. If a participant's vested balance exceeds \$5,000 a participant may elect to receive either a lump sum distribution or substantially equal installments over a certain period of time, which does not extend beyond the life expectancy of the participant or the joint life expectancies of the participant and his or her beneficiary.

**Forfeitures.** At December 31, 2024 and 2023, forfeited non-vested accounts total \$164 and \$2,259, respectively. These amounts will be used to reduce future employer matching contributions, and then pay administrative expenses. In 2024 and 2023, total forfeitures plus investment returns were \$12,313 and \$11,940 and employer matching contributions were reduced by \$10,152 and \$9,692, respectively.

**Note A - Description of Plan - Continued**

*Notes Receivable from Participants.* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note repayment terms range up to five years from the date of the note unless such note is for the purchase of a participant's primary residence, in which the repayment period may exceed five years. Notes are secured by the vested balance in the participant's account and bear interest at a fixed rate equal to the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. Notes outstanding at December 31, 2024 and 2023, bear interest at rates ranging from 4.25% to 9.50%.

**Note B - Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements have been prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for disclosure of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as deemed distributions based upon the terms of the Plan document.

**Administrative and Investment Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment related expenses are included in net appreciation in fair value of investments.

**Date of Management Review**

Subsequent events were evaluated through July 7, 2025, which is the date the financial statements were available to be issued.

**Note C - Custodial Agreement**

Transamerica Trust Company and Transamerica Financial Life Insurance Company acting as custodians for the Plan manages Plan assets, executes investment transactions for the Plan, and makes distributions to participants as directed by the plan administrator. Oakley Transportation Group, Inc. serves as the plan administrator.

**Note D - Certified Investments**

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of and for the years ended December 31, 2024 and 2023, included in the Plan's financial statements and supplementary schedule, that was prepared by or derived from information prepared by Transamerica Trust Company and Transamerica Financial Life Insurance Company, the custodians, and furnished to the Company. The Company has obtained certifications from the custodians as of and for the years ended December 31, 2024 and 2023, that such information is complete and accurate.

The Plan entered into a traditional fully benefit-responsive group variable annuity contract with Transamerica Financial Life Insurance Company (Transamerica) totaling \$990,021 for 2024 and \$866,616 for 2023. Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a declared interest rate that is guaranteed to the Plan. The declared credited interest rate is based on a formula established by Transamerica. The declared credited interest rate is set semi-annually and is effective on the first day of the semi-annual period. During 2024 and 2023, the average crediting rate was 2.06% and 1.17%, respectively.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its contractual obligations. The issuer's ability to meet its contractual obligations may be affected by future economic regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under *ERISA* (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**Note G - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Note H - Parties-in-Interest**

At December 31, 2024 and 2023, Plan investments totaling \$990,021 and \$1,055,551, are shares of mutual funds and a group annuity account owned and managed by Transamerica Financial Life Insurance Company, respectively. Purchases and sales of these investments qualify as party-in-interest transactions.

Transamerica Retirement Solutions (TRS) provides certain administrative services to the Plan. TRS is an affiliate of the custodians, therefore, these transactions qualify as party-in-interest transactions. Fees paid to TRS in 2024 and 2023 from the Plan were \$79,354 and \$80,868, respectively.

**Note I - Right to Terminate Plan**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the Plan's provisions and those of *ERISA*. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note J - Tax Status**

The Plan sponsor adopted a new Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan effective January 1, 2022. The IRS issued an opinion letter on the acceptability of the Plan in a letter dated June 30, 2020. The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.
