### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of TSG Enterprises 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

# TSG ENTERPRISES 401(K) PLAN NOTES TO FINANCIAL STATEMENTS

## 1. DESCRIPTION OF PLAN

The following description of the TSG Enterprises 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC). The Plan was established by TSG Enterprises, LLC (the "Company") in July 2013. A Summary Plan Document outlining the Plan, its benefit provisions and vesting requirements is provided to each Plan participant. The Plan is administered by the Company.

### **Eligibility Requirements**

Employees are eligible to participate in the Plan unless they are considered an independent contractor.

### **Contributions**

Participants may elect to contribute 100% of eligible compensation as defined in the Plan document, as pre-tax or Roth contributions subject to limits required by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company matches 100% of the first 3% of eligible compensation that a participant contributes to the Plan, and 50% of contributions over 3%, up to 5%.

All contributions are subject to certain IRC limitations.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of Plan investment earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant compensation, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested 100% in their contributions and Company matching contributions, plus actual earnings thereon.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by any outstanding loan balance, if any, during the one-year period ending on the day before a new loan is made or fifty percent (50%) of their vested account balance. The loans are secured by the balance in the participant's account and bear interest of 5.25% - 10.50% at December 31, 2024. The loan interest rate is based on the rates available for similar loans from commercial lending institutions. Loans must be fully repaid through payroll deductions within five years. A participant may not have more than one outstanding loan at any time.

**1. DESCRIPTION OF PLAN (CONTINUED)**

**Payment of Benefits**

Upon termination of employment, death, disability, or normal retirement, a participant or designated beneficiary may elect to receive the participant's vested interest in his or her account in the form of a lump-sum, installment, or direct rollover to another qualified retirement plan or IRA. Participants may also withdraw their vested account balance upon attaining age 59 ½. Participants who have not yet attained 59 ½ may only withdraw their rollover contributions. Hardship withdrawals are also permitted by the Plan. Participants who terminate employment with an aggregate vested account balance of \$5,000 or less will be automatically distributed from the Plan.

**Secure 2.0 Act**

The Secure 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, that started to become effective beginning January 1, 2023. Plan management evaluated the impact of the adoption and implementation of this legislation on the Plan and there was no material impact to the Plan for the years ended December 31, 2024 and 2023.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements are presented on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contribution Receivable**

Receivables are recorded when amounts have been withheld from employee compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based upon the terms of the Plan document. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

**Benefits Paid**

Benefits paid to participants and their beneficiaries are recorded when paid.

**Administration Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administration expenses. Investment related expenses are included in net appreciation/(depreciation) in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through June 23, 2025, the date the financial statements were available to be issued. No subsequent events were noted that could have a material impact on the financial statements.

**3. INFORMATION PREPARED AND CERTIFIED BY PLAN'S CUSTODIAN**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian (Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company) has certified to the completeness and accuracy of all investments reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related investment activity reflected on the Statements of Changes in Net Assets Available for Benefits for the years then ended, and Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year), as of December 31, 2024.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1**

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2**

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3**

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**4. FAIR VALUE MEASUREMENTS (CONTINUED)**

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes to the methodology used at December 31, 2024 or 2023.

*Mutual funds:* Valued at the net asset value (NAV) of shares held by the Plan at year end as traded on public exchanges.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. EXEMPT PARTIES-IN-INTEREST TRANSACTIONS**

Plan investments are shares of mutual funds. Principal Trust Company is the custodian as defined by the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions.

Certain administrative expenses for accounting and other services are rendered by parties-in-interest and are paid by the Company. The Company also provides certain administrative services to the Plan for which it receives no compensation.

**6. TAX STATUS**

The Internal Revenue Service (IRS) has provided an opinion and informed the Company by a letter dated June 30, 2020 that the prototype non-standardized plan maintained by the Plan is designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently operating in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan Sponsor has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator believes it has no uncertain tax positions as of and for the years ended December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income examinations for years prior to 2021.

**7. PLAN TERMINATION**

Although the Company has not expressed any intent to do so, it reserves the right to terminate the Plan at any time subject to the provisions of ERISA.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
