**Note 1 – Description of Plan:**

The following description of the Advanced Rehab & Sports Medicine Services 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan is sponsored by Advanced Physical Therapy Services, Ltd. (the “Plan Sponsor”).

General

The Plan was established to provide retirement benefits for employees of the Company. Eligible employees become participants in the Plan following the attainment of age 21. The Plan is subject to the provisions of the Employer Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan contains an elective 401(k) deferred compensation component. Eligible participants may elect to contribute not less than 1% and up to 100% of their compensation, subject to limitations to the 401(k) component of the Plan. The Plan is subject to a non-discretionary, safe-harbor matching contribution of a percentage of the participants’ 401(k) deferrals up to a maximum percentage of eligible compensation. The safe-harbor matching percentage declared for the plan year ended December 31, 2024 was 100% of the participant’s 401(k) deferrals up to 4% of eligible compensation on a payroll period by payroll period basis, then 50% of the participant’s 401(k) deferrals for the next 2% of the participant’s eligible compensation. The Company’s matching contributions for the plan year ended December 31, 2024 were \$150,792.

Rollover contributions are permitted under the Plan and shall be accepted from participants and non-participants, regardless of whether they have satisfied the eligibility requirements set forth in the Plan. There were \$-0- of rollover contributions received by the Plan during the plan year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the employer’s contributions, and the earnings attributable to the participant’s account.

Vesting

Participants are immediately vested in their 401(k) contributions, which also include rollover contributions, plus actual earnings thereon, as well as employer contributions.

Participant Loans

The Plan does not allow loans to Participants.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 1 – Description of Plan – Continued:**

Distributions to Participants

Amounts credited to an individual participant's account are distributed at termination of employment as a lump sum or in installments. Distributions may be deferred until the later of the participant's actual retirement date or the attainment of age 65, if the value of the distribution is not less than \$1,000. However, the Plan agreement stipulates that distributions must commence no later than April 1 of the year following the year in which the participant reaches the age of 73, unless the participant is not a 5% owner of the Company and is still employed by the Company.

In certain hardship situations, as described in the Plan agreement, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to their vested account balance.

**Note 2 – Summary of Accounting Policies:**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are held in a trust. The custodian values all investments at fair value. Investments are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net Assets Available for Benefits

Net assets available for benefits at both December 31, 2024 and 2023 included \$-0- allocated to the accounts of persons who, prior to that date, had withdrawn from participating in earnings and operations of the Plan.

**Note 3 – Tax Status:**

The Plan, originally adopted during 2008, and effective January 1, 2008, obtained its latest determination letter during 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

**Note 3 – Tax Status – Continued:**

The Plan Administrator and the Plan's Sponsor believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**Note 4 – Investments:**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Country Trust Bank has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- a. Total cash and investments as shown in the accompanying statements of net assets available for benefits of \$11,171,905 and \$10,070,058 as of December 31, 2024 and 2023, respectively.
- b. Total investment income (loss) as shown in the accompanying statement of changes in net assets available for benefits is \$1,395,141 for the year ended December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 5 – Fair Value Measurement:**

The Plan has determined the fair value of certain assets and liabilities through application of ASC 820. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values. Financial assets and liabilities carried at fair value are classified and disclosed in one of the following three categories:

- Level 1 – Valuations for assets and liabilities traded in active exchange markets. Valuations are obtained from readily available pricing sources for market transactions involving identical assets or liabilities.
- Level 2 – Valuations for assets and liabilities traded in less active dealer or broker markets. Valuations are obtained from third party pricing services for identical or similar assets or liabilities.
- Level 3 – Valuations for assets and liabilities that are derived from other valuation methodologies, including option pricing models, discounted cash flow models and similar techniques, and not based on market exchange, dealer or broker traded transactions. Level 3 valuations incorporate certain assumptions and projections in determining the fair value assigned to such assets.

**Note 6 – Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Note 7 – Related Party Transactions and Party-In-Interest Transactions:**

Certain Plan investments are shares of mutual funds managed by various fund companies. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly some fees related to the Plan's operations.

**Note 8 – Uncertain Tax Positions:**

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Tax years prior to 2021 are closed.
