### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Security Bank and Trust Company 401(K) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Security Bank and Trust Company 401(K) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1 - PLAN ADMINISTRATION AND DESCRIPTION**

The following brief description of the Security Bank and Trust Company 401(K) profit Sharing Plan and Trust is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

**A. General**

The Plan is a defined contribution plan covering all (defined as 1,000 hours in the plan year) employees of the Company who have two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**B. Contributions**

Each participant may contribute up to the maximum percentage allowed by the IRS for the plan year (January 1 to December 31). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investments of the contributions to their account to various investment plans offered by the Plan. The Plan also allows for Roth contributions. The Company match is discretionary and may be changed or eliminated at any time with the approval of the Board of Directors. The Company match for the years ended December 31, 2024 and 2023 was 100 percent of the first 4 percent of compensation. The Company profit sharing contribution for the years ended December 31, 2024 and 2023 was 2 percent of compensation. Contributions are subject to certain IRS limitations.

**C. Participants' Accounts**

Each participant account is credited with the participant's contribution and allocation of the Company's match contribution and plan earnings. Allocations are based on participant compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**D. Vesting**

Participants are vested immediately in their contributions plus actual earnings on them. Vesting in the Sponsor-contributions portion of their accounts plus earnings is based on years of continuous service. A participant is 100 percent vested after three years of credited service.

**E. Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms range from one to five years or up to twenty-five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate equal to "prime" plus one percent (1%). Interest rates on December 31, 2024 ranged from 4.25 to 9.50 percent. Principal and interest are paid ratably through monthly payroll deductions.

**F. Payments of Benefits**

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. A participant may elect to receive a lump-sum or partial distribution or distribution in cash or in property in the amount equal to the vested portion of the participant's account. Participants may elect to roll over their vested balance to another qualified retirement plan or IRA. Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$5,000, their vested balance may be automatically rolled into an

IRA unless otherwise elected. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Participants may also withdraw an amount at age 59½ if certain criteria are met.

**G. Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$0, respectively. Forfeitures of non-vested employer match account funds are used to reduce future employer match contributions. The unallocated and unused forfeitures are invested in a non-interest-bearing cash account. Forfeitures used in 2024 and 2023 were \$0 and \$9,038, respectively.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements are prepared on the accrual basis of accounting.

**B. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**C. Investments**

The Plan's investments are reported at fair market value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and asset custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**D. Contributions**

Participant contributions and any related employer contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/Profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

**E. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**F. Payment of Benefits**

Benefits are recorded when paid.

**G. Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation (depreciation) of the fair value of investments.

**H. Date of Management's Review**

Subsequent events were evaluated through July 21, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 - CERTIFIED INVESTMENT INFORMATION**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, Inc., a qualified institution.

**NOTE 4 - TAX STATUS**

The Employer adopted the FIS Business Systems LLC Prototype Standardized 401k Plan and has elected to rely upon their opinion letter dated June 30, 2020. Although the Plan has been amended since receiving this opinion letter, the Plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are mutual funds managed by Ascensus, Inc. (custodian and recordkeeper) for the Plan, and therefore, those transactions qualify as party in interest transactions.

Administrative services to the plan provided by Ascensus, Inc. (custodian and recordkeeper) included in the statements of changes of net assets are \$53,326 and \$51,160 for the years ended December 31, 2024 and 2023, respectively.

**NOTE 6 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

*Mutual funds:* Valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
