Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pine Instrument Company 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of Plan

The following description of the Pine Instrument Company 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Pine Instrument Company (the Plan Sponsor) and the related entities as defined below. The Plan was formed on December 31, 1996 (as amended, effective September, 1, 2024 to allow hardship distributions) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Eligible employees may enroll in the Plan on the first day of the month coinciding with or following the date of satisfaction of the eligibility requirements.

Participating employers in the Plan are as follows:

- Pine Instrument Company
- Pine Certified Service, Inc.
- Pine Electronics, Inc.
- Pine Research Instrumentation, Inc.
- Pine Test Equipment, Inc.

Additional information about the Plan agreement, including contributions, vesting, benefit payments, forfeitures, and investment allocation provisions is contained in the Summary Plan Description. Copies of this booklet are available from the Plan Administrator.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) their respective employer's contribution and (b) Plan earnings. Allocations are based on participant compensation and the participant may direct investment of their account within the investment funds offered by the Plan.

Contributions

Participants may elect to make deferred savings contributions for each regular pay period in any percentage of eligible compensation, subject to certain Internal Revenue Service (IRS) limitations. The Plan Sponsor is required to make a matching contribution equal to 100% of eligible compensation on the first 3% deferred by the participant plus 50% of salary deferrals up to 5%. In addition, at its discretion, the Plan Sponsor may make a discretionary profit-sharing contribution. The Plan Sponsor made matching contributions totaling \$248,746 and \$239,528 for the years ended December 31, 2024, and 2023, respectively. The Plan Sponsor made a profit sharing contribution totaling \$490,203 and \$388,752 for the years ended December 31, 2024 and 2023.

Vesting

Participants are immediately vested in their voluntary contributions, plus earnings thereon as well as their safe harbor contributions and rollover contributions. Participants with three or more years of service are 100% vested in their profit-sharing contributions. For the first three years of service, participants are 0% vested in the profit-sharing contributions. In the event of death, disability or attainment of age 65, the full balance of the participant's account becomes immediately vested.

1. Description of Plan (continued)

Payment of Benefits

Benefit payments may be made in installments or a participant may receive a lump-sum amount equal to the value of the vested interest in his or her account. The Plan Administrator will initiate an automatic lump-sum distribution of any account which does not exceed \$5,000. Vested balances in excess of \$5,000 will not be distributed without the written consent of the participant.

Forfeitures

The Plan Sponsor may use forfeitures to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan.

Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Administrative Expenses

Certain administrative expenses, which are not material to the Plan, are paid by the Plan assets. Certain administrative and recordkeeping expenses are allocated proportionately to each participant. General administrative and investment advisory fees paid to John Hancock Retirement Plan Services, LLC and Northwestern Mutual Investment Services totaled \$48,792 and \$45,839 for the years ended December 31, 2024 and 2023, respectively.

Reclassification

Certain reclassifications were made to the prior year financial statements to conform to the current year presentation.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accounting records and financial statements of the Plan are maintained on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America, which recognizes additions to and deductions from net assets when contributions are withheld, income is earned, and liabilities are incurred.

Valuation of Investments and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. See Note 5 and 6 for discussion of fair value and contract value, respectively.

2. Summary of Significant Accounting Policies (continued)

Valuation of Investments and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Investments are valued daily.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect amounts reported in the financial statements and related disclosures. Actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through July 15, 2025, the date the financial statements were available to be issued.

3. Tax Status

The IRS has determined and informed the Plan Sponsor by a letter dated June 30, 2020, that the trust established under the Plan to hold the Plan's assets qualifies under Section 401(a) of the Internal Revenue Code (the "Code") and is, therefore, not subject to tax under present income tax law. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Sponsor believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the Code.

Management evaluated the Plan's tax positions related to the Financial Accounting Standards Board (FASB) issued guidance on accounting for uncertainty in income taxes and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan sponsor believes it is no longer subject to income tax examinations for years prior to December 31, 2021.

4. Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net realized and unrealized appreciation in fair value of investments, interest and dividends and investment were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by John Hancock Trust Company, LLC, the trustee of the Plan.

5. Fair Value Measurements

Investments are recorded at estimated fair value, in accordance with FASB Accounting Standards Codification's (ASC) *Fair Value Measurements and Disclosures* topic. This topic establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC's *Fair Value Measurements and Disclosures* topic are described as follows:

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. 6. Investment Measured at Contract Value

The Plan has a fully benefit-responsive investment contract with New York Life Insurance Company (“NYL”) to establish the NYL Anchor Account IV, which was made available as an investment option to Plan participants. The NYL Anchor Account IV is a group annuity contract. Contributions to the contract are held in a pooled separate account that invests primarily in a diversified portfolio of high-quality, fixed income securities, which are owned and managed by NYL. NYL is contractually obligated to repay the principal and accumulated interest to the Plan. Interest is accrued daily and credited monthly at rates determined by NYL under the contract based on the investment experience of the pooled separate account. The crediting interest rate is reset at least annually and not more frequently than daily and guaranteed by NYL to not be less than zero.

The NYL Anchor Account IV meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value in the statement of net assets available for benefits. Benefit responsiveness is defined as the extent to which a contract’s terms and the Plan permit or require participant-initiated withdrawals at contract value. Contract value, as reported to the Plan by NYL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. Certain events would limit the ability of the Plan to transact at contract value with NYL, including (i) termination of the Plan’s interest by the Plan Administrator with less than twelve months’ notice, (ii) termination of the Plan’s interest due to loss of qualified status, or (iii) withdrawals and transfers of more than five percent of amounts held under the contract due to a Plan Administrator event including, but not limited to, a total or partial plan termination, merger, spin-off, lay-off, early retirement incentive program, sale or closing of all or part of the Plan Sponsor’s operations, bankruptcy or receivership. The Plan Administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Related Party Transactions

John Hancock Retirement Plan Services is the custodian of the Plan's assets. Participant investments are in John Hancock investment vehicles which are managed by John Hancock Retirement Plan Services. These transactions are considered party-in-interest transactions. These transactions are permitted under the provisions of the Plan and are exempt party-in-interest transactions under ERISA. Investment fund earnings and losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan. These fees are not prohibited; payments are for reasonable compensation for the operation of the Plan.

Certain administrative expenses are paid from the Plan assets for recordkeeping and investment advisory fees. These transactions qualify as party-in-interest transactions. These fees are not prohibited, payments are for reasonable compensation for the operation of the Plan.
