### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of The Juniata Valley Bank 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Juniata Valley Bank 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1. Description of the Plan**

The following description of The Juniata Valley Bank 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

**General**

The Plan is a defined-contribution plan covering substantially all full-time employees of The Juniata Valley Bank (Company or Employer). An employee becomes a participant in the Plan on the first day of employment in which they perform one hour of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

The Plan was amended to allow participation by all employees joining the Company through the acquisition of The First National Bank of Port Allegany (FNBPA) as of the acquisition date. This amendment was effective December 1, 2015. The Plan was further amended effective January 1, 2016 to allow years of service with FNBPA to count when determining vesting years of service and to permit the Plan to accept in-kind transfers of existing participant loans as part of plan mergers or rollovers from qualified plans.

The Plan was amended to allow participation by all employees joining the Company through the acquisition of Liverpool Community Bank (Liverpool) as of the acquisition date. This amendment was effective April 30, 2018. The Plan was further amended effective May 7, 2018 to allow years of service with Liverpool to count when determining vesting years of service.

Effective May 6, 2024, the Plan was amended to provide that interns are not eligible to participate in the Plan.

**Contributions**

There are several types of contributions that can be added to a participant's account: an employee salary deferral contribution, an employer matching contribution and an employer qualified non-elective contribution. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans as rollovers.

Participants may contribute a portion up to 75% of their annual pre-tax compensation by way of a salary deferral contribution. Participants may also contribute a portion of their annual post-tax compensation to a Roth 401(k) account by way of a salary deferral contribution. Catch-up contributions for those age 50 or older are also permitted. Unless they decline, participants are automatically enrolled in the Plan and will be deemed to have elected a salary deferral contribution of 3%. The automatic deferral shall be increased by an additional 1% as of each April 1 until the total salary reduction percentage equals 8% of compensation or the participant makes an affirmative election. Participants may change their deferral election at times throughout the year as defined in the Plan Document.

The employer makes an annual non-elective fully vested contribution equal to 3% of compensation to each eligible participant, resulting in a contribution of \$268,143 and \$265,264 for the years ended December 31, 2024 and 2023, respectively. The employer makes a matching contribution to each eligible participant equal to a 50% match on the first 8% of compensation, based on participant deferrals, and is allocated as of the last day of each payroll period, which resulted in a contribution of \$231,087 and \$227,181 for the years ended December 31, 2024 and 2023, respectively.

Contributions are subject to certain limitations.

**Participant Investment Account Options**

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and the Company’s matching contribution, and allocations of (a) the Company’s non-elective (discretionary and qualified) contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

A participant is 100% vested at all times in the participant’s salary deferrals and qualified rollovers, regardless of the number of years of service. If participants cease participation, other than by retirement, disability, or death, the vested interest in the employer matching contribution account is dependent upon the years of credited service, as follows:

3 years or more	100%

The vesting percentage applicable to the employer’s safe harbor non-elective contribution used to satisfy the qualified automatic contribution arrangement requirements shall be determined as follows:

**Payment of Benefits**

On termination of service due to death, disability, retirement or other reasons, participants will receive a lump-sum amount equal to the value of their vested interest in their accounts. In addition, the Plan allows for hardship distributions if certain criteria are met.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4 and \$3,062, respectively. Forfeitures are used to reduce employer contributions otherwise due under the Plan. Any remaining forfeitures are then used to pay administrative expenses. Forfeitures totaling \$15,356 and \$1,345 were used to reduce employer contributions during the years ended December 31, 2024 and 2023, respectively.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### ***Valuation of Investments and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. Money market funds are valued at cost, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Payment of Benefits***

Benefit of payments to participants are recorded upon distribution.

### ***Administration of Plan Assets and Administrative Expenses***

The Plan's assets are administered under a contract with Charles Schwab Trust Bank, the custodian of the Plan. The custodian invests funds received from contributions, investment sales, interest and dividend income, and makes distribution payments to participants. Certain administrative expenses of maintaining the Plan are paid by the Company. There is a revenue-sharing agreement between Conrad Siegel Investment Advisors, Inc. and the Plan that permits revenue to be used to pay Plan expenses, as defined, or to be allocated to participants. These revenues were de minimus in 2024 and 2023, and were allocated to the participants as investment income.

## **Note 3. Certification of Plan Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, a qualified institution and the custodian of the Plan, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. The mutual funds and money market funds are considered Level 1 securities in the Plan. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. There are no Level 2 securities in the Plan. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 3 securities in the Plan.

**Note 5. Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by the custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

Activity related to the revenue-sharing agreement discussed in Note 2 qualifies as a party-in-interest transaction. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

The Company may reduce or suspend employer matching safe harbor contributions upon satisfaction of certain requirements, including a 30-day advanced notice to all eligible employees.

**Note 7. Tax Status**

The Plan adopted a nonstandardized 401(k) profit-sharing plan (profit-sharing plan) sponsored by Conrad M. Siegel, Inc., which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the profit-sharing plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since adopting the profit-sharing plan. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Subsequent Events**

Subsequent events have been evaluated through July 17, 2025, which is the date the financial statements were available to be issued.
