Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the financial statements of GP 50 New York LTD 401k Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), my audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In my opinion, based on my audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

I conducted my audits in accordance with auditing standards generally accepted in the United States of America (GAAS). My responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of my report. I am required to be independent of the Plan and to meet my other ethical responsibilities in accordance with the relevant ethical requirements relating to my audits. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. GP 50 New York LTD 401k Profit Sharing Plan

Notes to Financial Statements December 31, 2024 and 2023

1. Description of the Plan

The following description of the GP 50 New York LTD 401k Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General — The Plan is a defined contribution plan sponsored by GP 50 New York LTD (the "Company" or "Employer") and covers eligible employees of the Company who are age 18 or older. Upon reaching eligibility, participants are allowed to enter the Plan on January 1st, April 1st, July 1st, and October 1st. Prior to January 12, 2023, the eligibility age was 21 or older. The Plan is funded by employee and employer contributions.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Principal Life Insurance Company and its affiliates are the Plan's recordkeeper and custodian of investments held by the Plan.

Contributions — Participants may authorize an elective deferral contribution in an amount equal to a percentage of the contributing employee's compensation as defined by the Plan, not to exceed the maximum annual limitations as provided by the Internal Revenue Code ("IRC"). Participants who are age 50 or older before the end of the plan year are allowed to make an additional "catch-up" contribution. The "catch-up" contribution is also subject to the employer matching contribution. Participants may also contribute amounts representing distributions from other qualified pension plans.

The Company will match employee contributions equal to 50% of the participant's salary deferrals. In applying the matching contribution, the participant's salary deferrals for each payroll period that exceed 6.0% of their compensation for such period will not be considered (i.e., will not be matched). Company matching contributions amounted to \$166,404 for the year ended December 31, 2024, of which \$151,249 was funded in cash and \$15,155 was funded from forfeited nonvested accounts. The Company can also make nonelective discretionary contributions each year. There were no nonelective discretionary contributions made for 2024.

Effective for participants with a hire date of July 1, 2018 and after, unless a participant makes an affirmative election, the Employer will withhold 6% of compensation for each payroll period. The provision does not apply to existing participants. Scheduled increases of automatic deferral rates by 1.0% up to a maximum of 10.0% of compensation apply on the first day of each plan year.

All contributions are subject to certain IRC limitations.

Participant Accounts — Each participant's account is credited with the participant's contributions, Employer contributions, Plan earnings, and charged with withdrawals and administrative expenses and Plan losses. Allocations are based on participant earnings, or account balances as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of employee and employer contributions into various investment options offered by the Plan. Participants may change their investment allocation on a daily basis. The various Principal LifeTime Hybrid Collective Investment Funds (target-date funds) are the default investments used when a participant has not made an investment election for all or any portion of their accounts.

Vesting — Participants are immediately vested in their voluntary contributions and earnings thereon. Vesting in the Company's matching contributions and nonelective contributions, and earnings thereon, are based on a graded vesting schedule with participants 100% vested after five years. A vesting waiver applied to participants employed on June 30, 2018. These participants are 100% vested in all Employer contributions and earnings thereon.

Notes Receivable from Participants — Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years but may exceed five years for the purchase of a primary residence. The loans are collateralized by the vested balance in the participant's account and bear interest at a rate at the prime rate plus two percentage points. Principal and interest is paid ratably through payroll deductions. The loans are collateralized by the balance in the participant's account and bear interest at the prime interest rate plus 1.0%. Principal and interest are paid ratably through payroll deductions.

Forfeitures — Participants not fully vested in Employer contributions upon separation from the Company, as defined in the Plan document, forfeit their non-vested balances, which may be used to pay administrative expenses or reduce amounts otherwise required to be contributed to the Plan, as defined.

Withdrawals and Distributions — Unless a participant elects otherwise, distributions will be made as soon as practical after a participant's termination of service due to retirement, death or disability. The normal retirement date is the date upon which a participant reaches age 65. Participants may also receive hardship distributions under certain circumstances, as defined. Participants may receive their accumulated vested benefits held by the Plan's trustee upon termination of employment or elect to keep his or her vested balance in excess of \$5,000 in the Plan. If the participant elects to keep his or her vested interest in the Plan, the participant's account will continue to receive its share of earnings and losses. Involuntary cash-outs of vested account balances equal to \$5,000 (\$7,000 effective January 1, 2024) or less will be automatically distributed without participant consent.

2. Summary of Significant Accounting Policies

Basis of Accounting — The financial statements of the Plan are prepared using the accrual basis of accounting under accounting principles accepted in the United States of America.

Investment Valuation and Income Recognition — Investments are reported at fair value as determined by Principal. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes gains and losses on investments held during the year.

Notes Receivable from Participants — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits — Benefits are recorded when paid.

Administrative Expenses — Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

Use of Estimates — The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties — The Plan's assets include various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to the value of such investments, changes in the values of investments will occur and such changes could materially affect the amounts reported in the accompanying financial statements.

Subsequent Events — Plan management has evaluated subsequent events through July 14, 2025, the date the financial statements were available to be issued.

Eligible employees of Blue Ribbon, Corp. hired by the Company were permitted entry to the Plan effective June 29, 2025.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- Level 1 – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.
- Level 2 – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, substantially for the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security.
- Level 3 – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value as of December 31, 2024 and 2023:

Collective Investment Trusts – Investments in collective investment trusts are valued by Principal based upon the redemption price of units held by the Plan, which is based on the current fair value of the collective investment trusts’ underlying assets. The net asset value (“NAV”) per unit is determined by the financial institution sponsoring such funds by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. The NAV is used as a practical expedient to estimate fair value. There are no unfunded commitments and no redemption restrictions in the common collective trust funds.

Pooled Separate Accounts – Pooled separate accounts are valued by Principal at market value of the underlying investments. The accounts are not publicly quoted on an active market. The accounts can be redeemed at NAV, as determined by the Custodian, as of the measurement date. The NAV is used as a practical expedient to estimate fair value. Certain redemption fees and transfer restrictions may exist. The pooled separate accounts do not have any unfunded commitments relating to their investments, nor any restrictions on redemptions. Participant-directed redemptions can be made daily and do not have a redemption notice period.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Related-Party and Party-In-Interest Transactions

All of the Plan’s investments are managed by Principal and its affiliates. Principal is the custodian as defined by the Plan. Accordingly, transactions involving these investments qualify as party-in-interest transactions. Notes receivable from participants qualify as party-in-interest transactions.

Certain employees and/or officers of the Employer, who may also be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

6. Tax Status

The Plan adopted a defined contribution pre-approved plan document sponsored by Actuarial Consulting Services, Inc. Actuarial Consulting Services, Inc. received an opinion letter from the Internal Revenue Service, dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (“IRC”). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

As of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Certified Financial Information

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan’s financial statements and supplemental schedule, that was prepared by or derived from information prepared by Principal Life Insurance Company and Principal Trust Company and furnished to the Company. The Company has obtained certifications from Principal Life Insurance Company and Principal Trust Company as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that such information is complete and accurate.
