Note 1 - Description of Plan

The following description of the Community Health Professionals 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan that provides benefits to eligible participants as determined according to the provision of the plan agreement. Employees of Community Health Professionals, Inc. (the “Organization”) are eligible to participate in the Plan at the date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for the oversight of the Plan and for determining the appropriateness of the Plans investment offerings and monitoring investment performance.

Contributions - The Plan provides for employee salary reduction contributions subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan accepts rollover contributions from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may direct the investments of their account balances into various investment options offered by the Plan. Each year, participants can elect to receive an employer contribution from the Organization once they have worked 83 hours in a one-month period. Upon electing to receive this employer contribution, participants receive a 2% of eligible compensation contribution to their account each pay period as long as they are employed by the Organization. The Organization may also contribute an additional discretionary employer contribution to the Plan. This contribution is then allocated to individuals based on each individual’s eligible compensation compared to the eligible compensation of all individuals in total.

Participant Accounts - Each participant’s account is credited with the participant’s contributions and an allocation of the (a) Organization’s contributions, and (b) plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participants’ earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their voluntary and rollover contributions plus actual earnings thereon. Vesting in the remainder of the accounts is based on years of continuous service as follows:

Payment of Benefits - On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period of time.

Distribution Prior to Termination - In-service withdrawals are subject to varying rules depending on the source of the funds in the participant's account. Participants may withdraw all or part of their deferral contributions account and qualified non-elective contributions account provided they have attained age 59½. Participants may take hardship distributions from their vested account balances. These distributions would be subject to potential penalties and taxation. Participants are advised to consult a tax advisor for the most recent tax laws.

Death Benefits - Upon the death of a participant, the account becomes available for distribution to the participant's beneficiaries.

Forfeitures - Forfeited amounts attributable to the Organization matching portion of a participant's account will be applied to reduce the Organization matching contribution for the Plan year in which such forfeitures occur. Forfeited amounts attributable to the Organization discretionary portion of a participant's account will be reallocated to all participants based on compensation, as defined. For the years ending December 31, 2024 and 2023, forfeited amounts used during the year totaled \$12,060 and \$16,612, respectively. Forfeiture balances as of the years ended December 31, 2024 and 2023, amounted to \$3 and \$11, respectively.

Note 2 - Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan.

Basis of Accounting - The Plan prepares its financial statements on the accrual basis. Unrealized gains and losses on the Plan's assets are reported even though no sales of such assets actually took place.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates. There were no significant c

Contributions - Contributions to the Plan are accrued, if necessary, to the year to which they apply. The Plan evaluates contribution receivables based on risk characteristics, such as historical losses, current economic conditions and on a case-by-case basis. The Plan provides for probable uncollectible contributions through a provision for bad debts and an adjustment to a valuation allowance based on its assessment of the status of the receivables. Balances that are still outstanding after the Plan has made a reasonable collection effort are written off through a charge to the valuation allocation and a credit to the contribution receivable. The allowance for credit losses for the years ended December 31, 2024 and 2023, totaled \$0 and \$0, respectively.

Note 2 - Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Net appreciation (or depreciation) in fair value of investments is reflected in the Statement of Changes in Net Assets Available for Benefits and includes realized gains and losses on investments bought and sold and the change in appreciation from one period to the next. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits - Benefits are recorded when paid.

Information Certified by Custodian - The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certification from Alerus Financial, N.A. ("Alerus"), that all information relating to the Plan's investments and related investment income is complete and accurate. Information as to the value of the investments in the trust fund managed by the custodian, investment income (loss), and all information in the supplemental schedule is presented in reliance solely upon those certifications.

Note 3 - Plan Termination

Although it has not expressed any intention to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 4 - Certified Investments

Information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Alerus (the custodian of the Plan).

Investments included in the Plan's net assets available for plan benefits were \$4,927,417 and \$4,287,870 at December 31, 2024 and 2023, respectively. The Plan also has non-interest bearing cash with Alerus totaling \$6,191 and \$5,916 at December 31, 2024 and 2023, respectively.

The Plan's investments including gains and losses on investments bought and sold, as well as held during the year, appreciated in value by \$261,768 in 2024 and appreciated in value by \$528,859 in 2023. Interest and dividends on all investments totaled \$335,243 and \$164,934 for the years ended December 31, 2024 and 2023, respectively.

Note 5 - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There were no plan assets requiring the use of level 2 or 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Note 6 - Income Tax Status

The Plan is designed based on a prototype plan. The Internal Revenue Service has provided a determination letter dated March 31, 2014, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believe that the plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 7 - Party-in-Interest

All Plan assets are managed by Alerus. Alerus is the Plan's direct custodian, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. The Plan pays for the record keeping services. Certain expenses of maintaining the Plan are paid by the Organization and are therefore excluded from these financial statements. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 - Subsequent Events

Management has evaluated subsequent events through July 18, 2025, the date on which the financial statements were available to be issued.
