Responsibilities Of Management For The Financial Statements

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with auditing standards generally accepted in the United States of America, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required By ERISA

The supplemental schedule of Assets Held at End of Year as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following description of the Creative Management Services, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement or the Summary Plan Description for more complete information.

General

The Plan is a defined contribution profit sharing plan sponsored by Creative Management Services, LLC (the Company) and subsidiaries d/b/a MC2 for the benefit of eligible employees of the Company, as defined below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration Of The Plan

The Company serves as Plan Administrator. Reliance Trust Company serves as Trustee of the Plan. Reliance Trust Company engages Fidelity Investments (Fidelity) to serve in a sub-custodial capacity.

Eligibility

Participants become eligible for purposes of salary deferrals on the first day of the month following age 21 and after completing one month of employment. Participants become eligible for purposes of Company contributions on the first day of the quarter following attaining age 21 and after completing one year of employment in which they perform 1,000 hours of service. Employees classified as temporary part-time and temporary full-time employees whose regularly scheduled service is less than 1,000 hours of service are not eligible to participate in the Plan.

Contributions

The default rate for automatic enrollment is 3% of compensation. A participant may modify the automatic election on the first day of each month to elect a different salary deferral percentage or elect to not participate in accordance with the deferral procedures of the Plan.

Notes To Financial Statements (*Continued*)

Participants may contribute to the Plan a percentage or dollar amount of their compensation, as defined in the Plan Agreement, through pre-tax or Roth (after-tax) payroll deductions, not to exceed certain Internal Revenue Service (IRS) limitations. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan provides for mandatory Company matching contributions for all participants, calculated as 50% of the first 6% of each participant's compensation that was contributed to the Plan.

The Plan also provides for discretionary profit sharing contributions, which are allocated as of December 31, if authorized by the Board. The Board elected not to make a discretionary profit sharing contribution for either of the years ended December 31, 2024 or 2023.

Participants may direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of registered investment companies and collective investment trust funds.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and an allocation of the Plan's earnings. The allocation of earnings is determined by the earnings of the participant's investment selection based on each participant's account balance, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their salary deferral contributions, plus actual earnings thereon. Participants vest in Company contributions at a rate of 20% for each service year after the second year of service, as defined by the Plan, beginning after the first year of service until they are fully vested. Nonvested amounts are forfeited if a participant terminates employment with the Company prior to full vesting. In the event of the death or disability of a participant, the participant will automatically be considered fully vested.

Forfeited Accounts

The Plan allows the Company to utilize forfeitures to reduce the amount of matching contributions to the Plan. The amount funded by the Company for employer matching was reduced by forfeitures of \$16,132 and \$16,964 during 2024 and 2023, respectively. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$26,034 and \$16,132, respectively. These amounts will be used to reduce future Company contributions.

Notes Receivable From Participants

Participants may borrow from their vested accounts, and these loans are secured by participants' vested account balances. The minimum loan amount is \$1,000, and the maximum loan amount is the lesser of \$50,000 or 50% of the total value of the participant's vested account balance. Loan terms cannot exceed five years, unless used to acquire a personal residence. Interest rates on loans are set by the Plan Administrator; loans are due on various dates through March 2052. Principal and interest are collected ratably through semi-monthly payroll deductions.

Participant Hardship Withdrawals

A participant may withdraw from the Plan that portion of his or her account resulting from salary deferral contributions and the vested portion of Company contributions in the event of undue qualifying financial hardship.

Payment Of Benefits

Upon termination of service due to death, disability or attainment of normal retirement age, a participant may elect distribution of his or her account as a single lump-sum or a retirement annuity.

In-service distributions may be made to a participant who has not separated from service provide the participant has attained the age of 59½.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements. Interest income on investments is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

The net change in fair value of investments represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year and includes any realized gains and losses in securities that were bought and sold during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan Document.

Payment Of Benefits

Benefits are recorded when paid.

Administrative Expenses

Salaries and related benefits of employees who administer the Plan are paid by the Company. Expenses incurred on the purchase or sale of investments are added to the cost or deducted from the proceeds of the respective investment. Substantially all other expenses of the Plan are paid by the Company.

3. Certified Investment Information

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedules that were prepared by or derived from information certified by Reliance Trust Company, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Reliance Trust Company that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rule and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of December 31:

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Notes To Financial Statements (Continued)

Common/Collective Trusts

Valued at the unit value or NAV of shares held by the Plan at year-end. The NAV, as provided by the trustee of the fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The common/collective trusts held by the Plan are not required to be reported in the fair value hierarchy. All of the common/collective trusts held by the Plan file an annual report on Form 5500 as a direct filing entity. The common/collective trusts have no unfunded capital commitments, and these investments may be redeemed daily.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Party In Interest Transactions

Certain Plan investments held with Fidelity are shares of registered investment companies managed by Fidelity. Fidelity is the Custodian of the Plan's assets; therefore, these transactions qualify as party in interest transactions.

Certain employees have outstanding loans with the Plan as of December 31, 2024 and 2023. These loans are considered party in interest transactions allowable under ERISA.

6. Risks And Uncertainties

The Plan invests in investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with investment securities, and the uncertainty related to changes in the value of such securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes in net assets available for benefits.

7. Income Tax Status

Effective January 1, 2021, the Plan was restated and uses a pre-approved plan document sponsored by Sentinel Benefits Group Inc. Sentinel Benefits Group Inc. received an opinion letter from the IRS, dated November 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

9. Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.
