Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of CEVA 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of CEVA 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

A. General

The Plan is a defined contribution plan that was established by CEVA, Inc. (the “Company”) to provide benefits to eligible employees, as defined in the Plan document. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

B. Administration

The Company designated Empower Annuity Insurance Company of America and Empower Trust Company, LLC as trustees and its affiliate, Empower Retirement Services as third-party administrator.

C. Eligibility

Substantially all employees of the Company are eligible to participate in the Plan. Eligible employees may enter the Plan on first day of the month coincident with or next following their date of hire. The Plan specifically excludes leased employees, non-resident aliens who earn no U.S. source income, union employees governed by a collective bargaining agreement, and reclassified employees, such as someone paid as an independent contractor or an out-sourced worker.

D. Participant Contributions

Participants may contribute a specific percentage or dollar amount up to 90% of pretax annual compensation, or Roth deferrals, as defined in the Plan document and within the annual dollar limit set by the Internal Revenue Service Code (the “Code”). Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants who make pre-tax contributions to the Plan receive an equivalent reduction in taxable compensation.

E. Company Contributions

The Company makes matching contributions equal to 100% of the first 3% or 6% of eligible compensation deferred or 50% of the first 6% of eligible compensation deferred by each participant, depending on a participant’s date of hire and division. The Plan permits additional matching and nonelective contributions at the Company’s discretion. No additional discretionary employer contributions were made in 2024.

F. Participant Accounts

Each participant’s account is credited with the participant’s contributions, rollover contributions, Company contributions, if any, and an allocation of Plan earnings or losses and expenses. Participants may direct their investments among a diversified menu of core investment funds offered under the Plan. Assets of the Plan are invested based solely on participant directions.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

F. Participant Accounts (Continued)

The contributions of participants who decline to make an investment election are invested in the American Funds Retirement Fund that is appropriate for the individual's age and projected date of retirement.

G. Vesting and Forfeitures

Participants are immediately vested in their contributions, rollovers, and related earnings. Vesting in the Company's contributions, if any, occurs over a four year period and participants are 100% vested in Company contributions after four years. Forfeitures of terminated participants' non-vested accounts may be used to reduce Company contributions or to pay Plan administrative expenses. During 2024, \$10,000 of forfeitures were used to fund Company contributions. The forfeiture account balance was approximately \$14,000 and \$7,000 as of December 31, 2024 and 2023, respectively.

H. Expenses

Investment fund operating expenses, brokerage, administrative and trust fees are charged directly to the investment funds and are thereby factored into each investment fund as a reduction of investment return. Participant loan administration and benefit payment processing costs are charged directly to participants. Other costs incurred for administering the Plan may be paid by the Plan or the Company.

I. Payment of Benefits

Participants are eligible for benefits upon attainment of age 59 ½, retirement, disability or termination of service. A participant's benefit under the Plan is equal to his or her account balance. Benefits are payable in a lump sum. Hardship distributions are permitted under limited circumstances subject to approval of the plan administrator. The accounts of terminated participants valued at \$5,000 or less who do not make an affirmative election concerning distribution of their accounts may be distributed by the plan administrator in accordance with applicable provisions of the Code.

J. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account balance, bears interest at a rate equal to 2% above the prime rate and must be repaid to the Plan within a five-year period, unless a loan is used for the purchase of a principal residence. Principal and interest are paid ratably through payroll deductions. Delinquent notes are recorded as a distribution based on terms of the Plan. Outstanding participant notes at December 31, 2024 carry interest rates ranging from 3.25% to 10.25% with various maturities through October 2029.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Investment Valuation and Income Recognition

Investments are stated at fair value except for fully benefit-responsive investment contracts which are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made under a contract plus earnings, less participant withdrawals and administrative expenses. Purchases and sales of securities are recorded when settled and interest and dividend income is recorded when received. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

C. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

D. Risks and Uncertainties

Plan investments are exposed to various investment risks such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - PARTY-IN-INTEREST TRANSACTIONS

An investment offered under the Plan is issued by Empower. Purchases and sales of this investment and payment of expenses to Plan service providers from Plan assets are considered party-in-interest transactions under ERISA. Such transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 4 - TAX STATUS

The Company adopted a prototype plan that has received a favorable opinion letter from the Internal Revenue Service stating that the form of the Plan qualifies under applicable provisions of the Code. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEES

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

NOTE 6 - FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value as follows: Level 1 refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2 refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3 refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified based on the lowest level of input that is significant to the fair value measurement.

Mutual funds are valued at the daily closing price reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

NOTE 7 - GUARANTEED INTEREST FUND

The Guaranteed Interest Fund is maintained in an insurance company general account. Empower Annuity Insurance Company of America is contractually obligated to repay principal and a specified interest rate to the Plan. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The average yield earned by the Plan can be derived by averaging the quarterly gross interest rates for the fund over the year. The averages of 2024 and 2023 are 1.66% and 1.48%, respectively.

The fund meets fully benefit-responsive investment contract criteria and is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan. There are no reserves against contract value for credit risk of the contract issuer.

A provision in the contract prohibits the immediate pay out of investments in the fund at contract value for certain Plan level events. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through July 8, 2025, the date on which the financial statements were available to be issued. There are no material subsequent events that require recognition or additional disclosure in the Plan's financial statements.
