INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the
International Union of Operating Engineers
Local 30 Benefits Fund

Opinion

We have audited the financial statements of the International Union of Operating Engineers Local 30 Benefits Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

The supplemental Schedules of Benefits Paid, Schedules of Administrative Expenses, Schedule of Assets Held at End of Year, and Schedule of Reportable Transactions, together referred to as “supplemental information,” are presented for the purpose of additional analysis and are not a required part of the financial statements. The supplemental Schedule of Assets Held at End of Year and Schedule of Reportable Transactions represent supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The supplemental information is the responsibility of the Plan's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the International Union of Operating Engineers Local 30 Benefits Fund (the Plan) provides only general information about the Plan's provision. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

The Plan was established on November 14, 1951, pursuant to collective bargaining agreements between the International Union of Operating Engineers Local 30 and various employers and employer associations in the heating, ventilation, and air conditioning industry. The Plan is a multiemployer welfare benefit plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The Plan provides health benefits, including hospital, major medical, prescription drug, dental, life insurance, supplemental disability, and optical coverage, to eligible participants and their covered dependents, as well as retired participants and their spouses and dependents. Certain participants receive sick pay benefit as stipulated in the collective bargaining agreement of their employer.

The Plan utilizes a pharmacy benefit manager that makes periodic refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Stop Loss Coverage

The Plan has entered into stop-loss insurance arrangements in an effort to limit its exposure for self-insured benefits. Stop loss refunds of \$1,823,751 and \$3,897,328 have been netted with claims paid for the year ended December 31, 2024 and 2023, respectively.

Eligibility

Active participants become eligible for benefits on the first day of the month following eight consecutive weeks of employment with a covered employer. Coverage terminates on the last day of the month following the month in which full-time employment has ceased with a contributing employer.

NOTE 1. DESCRIPTION OF THE PLAN (continued)

Participants retiring after age 60 are permitted to make voluntary contributions for a period not to exceed 5 years after expiration of COBRA coverage. The Plan provides a retiree health allowance to participants who meet certain age and service requirements at the date of retirement.

Inactive participants and surviving dependents who fail to meet eligibility requirements may pay to extend coverage for a maximum period of 18 months. Qualifying spouses and dependents may pay to extend coverage for a maximum period up to 36 months.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The accompanying financial statements are prepared using the accrual basis of accounting.

Investments and Income Recognition - Investment in mutual funds are carried at fair value, which generally represents the quoted market price or net asset value of the fund as of the last business day of the fiscal year as provided by the custodian. The investment in the common collective trust is carried at estimated fair value as provided by the trusts. Short-term investments are carried at cost, which approximates fair value. The investment in real estate partnership is carried at estimated fair value as determined by the investment advisor.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) include the Plan's gains and losses on investments bought and sold as well as held during the year.

Property and Equipment - Property and equipment are carried at cost. Major additions are capitalized while replacements, maintenance, and repairs, which do not improve or extend the lives of the respective assets, are expensed currently. Depreciation is computed over the estimated useful lives for furniture and fixtures of 5 to 10 years by the straight-line method.

Depreciation expense totaled \$80,799 and \$78,561 for the years ended December 31, 2024 and 2023, respectively.

Employer Contributions - Employer contributions due but not paid at year end are recorded as contributions receivable. The Plan believes that the receivables are fully collectible; therefore, no allowance for credit losses is recorded. Contributions are accounted for as exchange transactions.

Claims Incurred but not Reported - Claims incurred but not reported at year-end were estimated by the Plan's consultant based on historical claims experience.

Accumulated Eligibility Credits - The estimated obligation for accumulated eligibility credits was calculated by the Plan's consultant.

Payment of Benefits - Benefit payments are recorded when paid.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Refunds - The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs. Refunds due are recorded when earned. Pharmacy rebates of \$5,654,216 and \$5,169,995 have been netted in the accompanying 2024 and 2023 statements of changes in net assets available for benefits, respectively.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. Employer contributions are accounted for as exchange transactions.

NOTE 3. FUNDING POLICY

The Plan is funded through employer contributions, as well as contributions from members electing COBRA coverage. The employer contribution rates vary and are set forth in the collective bargaining agreements.

NOTE 4. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

NOTE 5. TAX STATUS

The Plan obtained its determination letter on January 23, 1956, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of Section 501(c)(9) of the Internal Revenue Code, and was, therefore, exempt from Federal income taxes. The Plan has been amended since receiving the determination letter. The Plan's Administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE 5. TAX STATUS (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

NOTE 6. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

NOTE 6. FAIR VALUE MEASUREMENTS (continued)

For the years ended December 31, 2024 and 2023, there were no transfers in or out of levels 1, 2 or 3.

(a) - The Plan has a 25% interest in the 1616 WSE, LLC real estate partnership. The IUOE Local 30 Pension Fund owns the remaining 75% interest in 1616 WSE, LLC. 1616 WSE, LLC owns 16-16 Whitestone Expressway in Whitestone, New York, which was last valued by an independent appraiser as of December 31, 2023 with a post-completion market value of \$57,000,000. The Plan's proportionate interest in the appraised value is included in the determination of the Plan's partnership interest. The 1616 WSE, LLC real estate partnership is measured at estimated fair value by the investment advisor, without adjustment by the Plan. As of December 31, 2024 and 2023, the estimated fair value of the Plan's interest was \$14,368,795 and \$14,415,117, respectively.

NOTE 7. MEDICARE PART D PROGRAM

The Plan provides prescription drug coverage to eligible participants. The Plan's consultant has determined that benefits provided by the Plan were at least actuarially equivalent to Medicare Part D, and, accordingly, the Plan is entitled to a subsidy under the Medicare Prescription Drug, Improvement, and Modernization Act of 2003. The Plan estimated revenue of \$27,347 and \$67,988 during the years ended December 31, 2024 and 2023, respectively. The Plan was due \$67,346 at December 31, 2024, and \$87,988 at December 31, 2023.

NOTE 8. POSTRETIREMENT BENEFIT OBLIGATIONS

The Plan provides lifetime health care coverage to eligible retirees and their dependents.

Accounting principles generally accepted in the United States of America require that the Plan include the actuarial present value of postretirement benefit obligations in the benefit obligations of the Plan.

The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants.

NOTE 8. POSTRETIREMENT BENEFIT OBLIGATIONS (continued)

The following were significant assumptions used in the postretirement benefit obligation valuations as of December 31, 2024 and 2023:

Investment return: 5.50% for 2024 and 4.75% for 2023

Mortality: Healthy: Headcount-Weighted RP-2006 Blue Collar Healthy Annuitant Mortality Table using generational projection with Scale MP-2021 for 2024 and 2023.

 Disabled: Headcount-Weighted RP-2006 Disabled Retiree Mortality Table using generational projection with Scale MP-2021 for 2024 and 2023.

Per capita costs are expected to exceed annual maximum reimbursements; therefore, health care cost trend rates will have no impact on obligations.

For the year ended December 31, 2024, an actuarial experience loss increased obligations by \$3,560,456. This was the net result of gains and losses due to demographic changes.

For the year ended December 31, 2024, valuation assumption changes decreased obligations by \$4,936,351. This was the result of a decrease in obligations due to raising the discount rate.

For the year ended December 31, 2023, an actuarial experience gain decreased obligations by \$1,921,591. This was the net result of gains and losses due to demographic changes.

For the year ended December 31, 2023, valuation assumption changes increased obligations by \$1,651,716. This was the net result of an increase in obligations due to updating the generational mortality improvement scale assumption, and an increase in obligations due to lowering the discount rate.

For the year ended December 31, 2023, a plan amendment increased obligations by \$1,551,663. As of January 1, 2023, retiree health coverage was extended to the surviving spouses of active participants with at least 20 years of participation in the Plan.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

The Plan shares facilities and staff with related organizations. The Plan reimburses the Union and Credit Union for its portion of shared administrative expenses which includes salaries, payroll taxes and employee benefits.

The Plan charges the related parties for their allocated portion of common administrative expenses. Such expenses are allocated pursuant to a cost sharing agreement approved by the Board of Trustees and are payable monthly. The Plan also collects contributions on behalf of the related entities.

The Plan's share of allocated expenses from the Union totaled \$45,394 and \$33,988 for the years ended December 31, 2024 and 2023, respectively.

Master Lease

On August 17, 2010, 5225, LLC (the Company) was formed to acquire, develop, finance, construct, maintain, own, operate, manage, lease, rent, renovate, improve, and sell the company. As the sole member of the Company, the Pension Fund executed the Operating Agreement. On June 1, 2012, the existing agreement was amended and restated to admit the Benefits Fund as a member of the Company. The WhiteStar Advisors, LLC were appointed the initial manager and responsible for day-to-day management of the Company.

In October 2011, the Company purchased the 16-16 Whitestone Expressway property located in Whitestone, NY and the Benefits Fund and Pension Fund entered into a lease agreement with the Company for the entire building. The building was completed during 2015 and the Benefits Fund and Pension Fund moved into the property in December 2015.

NOTE 10. RELATED PARTY TRANSACTIONS (continued)

On September 13, 2016, the Company's name was changed from 5225, LLC to 1616 WSE, LLC.

On March 1, 2016, a limited liability company operating agreement was entered into between 16-16 MT, LLC and the Benefits Fund and Pension Fund. The WhiteStar Advisors, LLC were appointed the manager of the Company and responsible for day-to-day management, which includes subleasing space within the Whitestone property to affiliated and non-affiliated entities. The sub-lessees are invoiced monthly and make payments to 16-16 MT, LLC. The payments from the sublease cover a portion of the amount owed to 1616 WSE, LLC for the monthly Master Tenant lease payment so the two Master Tenant members (Pension Fund and Benefits Fund) transfer money for the shortage into 16-16 MT, LLC.

The Plan made contributions of \$605,639 and \$423,34 in accordance with the master lease during the years ended December 31, 2024 and 2023, respectively.

Office Space Lease

On November 19, 2015, the Plan entered into a twenty year lease with 16-16 MT, LLC. Effective September 1, 2021, the lease was amended and extended to November 30, 2042. 16-16 MT, LLC is 75% owned by the Pension Fund and 25% owned by the Plan. The lease has a base rent with provisions for additional rent that is proportionately paid by the Plan. Rent expense totaled \$211,102 and \$201,833 for the years ended December 31, 2024 and 2023, respectively.

Certain plan investments are shares of a common collective trust managed by Amalgamated Bank, the Trustee, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. These transactions have been denoted as such on the supplemental schedule of assets held at end of year.

The transactions above qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

NOTE 11. CONCENTRATION OF CASH

The Plan places some of its cash and money market funds with the Northeastern Operating Engineers Federal Credit Union, a related party. The balances are insured by the National Credit Union Share Insurance Fund (NCUSIF) up to \$250,000. The Plan also maintains some of its cash at another financial institution. The balance is insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. Cash balances may at times exceed the NCUSIF and the FDIC insured deposit limit.

NOTE 12. RISKS AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, sector, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 12. RISKS AND UNCERTAINTIES (continued)

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and participant demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 13. FEES MANDATED BY THE PATIENT PROTECTION AND AFFORDABLE CARE ACT

The Plan is subject to certain fees mandated by the Patient Protection and Affordable Care Act. Fees payable to the Patient-Centered Outcomes Research Institute (PCORI) are equal to \$3.22 and \$3.00 per covered life for the 2023 and 2022 calendar years, respectively. Thereafter, the fee will be indexed based on increases in the projected per capita amount of national health expenditures. For the years ended December 31, 2024 and 2023, the Plan paid \$22,963 and \$20,565 in PCORI fees, respectively.

NOTE 14. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through May 29, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
