Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the First Pioneer Bank Corp. 401(k) Profit-Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 – Description of the Plan

The following description of the First Pioneer Bank Corp. 401(k) Profit-Sharing Plan (the "Plan") provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan, which went into effect January 1, 1989, that is generally available to all employees of First Pioneer Corp. (the "Company", "Plan Sponsor", or "Plan administrator"), The Farmers State Bank of Brush, and First Pioneer National Bank (collectively, the "Employer"). The Plan excludes part-time/temporary/seasonal employees and reclassified employees. Employees become eligible to participate in the Plan after completing 60 days of service and may enter the Plan on the first day of the month coinciding with or next following the date they meet the Plan's eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

SECURE Act of 2019. Under the SECURE Act of 2019, certain long-term part-time ("LTPT") employees became eligible for participant salary deferral contributions on January 1, 2024, after completing 500 hours of service for three consecutive years.

Plan Amendments. Effective January 1, 2024, the Plan document was amended as follows:

- Employees become eligible to participate in the Plan after completing 60 days of service and may enter the Plan on the first day of the month coinciding with or next following the date they meet the Plan's eligibility requirements; and
- The Plan provides for an automatic contribution arrangement ("ACA"). Unless an eligible participant makes an affirmative election otherwise, they will be auto-enrolled into the Plan with a 5% elective deferral contribution.

Contributions. The following types of contributions are allowable under the Plan:

- Elective Deferral Contributions – Participants may contribute a percentage of their pre-tax compensation, as defined in the Plan document, subject to limitations. Participants may also contribute a percentage of their after tax compensation and designate it as a Roth deferral contribution. The Plan provides for an automatic contribution arrangement ("ACA"). Unless an eligible participant makes an affirmative election otherwise, they will be auto-enrolled into the Plan with a 5% elective deferral contribution. A participant's total contributions cannot exceed \$23,000 (\$30,500 if age 50 or older) in calendar year 2024.
- Safe Harbor Employer Nonelective Contributions – The Employer makes a safe harbor Employer nonelective contribution each Plan year equal to 3% of an eligible participant's compensation.
- Employer Matching Contributions – The Employer makes matching contributions each payroll period equal to 100% of an eligible participant's elective deferral contributions up to 5.5% of a participant's compensation.
- Discretionary Employer Contributions – The Employer may make a discretionary contribution to eligible participants who have completed 1,000 hours of service and are employed on the last day of the Plan year. Participants who die, become disabled, or terminate employment on or after attaining normal retirement age are also eligible to receive an allocation of the discretionary Employer contribution. This contribution is allocated to eligible participants' accounts in the ratio that each participant's compensation bears to the compensation of all eligible participants.
- Rollover Contributions – Amounts distributed to participants from other qualified employee benefit plans may be rolled into the Plan.

Note 1 – Description of the Plan (continued)

All contributions are allocated to the Plan's investment funds at the direction of the participants. The total annual additions to a participant's account may not exceed the lesser of \$69,000 or 100% of the participant's compensation.

Investment Options. Participants may direct their investments into various pooled separate accounts, registered investment companies, and an investment contract with insurance company.

Participant Accounts. Each participant's account is increased and/or decreased, as applicable, with the participant's contributions (elective deferrals and rollovers, if any) and an allocation of (a) the Employer's contribution (safe harbor nonelective, matching and discretionary), (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting. Participants are immediately vested in their elective deferral contributions, rollover contributions, safe harbor Employer nonelective contributions, and related earnings thereon. Employer matching and discretionary Employer contributions made to a participant's account vest according to the following schedule:

Furthermore, employed participants become 100% vested in their Employer matching and discretionary Employer contribution accounts upon the following events:

- Participant's death;
- Participant becomes disabled as defined under the Plan;
- Participant reaches their normal retirement age; or
- Termination or partial termination of the Plan.

Forfeitures. When certain terminations of participation in the Plan occur, the non-vested portion represents a forfeiture. Forfeitures are used to pay Plan expenses, used to reduce Employer contributions, or are reallocated to eligible participants as a discretionary Employer contribution. During 2024, forfeitures of \$89 were used to pay Plan expenses. The balance in the unutilized forfeitures account was \$21,753 and \$11,829, as of December 31, 2024 and 2023, respectively.

Payment of Benefits. Benefits to participants or beneficiaries are generally payable as a lump-sum, partial payment, or installments equal to the value of their vested account balance upon retirement, termination of employment, death or disability. Participant may also elect a rollover distribution of their vested account balance into another qualified plan or Individual Retirement Account. Additionally, participants may elect in-service withdrawals of their rollover contributions account, upon attainment of age 59 ½, for a qualified reservist distribution, or upon incurring a financial hardship, as defined, if certain criteria are met.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates. The financial statements of the Plan are prepared using the accrual method of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions. Participant contributions and the related Employer matching contribution are recognized in the period in which participant contributions are withheld from compensation.

Benefit Payments. Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Included in administrative expenses are contract administrator, recordkeeping, and other fees. Certain investment related expenses are included in net appreciation in fair value of investments.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

- Pooled Separate Accounts ("PSAs") are valued at the net asset value ("NAV") of units held by the Plan at year end. The NAV, as provided by the custodians, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the PSAs less their liabilities. This practical expedient is not used when it is determined to be probable that the PSAs will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.
- Registered investment companies are valued at the quoted NAV of shares held by the Plan at year end.
- The investment contract with Principal Life Insurance Company ("Principal Life"), the Guaranteed Interest Account ("GIA"), is valued at fair value by the insurance company by using a discounted cash flow valuation methodology and by considering the credit-worthiness of the issuer. Fair value is the amount plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity for an event other than death, disability, termination or retirement. This fair value represents contract value adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates (see Note 4).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) Various short-term fixed income, fixed income, balanced / asset allocation, small/mid/large US equity, global / international equity, and U.S. real estate investment strategies.
- (b) All the PSAs offered under the Plan, with the exception of the Liquid Assets Separate Account, have transfer restrictions that limit the number of transfers allowed to 1 transfer every 30 day period.
- (c) US Property Separate Account: Participants that contribute funds into this PSA may not be able to immediately withdraw them. This PSA is unlike most other retirement plan investment options because it invests primarily in owned private equity commercial real estate rather than securities. Unlike public securities sold on an exchange, commercial real estate assets are usually sold in time-consuming, and often complex, transactions. Due to the nature of these transactions, this PSA may be subject to market conditions which may delay or prevent a sale. Principal Life may implement a pre-existing contractual limitation in the group annuity contract which allows them to manage the PSA and satisfy withdrawal or transfer requests proportionately over time and fairly among all those making a request.

Note 4 – Investment Contract with Insurance Company

The Plan has entered into an investment contract with Principal Life, the GIA. The GIA provides for a guarantee of principal and interest. Contributions and transfers allocated to the GIA will be credited interest at a guaranteed interest rate Principal Life declares for a set period of time (the "Guarantee Period"). Guaranteed interest rates for new allocations are subject to change daily, and each amount allocated to the GIA will earn interest based on this guaranteed interest rate in effect for the date that the amount is allocated to the GIA. Guarantees are supported by the General Account of Principal Life, but do not participate in the investment experience or performance of the General Account.

The GIA promises contract value for a benefit event (termination, death, disability and retirement); however, there is a possible surrender charge when funds are withdrawn prior to their maturity. Thus, the GIA is considered non-benefit responsive. For withdrawals made prior to maturity, payment will be made within 7 days, but Principal Life reserves the right to defer payment up to 270 days.

Note 5 – Certified Information

The following information disclosed in the accompanying financial statements and ERISA-required supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal Trust"), the custodians of the Plan:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and Note 3;
- Investment income and other income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024; and
- The investment information presented in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown in the supplemental schedule.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination or partial termination, affected participants will become 100% vested in their accounts.

Note 7 – Tax Status

The Plan Sponsor has adopted a Principal Life Insurance Company Non-Standardized Pre-Approved Profit Sharing Plan (“pre-approved plan”). The pre-approved plan received an opinion letter from the IRS on June 30, 2020, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code (“IRC”). Although the pre-approved plan and the Plan have been amended since receiving the IRS opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related Trust is tax exempt as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Party-In-Interest Transactions

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

Certain Plan investments are units of pooled separate accounts and a GIA offered by Principal Life. As Principal Life and Principal Trust are the custodians of the Plan, these transactions qualify as party-in-interest transactions. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

Note 9 – Concentrations, Risks, and Uncertainties

The Plan provides for various investment options in pooled separate accounts, registered investment companies, and a GIA. Investment securities, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts presented in the Statements of Net Assets Available for Benefits. As of December 31, 2024 and 2023, there were two investments which individually represented more than 10% of net assets available for Plan benefits. See supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

Note 10 – Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through July 21, 2025, which is the date the financial statements were available to be issued.

Under the SECURE 2.0 Act of 2022 ("SECURE 2.0"), certain LTPT employees become eligible for participant salary deferral contributions on January 1, 2025, after completing 500 hours of service for two consecutive years and attainment of age 21.
