Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Lutheran Homes of Oconomowoc Retirement Plan (the "Plan") provides only general information. For a more complete description of the Plan, participants should refer to the plan document.

General

The Plan is a participant-directed defined contribution plan established for a not-for-profit organization, commonly known as a Code Section 403(b) savings plan. Lutheran Homes of Oconomowoc is the plan sponsor (the "Sponsor") and is a not-for-profit corporation as described in Section 501(c)(3) of the Internal Revenue Code (the "Code"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA and, therefore, provides that participants may choose to direct their contributions and/or all or part of their account balances among the Plan's investment alternatives. All investments are participant-directed.

Eligibility and Participation

Substantially all employees of the Sponsor are eligible to participate in the Plan.

To be eligible for the purpose of receiving matching Sponsor contributions, employees must complete 1 year of service and 1,000 hours and must be at least 18 years of age. Eligible employees begin receiving Sponsor contributions on January 1st or July 1st coincident with or immediately following the attainment of these requirements.

Contributions

Each year, participants may contribute between 1% and 100% of compensation, as defined in the Plan, not to exceed the limits of the Internal Revenue Service ("IRS"). Participants may also contribute amounts representing distributions from other qualified retirement plans ("rollovers"). In addition, the Sponsor contributes a 100% match of the employee contribution, not to exceed 5% of participant's eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Sponsor's contributions and (b) plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Notes Receivable From Participants

Participants may borrow from their account balance the lesser of \$50,000 or one-half of the participant's vested account balance. Loans to participants are treated as a separate investment of the participant and all principal and interest payments on loan balances are credited to the participant's account from which the loan was made. The loans are secured by the vested balance in the participant's account and bear interest at a fixed rate determined by the plan administrator based on prevailing market conditions. Interest rates on existing loans are set between 3.25% and 8.50%. Participants may only have one loan outstanding at any particular time. Principal and interest is paid ratably through bi-weekly payroll deductions.

Vesting

Participants are immediately vested in their voluntary contributions, Sponsor contributions, and actual earnings (losses) thereon.

Payment of Benefits

Benefits are paid to the participant or beneficiary upon death, disability, or retirement, up to the amount of the participant's interest in the participant's account. Benefits may be paid in a lump-sum distribution or distributed in installment payments. For termination of service due to other reasons, a participant may receive the value of the interest in their account as a lump-sum distribution. In addition, hardship distributions are allowed if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 55 and three years of service.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that directly affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates and are subject to change in the near term.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except the stable value fund, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the Plan through an allocation to participant accounts. Per-use fees are charged directly to the participant accounts. The Sponsor pays certain professional fees and other plan expenses, which are excluded from the accompanying financial statements. Investment related expenses are allocated proportionately to plan participants based on their respective account balances and are included in investment income.

Subsequent Events

The Plan has evaluated subsequent events through July 21, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflection of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of a different methodology or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Information Prepared and Certified by Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including cash, investments, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the Custodian of the Plan.

Note 5: Guaranteed Investment Contracts

The Plan includes a fully benefit-responsive stable value fund. The issuer of this investment maintains the contributions in a general account. The investment issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the stable value fund is fully benefit-responsive, contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the investment. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Plan has the right to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA.

Note 7: Tax Status of the Plan

The Plan adopted the Standard Retirement Services, Inc. 403(b) Prototype Plan with an IRS notification letter dated June 30, 2020, which states the prototype plan document is in compliance with the applicable sections of the Code. The Plan has been amended since receiving the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Party-in-Interest Transactions

Standard Insurance Company is the Plan's third-party administrator. Additionally, Charles Schwab Trust Bank is an affiliate of Schwab Funds, the issuer of certain mutual funds within the Plan's portfolio. Transactions with Standard Insurance Company, Charles Schwab Trust Bank, and notes receivable from participants are party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.
