Baker Bro., LLC 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). **1. Description of Plan**

The following brief description of the H.J. Baker & Bro., LLC. 401(k) Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Summary Plan Description or the current Plan document for a complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering all eligible employees of H.J. Baker & Bro., LLC (the "Company" or "Employer"). Employees are not eligible to participate in the Plan if they are: leased employees, nonresident aliens, employees who are residents of Puerto Rico, or covered employees acquired in an asset or stock acquisition, merger, or similar transaction. Eligible employees are eligible to participate in the Plan on the first day of the month after completing 1 month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

***Contributions***

Each year, eligible employees may contribute up to 100% of their eligible compensation on a pre-tax or Roth basis, as defined in the Plan document, subject to certain Internal Revenue Code ("IRC") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollovers) from another qualified plan.

The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 3% of their eligible compensation. The amount will be contributed on a pre-tax basis. Each year, the deferral rate will be automatically increased by 1% until the participant reaches 10% of their eligible compensation.

The Employer makes a safe harbor matching contribution for eligible participants equal to 100% of the first 3% of the participant's eligible compensation contributed to the Plan plus 50% of the next 2% of the participant's eligible compensation contributed to the Plan. For the 2024 plan year, safe harbor matching contributions amounted to approximately \$378,700. The Employer may also make a discretionary non-elective contribution to the Plan. For the 2024 plan year, the Employer made a non-elective contribution to the Plan equal to 5% of participants' eligible compensation for those participants employed on the last day of the plan year. For the 2024 plan year, non-elective contributions made to the plan amounted to approximately \$487,400.

***Participants' Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

**1. Description of Plan (continued)**

***Vesting***

Participants are immediately vested in their contributions and Employer safe harbor matching contributions and actual earnings thereon. Vesting in the Company's non-elective contributions is based on years of credited service. Participants vest in the Company's non-elective contributions, if any, based on the schedule below:

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the participant's vested account balance and bear interest at the prime rate plus 2%. A participant may only have 2 loans outstanding at any given time. Loan repayments must be made through payroll deductions over a term not to exceed 5 years unless the proceeds of the loan are used to purchase the participant's principal residence, in which case the term is not to exceed 30 years.

***Forfeitures***

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account as defined by the Plan, represents a forfeiture. The Plan document permits the use of forfeitures to either reduce future Employer non-elective contributions or Plan administrative expenses for the Plan year. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$16,154 and \$7,177. During 2024, no amounts were used to reduce Employer non-elective contributions or pay Plan administrative expenses.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement or separation from service, a participant may elect to receive installment payments or a lump sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals from the Plan may also be granted based upon circumstances of financial hardship or after attaining age 59 1/2, in accordance with provisions specified in the Plan document.

***Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are paid by the Plan and are included in net appreciation in fair value of investments.

**2. Summary of Significant Accounting Policies**

***Basis of Presentation and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value (“NAV”) per share as a practical expedient is not categorized within the fair value hierarchy.

***Investment Valuation and Income Recognition***

All of the Plan’s investments are stated at fair value. The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The common/collective trusts are valued at NAV, as provided by the trustees, which is used as a practical expedient based on the funds’ underlying investments. The practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus unpaid accrued interest. The Plan considers a note to be in default at the end of the quarter following the quarter when payments have not been received. Defaulted notes are deemed distributed and recorded as benefits paid to participants in the statement of changes in net assets available for benefits when a distributable event has occurred.

***Payment of Benefits***

Benefits are recorded when paid.

**5. Common/Collective Trusts**

***T. Rowe Price Stable Value Fund - N***

The T. Rowe Price Stable Value Fund - N (the “SV Fund”) is an investment option offered to participants under the Plan. The SV Fund is operated by T. Rowe Price Trust Company.

The SV Fund’s NAV per unit is computed at the close of the New York Stock Exchange (“NYSE”), each day the NYSE is open for business (valuation date). Generally, trust units are issued and redeemed only on a valuation date and at the NAV per unit computed on that date. The investment objectives of the SV Fund are to maximize current income consistent with the maintenance of principal and to provide for participant withdrawals at NAV for certain events without penalty or adjustment. Fund units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the SV Fund. Retirement plans invested in the SV Fund are required to provide either 12 or 30 months’ advance written notice to the trustee prior to redemption of trust units; the notice period may be shortened or waived by the trustee in its sole discretion.

***Great Gray T. Rowe Price Retirement Date Series***

The Great Gray T. Rowe Price Retirement Date Series (the “Retirement Date Series”) is a collection of investment options offered to participants under the Plan. The Retirement Date Series is operated by Great Gray Trust Company, LLC.

The NAV per unit of each of the target date trusts in the Retirement Date Series is computed at the close of the NYSE, each day the NYSE is open for business (valuation date). Generally, trust units are issued and redeemed only on a valuation date and at the NAV per unit computed on that date. The investment objective of the Retirement Date Series is to seek the highest total return over time consistent with an emphasis on both capital growth and income. Fund units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the Retirement Date Series.

***Great Gray flexPATH Large Cap Value Fund***

The Great Gray flexPATH Large Cap Value Fund (the “LCV Fund”) is an investment option offered to participants under the Plan. The LCV Fund is operated by Great Gray Trust Company, LLC.

The LCV Fund’s NAV per unit is computed at the close of the NYSE, each day the NYSE is open for business (valuation date). Generally, trust units are issued and redeemed only on a valuation date and at the NAV per unit computed on that date. The investment objective of the LCV Fund is to seek capital growth and current income. Fund units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the LCV Fund.

There were no unfunded commitments as of December 31, 2024 and 2023.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer contributions.

**7. Tax Status**

The Plan received an opinion letter from the Internal Revenue Service ("IRS") dated August 19, 2020 stating that the Plan was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**8. Party-in-Interest**

Certain Plan investments are managed by an affiliate of T. Rowe Price Trust Company. T. Rowe Price Trust Company is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Company, who may be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

**9. Risks and Uncertainties**

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
