### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of UPM Raflatac Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the UPM Raflatac Retirement Savings Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

**Note 1: Description of Plan**

The following description of the UPM Raflatac Retirement Savings Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of UPM Raflatac, Inc. ("Company") who are eighteen or older and are not covered by a collective bargaining agreement, nonresident aliens, or expatriates who participate in their home country pension plan. Employees are immediately eligible to participate in the Plan upon reaching age eighteen. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan, and post-tax Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default pre-tax deferral rate set at 6% of eligible compensation. The Plan also includes an auto-escalate provision where participants may increase their pre-tax deferral rate 1% annually on May 1st, up to a maximum of 6%. Contributions are automatically invested in a designated balanced fund until changed by the participant. The Company makes safe harbor matching contributions at the rate of 100% of the first 4% of eligible compensation and 50% of the next 2% of eligible compensation contributed by the participant. The Company also makes a nonelective contribution equal to 4% of each participant's eligible compensation. During the year ended December 31, 2024, the Company made safe harbor matching and nonelective contributions of \$1,676,398 and \$1,498,752 to the Plan, respectively. Contributions are subject to certain statutory limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's matching and nonelective contributions and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are immediately vested in safe harbor matching contributions made by the Company plus actual earnings. Vesting in the Company's nonelective contributions plus actual earnings thereon is based on years of continuous service. A participant is fully vested after five years of credited service. A participant is also fully vested upon reaching normal retirement age, upon death, or upon becoming totally and permanently disabled.

**Note 1: Description of Plan (Continued)**

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 5.25%-10.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest payments are paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons, a participant or designated beneficiary may elect to receive the value of the participant's vested interest in the participant's account as a lump-sum or various installment and annuity options as provided by the Plan. If a participant terminates with a vested balance of less than \$5,000, but greater than \$1,000, the participant's balance will be rolled over to an individual retirement plan designated by the Plan administrator. If a participant terminates with a vested balance less than \$1,000, the participant will receive a lump-sum distribution.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$21,000 and \$91,067, respectively. These accounts will be used to reduce the Plan's future expenses and employer contributions. Also, in 2024, employer contributions were reduced by \$198,498 from forfeited nonvested accounts.

**Note 2: Summary of Significant Accounting Policies**

**Statement Presentation**

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value.

**Use of Estimates**

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Corporate common stocks, registered investment companies, and interest-bearing cash are valued at fair value which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Investment Valuation and Income Recognition (Continued)**

The common/collective trust funds are valued at the net asset value (“NAV”) of the shares held at year-end. The NAV is used as a practical expedient to estimate fair value. The NAV is based on fair value of the underlying investments held by the fund less its liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the plan year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant note receivable to be in default, the participant note receivable balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant’s account.

**Subsequent Events**

The plan sponsor has evaluated subsequent events through July 15, 2025, the date on which the financial statements were available to be issued.

**Note 3: Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs would only be used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

The fair value of registered investment companies consists of mutual funds and are based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The mutual funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The fair value of corporate common stock is based on quoted net asset values of the shares. The shares are registered with the U.S. Securities and Exchange Commission.

The Plan's policy is to recognize transfers into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers of investments into or out of Level 3.

**Note 4: Priorities Upon Termination of the Plan**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become fully vested in their account balances.

**Note 5: Trustee and Administration of the Plan**

The Plan is administered by UPM Raflatac, Inc., the Plan sponsor. The Company uses a third-party administrator to aid in the acquisition, disposition, and accounting for trust assets. Fidelity Management Trust Company is the appointed trustee.

**Note 6: Tax Status**

The Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is exempt from federal and state income taxes. The non-standardized pre-approved plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the underlying non-standardized pre-approved plan was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the IRC.

GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in process.

**Note 7: Information Prepared and Certified by the Trustee**
