Notes to Financial Statements December 31, 2024

1. Description of Plan

The following description of the Fehrer Automotive North America, LLC 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code covering substantially all employees of Fehrer Automotive North America, LLC ("the Company") except for members of a collective bargaining agreement and non-resident aliens, as defined by the Plan, who are at least 18 years of age and have completed 90 days of service. To be eligible for discretionary employer nonelective contributions, participants must be employed on the last day of the plan year or have earned 500 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute 100 percent of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company provides a safe-harbor matching contribution of 100 percent of participant's elective deferrals up to 3 percent and then 50 percent of participant's elective deferrals of the next 2 percent each payroll period. The Company may also make discretionary employer nonelective contributions. There were no discretionary employer nonelective contributions made during 2024. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct their contributions into selected investment options as made available and determined by the Plan Administrator and Plan Sponsor.

Vesting

Participants are vested immediately in their elective deferral and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary employer nonelective portion of their accounts is based on years of continuous service. A participant vests 25 percent per year and is 100 percent vested after four years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at Prime plus 2 percent. Principal and interest is paid ratably through regular payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, early retirement, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in her or her account in a lump sum. Hardship distributions are permitted from the vested portion of a participant's account upon demonstration of financial hardship. In-service distributions are permitted from fully vested accounts upon the participant attaining age 59 ½.

Forfeited Accounts

At December 31, 2024 and 2023 there were \$1,546 and \$1,403 in forfeited non-vested accounts. Forfeitures may be used to reduce future Company contributions or pay for plan expenses. No forfeitures were used during 2024.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include recordkeeping fees and third party administrator fees. Investment related expenses are included in net appreciation/(depreciation) in the fair value of investments.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. There were \$73,179 in loans that defaulted during the year ended December 31, 2024.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for the fair value of the Plan's assets.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Pooled separate accounts are valued using the net asset value (NAV) of units held by the Plan at year end. The NAV is determined by the fund issuer and is based upon the fair value of the underlying assets held by the fund. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

These accounts are not direct filing entities, and therefore the underlying investments are reported on the Form 5500. The John Hancock Stable Value Fund is a separate account that invests in a fully benefit responsive collective investment trust fund. The remainder of the separate accounts each invest in a single mutual fund.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

7. Tax Status

The Plan has received an opinion letter dated June 30, 2020, that the Plan Document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator and the Plan's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust is tax-exempt.

8. Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Related Party and Party-in-Interest Transactions

Fees incurred by the plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid through revenue sharing rather than a direct payment. During 2024, the Plan made direct payments for administration and advisory fees. The Plan sponsor pays directly any other fees related to the operation of the Plan. Certain Plan investments are pooled separate accounts managed by John Hancock, the contract holder and record keeper, as defined by the Plan, and therefore, transactions with John Hancock qualify as party-in-interest transactions.

10. Non-Exempt Transactions

During the plan years ended December 31, 2024, 2023, 2022, and 2021, employee withholdings amounting to \$115,864, \$75,830, \$112,056, \$27,493, respectively, were not remitted within the appropriate time by the Company. These transactions constitute prohibited transactions as defined by ERISA. The Company corrected and remitted the lost earnings for the 2021 and 2022 contributions in December 2024, and corrected 2023 and 2024 in July 2025.
