Retirement Savings Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of Achanges in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

December 31, 2023 and 2024

1. Description of Plan

The following description of the Magellan Health, Inc. Retirement Savings Plan (the “Plan”) provides general information about the Plan’s provisions. Magellan Health, Inc. (the “Company”) is the plan sponsor. Magellan is a wholly owned subsidiary of Centene Corporation. Participants should refer to the plan document for a more complete description of the Plan’s provisions, copies of which may be obtained from the plan sponsor.

General

The Plan is a defined-contribution plan covering all eligible employees of the Company, as defined in the plan document. The Retirement Savings Plan Committee (the “Committee”) is responsible for the general administration of the Plan. Empower Trust Company, LLC and Empower Annuity Insurance Company of America (the “Trustees”) are the trustees of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute from 1% to 75% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other defined-benefit or defined-contribution plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company contributes 50% of the first 6% of base compensation that participants contribute to the Plan. Additional discretionary contributions may be contributed to participants. The Company did not make any discretionary contributions during the year ended December 31, 2024. All contributions are subject to certain limitations of the Internal Revenue Code (the “Code”).

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. Participants who are automatically enrolled have their contributions invested in the applicable target retirement date fund based on their age until they change their election. The Company’s contributions are invested in the same manner as that of a participant’s elective contributions.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions and allocations of plan earnings or losses and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Plan earnings are allocated based on participants' shares of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on participants' account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. The Company's matching contribution portion of a participant's account, plus actual earnings (losses) thereon, vest based on years of continuous services. A participant is fully vested after three to five years of service in accordance with the Plan document.

Forfeitures

Upon termination of employment, participants forfeit their non-vested balances. Forfeited balances are used to reduce future Company contributions. At December 31, 2023 and 2024, forfeited nonvested accounts totaled \$130,884 and \$379,798, respectively. In 2024, the contributions were reduced by \$1,014,957.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Loan terms range from 1–5 years or up to 10 years for the purchase of a primary residence. A participant may not have more than one loan outstanding at any point in time. The loans are secured by the balance in the participant's account and bears interest at an annual rate, fixed by the plan administrator, equal to one percentage point above the prime rate charged on the date the loan is made. Principal and interest are paid ratably through payroll deductions. If a participant terminates employment with the Company, they may continue to make loan payments through a pre-authorized agreement. If a loan is not repaid, it will automatically be treated as a distribution to the participant.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Payment of Benefits

Upon separation from service due to death, disability, or retirement, a participant may receive a lump-sum amount or installment payments equal to the vested value of the participant's account. The Plan also allows in-service withdrawals in certain circumstances as defined by the Plan.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

During the plan year ended December 31, 2023, the Company terminated approximately 1,500 employees as a result of the divestiture of Magellan Specialty Health. Plan management determined a partial termination of the Plan had occurred. The plan instructed the third-party administrator to fully vest participants impacted by the divestiture.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan had no excess contributions payable as of December 31, 2023, and 2024.

2. Summary of Significant Accounting Policies (continued)

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 or 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan (except for fully benefit-responsive investment contracts) are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

The Group Stable Asset Fund is invested in broadly diversified, fixed-income portfolio and is fully benefit-responsive. This fund is recorded at contract value, which is the relevant measurement attributable to fully benefit-responsive investment contracts because contract value represents the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees, which approximates the fair value. See Note 5 for further discussion on the fully benefit-responsive investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. Investments

Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2023 and 2024, and net appreciation in fair value of investments, interest, dividend income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by the Trustees of the Plan.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - Quoted prices for similar assets and liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in markets that are not active
 - Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (i.e., interest rate and yield curve quotes at commonly quoted intervals)
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

4. Fair Value Measurements (continued)

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

Mutual Funds – Valued at quoted prices in an active market, which represent net asset value of shares held by the Plan at year end.

5. Fully Benefit-Responsive Investment Contracts

The Plan held traditional investment contracts for the years ended December 31, 2023 and 2024 that met the fully benefit-responsive investment contract criteria and therefore are reported at contract value. The Group Stable Asset Fund is a fixed-rate fund that guarantees interest rates. The rates are guaranteed for three months at a time for the fully benefit responsive investment contracts held as of December 31, 2024. Participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account balances at contract value within reasonable time frames. The issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Interest is credited on contract balances using a single-portfolio-rate approach. Under this methodology, a single, interest-crediting rate is applied to all contributions made to the product regardless of the timing of those contributions. Interest-crediting rates are reviewed on a quarterly basis for resetting under the fully benefit-responsive investments contracts held. When establishing interest-credit rates for these products, many factors are considered, including current economic conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. These rates are established without using a specific formula. Generally, there are not any events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value over time. There are not any events that allow the issuer to terminate the contract and that require the plan sponsor to settle on an amount different from contract value paid either within 90 days or over time.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Related-Party Transactions

Certain of the Plan's administrative functions were performed by Empower Retirement. In addition, certain plan investments are shares of a group stable asset fund managed by Empower Annuity Insurance Company of America. Transactions with Empower Annuity Insurance Company of America qualify as exempt party-in-interest transactions.

8. Tax Status

The Plan has received a determination letter from the Internal Revenue Service (“IRS”) dated June 30, 2020 stating that the Plan is qualified under Section 401(a) of the Code and therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and therefore, believes the Plan, as amended and restated, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Subsequent Events

The Company evaluated all subsequent events for the Plan through July 15, 2025, the date financial statements were available to be issued.
