## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

## Notes to Financial Statements

December 31, 2024

### 1. Description of Plan

The following description of QAS Management LLC 401(k) PSP & Trust ("the Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a safe harbor plan under Section 401(k) of the Internal Revenue Code covering all employees of QAS Management LLC ("the Company") who are 19 years of age or older and have completed at 3 months of service, as defined by the Plan, except for collective bargaining employees and non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Contributions***

Each year, participants may contribute up to 80 percent of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company contributes safe harbor matching contributions of 100 percent of the first 4 percent of participants' compensation which is deferred to the Plan. The matching contributions are annualized through a true-up contribution subsequent to year-end. True-up contributions are included in employer contributions receivable. The Company may make discretionary non-elective contributions to the Plan for each employee who is employed on the last day of the plan year. There were no non-elective contributions made during the Plan year ended December 31, 2024. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, Company matching contributions, as well as allocations of plan earnings. Allocations are based upon participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers collective investment trust funds, a fixed account, and registered investments, through a group annuity contract, as investment options for participants.

#### ***Vesting***

Participants are vested immediately in their contributions and the Company safe harbor contributions, plus actual earnings thereon. Employer non-elective contributions will vest 20 percent after 2 years of service and become fully vesting after 6 years of service.

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at the rate of prime plus 2 percent, which is commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid ratably through payroll deductions.

### ***Payment of Benefits***

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in fixed installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also permits in-service distributions for participants that have attained age 59 ½. Distributions for reason of hardship, as defined in the Plan, are permitted from all accounts.

### ***Forfeited Accounts***

Forfeitures may be used to reduce Company contributions or plan expenses. At December 31, 2024 and 2023, there were no forfeited non-vested account balances.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value except for the fixed account which is reported at contract value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Participant loans in the amount of \$27,608 were deemed defaulted during 2024 and recorded as distributions.

### ***Payment of Benefits***

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Fees charged for benefit payments are also charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments.

### **3. Unaudited Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company ("VOYA") has certified that the following data included in the accompanying financial statements is complete and accurate.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to related information in the financial statements and supplemental schedules.

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

The Plan currently participates in a Group Annuity Contract through VOYA. This contract holds sub-accounts which comprise of collective investment trust funds and registered investments under the variable portion of the contract. As the contract does not file its own 5500 return and participants select from the sub-accounts, the Plan reports the underlying investment options which are available to participants as described below.

*Registered Investments:* The fair values of participation units held in the registered separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each of the separate accounts invest in a single, open-ended mutual fund which is generally identified in the name of the separate account. The investment strategies of these separate accounts are consistent with each of the mutual funds identified in the name of the fund. Each of the separate accounts provides for daily redemptions by the Plan with no advance requirements and has redemption prices that are determined by the fund's net asset value per unit.

*Collective Investment Trust Funds:* The Plan invests in equity based funds. They are valued at 4 pm EST on the last calendar day of the period. The portfolios obtain prices from one or more third party pricing vendors to value its investments. The funds are valued using NAV as a practical expedient.

### 6. Fully Benefit Responsive Insurance Contract

In January 2023, the Plan entered into a fully benefit responsive insurance contract with VRIAC. VRIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate to the Plan. The account has a guaranteed interest rate set by the insurance company.

Contract value, as reported to the Plan by VRIAC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1 percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The contract value of the VRIAC Fixed Account was \$17,846 and \$34,327 as of December 31, 2024 and 2023, respectively.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants are 100 percent vested in their accounts. Any unallocated assets of the Plan would be allocated to participant accounts and distributed in such a manner as the Company may determine.

### **8. Non-Exempt Transactions**

During the 2024, 2023 and 2022 Plan years, the Company failed to deposit participant contributions in the amounts of \$285, \$55,374 and \$40,926, respectively, within the required timeframe as stated by the DOL regulations. These transactions constitute non-exempt transactions as defined by ERISA. The Company remitted the contributions during the 2024 and 2023 plan years.

### **9. Tax Status**

The Plan has received an opinion letter dated June 30, 2020, that the Plan Document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator and the Plan's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust is tax-exempt.

### **10. Risks and Uncertainties**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **11. Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are shares of registered separate accounts, collective investment trust funds, and fixed accounts managed by VOYA. VOYA is the current recordkeeper and, therefore, any transactions with VOYA qualify as party-in-interest transactions. Notes receivable from participants are also considered exempt party-in-interest transactions with participants.
