## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the financial statements of Lumsden & McCormick, LLP 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## Notes to Financial Statements December 31, 2024 and 2023

---

### 1. Description of the Plan

The following description of Lumsden & McCormick, LLP 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

*General* — The Plan is a defined contribution plan covering all employees of Lumsden & McCormick, LLP (and participating employers) (the “Firm” or “Employer”) who are age twenty-one or older. Eligible employees may participate in the Plan upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Fidelity Management Trust Company (“Fidelity”) and Fidelity Workplace Services LLC (“FWS”) serve as the Plan’s trustee for the assets held under its custody and recordkeeper, respectively.

*Contributions* — Each year, participants may contribute up to 100% of pretax or Roth (post-tax) annual compensation, as defined in the plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined plans (rollover contributions).

The Firm makes an annual Safe Harbor contribution on behalf of eligible participants in an amount equal to 3% of compensation. The Plan also provides for discretionary Profit Sharing contributions. A participant must complete 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year to be eligible to receive any Profit Sharing contribution. Profit Sharing contributions, if any, are allocated first at the Employer’s discretion among the four employee groups, as defined. The amount allocated to each employee group shall then be allocated among the eligible participants within each respective employee group in the ratio that each eligible participant’s compensation for the Plan year bears to the total compensation paid to all eligible participants within the respective group. Employer Safe Harbor contributions and Profit Sharing contributions amounted to \$1,143,487 for the year ended December 31, 2024, of which \$22,564 was funded via forfeited non-vested accounts. These contributions were allocated to eligible participants’ accounts on April 14, 2025.

All contributions are subject to certain Internal Revenue Code (“IRC”) limitations. Participants direct all contributions into various investment options available under the Plan.

*Participant Accounts* — Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s elective deferral contribution, the Firm’s contributions, if any, and Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* — Participants are 100% vested in their elective deferral contributions, rollover contributions, Safe Harbor contributions and any earnings thereon. Discretionary Profit Sharing contributions and earnings vest 100% after two years of service, as defined. Participants hired before to January 1, 2019 are fully vested in any Profit Sharing contributions.

*Payment of benefits* — Upon termination of service due to retirement, early retirement, death, or disability, a participant may elect to receive the value of the participant's vested interest in his or her account, in the form of a lump-sum, as defined by the Plan. Participant balances less than \$5,000 (\$7,000 effective January 1, 2024) are distributed in accordance with plan provisions. Subject to certain conditions, other payments may be permitted for in-service distributions including financial hardship, as defined by the IRC.

*Forfeited Accounts* — Any forfeitures occurring during the Plan year shall be applied to reduce Employer contributions or to pay administrative expenses.

## **2. Summary of Significant Accounting Policies**

*Basis of Accounting* — The financial statements of the Plan are prepared on the accrual basis of accounting.

*Investment Valuation and Income Recognition* — Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits* — Benefits are recorded when paid.

*Administrative Expenses* — Certain expenses of maintaining the Plan are paid directly by the Firm and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

*Use of Estimates* — The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Market Risk Factors* — The Plan invests in various investment securities. Investment securities are exposed to risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

*Subsequent Events* — Plan management has evaluated subsequent events through July 22, 2025, the date the financial statements were available to be issued.

### 3. Fair Value Measurements

The framework to measure fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds* — Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

All of the Plan's investments are deemed Level 1 within the fair value hierarchy as of December 31, 2024 and 2023.

### 4. Related-Party Transactions and Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions.

Certain employees and/or officers of the Firm or its affiliates perform administrative services to the Plan at no cost to the Plan.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

## 6. Tax Status

The Plan adopted a pre-approved document sponsored by FMR LLC, a related party to Fidelity and FWS. FMR LLC received an opinion letter from the Internal Revenue Service, dated June 30, 2020, which states that the pre-approved document satisfies the applicable provisions of the IRC. The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

As of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 7. Certified Investment Information

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Fidelity and furnished to the Company. The Company has obtained certifications from Fidelity as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that such information is complete and accurate.
