and its Participants:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Merritt Management Corporation 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### 1. DESCRIPTION OF THE PLAN

The following description of the Merritt Management Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### General

The Plan, which was established July 1, 1990, is a defined contribution plan covering substantially all employees of Merritt Management Corporation (the Company) except for union employees covered by a collective bargaining agreement, certain non-resident alien employees and interns. Employees may enter the Plan on the first day of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended effective October 1, 2021, to update in-service distribution provisions allowable by the Plan.

#### Participant Contributions

Participants may contribute up to 100% of their eligible annual compensation, as defined by the Plan, or a flat dollar amount, not to exceed the maximum allowable contribution under the Internal Revenue Code (the Code), which totaled \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants have the option to make after-tax Roth elective contributions from which tax-free withdrawals can be made upon retirement under certain circumstances. The participants' Roth elective contributions are allocated to a separate account maintained for such contributions. Roth elective contributions are treated as elective contributions for all purposes under the Plan. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for the years ended December 31, 2024 and 2023, respectively.

Participants are permitted to make rollover contributions from other qualified plans into the Plan. Effective November 1, 2018, the Plan was amended to allow in-plan Roth rollovers from an eligible rollover distribution from other qualified retirement plans into the Plan.

Effective January 1, 2020, the Plan was amended to allow for automatic enrollment of all employees at a 3% deferral rate, unless the employee makes an alternative election or is already contributing at least 3%. The amendment also allows an automatic increase in the deferral percentage by 1% annually on the first day of the Plan year, up to a maximum of 10% of compensation.

#### Company Contributions

The Company may, at its discretion, elect to match a portion of eligible participants' contributions on a per-payroll basis. For the years ended December 31, 2024 and 2023, the Company provided a discretionary matching contribution of 100% of participant contributions up to 3% of their eligible annual compensation, totaling \$532,667 and \$522,538, respectively. The Company's matching contributions are invested in the same manner as those directed by the participant.

#### Company Contributions – cont’d.

The Company may also make a discretionary profit-sharing contribution to the Plan. In order to be eligible for the discretionary profit-sharing contribution, participants must be actively employed on the last day of the Plan year and have completed at least 1,000 hours of service during the Plan year, as defined by the Plan agreement. Discretionary profit-sharing contributions are allocated to all eligible participants in proportion to their eligible compensation for the year. The Company did not make a discretionary profit-sharing contribution for the years ended December 31, 2024 and 2023.

#### Participant Accounts

Each participant’s account is participant-directed and credited with the participant's contributions, withdrawals, and allocations of: (a) Company contributions, (b) Plan earnings and losses and (c) administrative expenses. Allocations of earnings, losses, and administrative expenses are based on the proportion of each participant’s account balance to the total of all account balances within the respective investment. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant’s account.

#### Vesting

Participants are immediately vested in their contributions plus earnings thereon. Participants vest in Company matching and profit-sharing contributions plus earnings thereon based on years of service, as defined by the Plan agreement, according to the following schedule:

Less than 2	0%
2	50%
3	75%
4	100%

Upon termination of service due to death, disability, early retirement at age 60, or retirement at age 65, an employee becomes 100% vested in their matching and profit-sharing contributions.

#### Payment of Benefits

Upon termination of service, death, disability, normal retirement at age 65, early retirement at age 60, or attainment of age 59 ½, a participant (or their beneficiary, in the event of death) is entitled to a distribution of their vested account balance. Distributions from the Plan are payable in the form of a lump sum or installments over a period not to exceed their assumed life expectancy, at the election of the participant. Upon termination of service, participants with vested account balances of less than \$5,000 will receive a lump sum distribution. Effective September 1, 2018, the Plan was amended to allow automatic rollovers for participants with vested account balances of less than \$5,000.

#### Payment of Benefits – cont'd.

Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. In-service withdrawals may be requested by a participant upon attainment of age 59 ½, as subject to the Plan provisions. In-service withdrawals may consist of all contributions in the participant's account; including, elective deferrals, matching, and non-elective contributions. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. Distributions and withdrawals are subject to the applicable provisions of the Plan agreement.

Effective January 1, 2024, in accordance with the SECURE 2.0 Act (SECURE 2.0), the Plan elected to allow for certain additional distribution events as follows: (a) participants may request a distribution of up to \$1,000 annually to cover emergency personal expenses, subject to specific eligibility and repayment provisions, (b) the threshold for mandatory distributions increased from \$5,000 to \$7,000, (c) participants may take penalty-free early distributions in cases of domestic abuse wherein eligible participants may withdraw up to the lesser of \$10,000 or 50% of their vested account balance, provided the distribution occurs within one year of the domestic abuse incident, subject to specific provisions, and (d) the Plan permits distributions of up to \$22,000 for expenses incurred as a result of a federally declared disaster, in accordance with the permanent disaster relief rules established under SECURE 2.0. Such federally declared disaster distributions are not subject to the 10 percent additional tax and are taken into account as gross income over 3 years, subject to specific repayment options. A formal amendment incorporating all SECURE 2.0 provisions is expected to be adopted no later than December 31, 2026, in accordance with IRS guidelines. As of July 22, 2025, the Plan has not been formally amended for these provisions.

As of December 31, 2024 and 2023, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not received such distributions prior to year-end.

#### Forfeitures

Forfeitures of Company contributions may be applied to reduce future Company contributions or to pay Plan expenses. Forfeitures become available to the Plan as of the earlier of the last day of the Plan year in which a participant incurs five consecutive one-year breaks in service or a distribution of the participant's entire vested account balance occurs. Forfeitures available to the Plan totaled \$0 as of December 31, 2024 and 2023. During the years ended December 31, 2024 and 2023, forfeitures applied to reduce Company contributions totaled \$1,580 and \$4,528, respectively. No forfeitures were applied to pay Plan expenses during the years ended December 31, 2024 and 2023.

#### Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance, not to exceed \$50,000, without regard to the intended use of the funds. The minimum note amount is \$1,000 and a participant may have no more than two notes outstanding at any given time. Notes are collateralized by the participant's vested account balance. Note repayments are to be made at least quarterly with interest based on interest rates comparable to those offered by financial institutions at the time of note origination. Notes for reasons other than the purchase of a primary residence are to be repaid within five years. Notes receivable for the purchase of a primary residence must be repaid within thirty years.

#### Plan Expenses

All administrative expenses are paid with assets of the Plan, unless paid by the Company, at its discretion. During the years ended December 31, 2024 and 2023, the Company paid the majority of the direct expenses related to the Plan. Loan and distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation of fair value of investments.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets available for benefits and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur that materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are treated as distributions based on the terms of the Plan agreement.

#### Fair Value Measurement

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2     Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### Fair Value Measurement – cont'd.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Interests in registered investment companies:* Valued at the closing price reported in the active market in which the funds are traded.

*Interest in common/collective trust:* Value is based on the net asset value (practical expedient) as determined by the issuer.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

All investment information disclosed in the accompanying financial statements and supplemental schedule, including assets held as of December 31, 2024 and 2023, interest and dividend income and net appreciation in fair value of investments for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC, the Trustee of the Plan.

### 4. PARTY-IN-INTEREST TRANSACTIONS

The Plan allows participants to take out notes against their vested account balances. The Company provides certain accounting and administrative services to the Plan for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### 5. INCOME TAX STATUS

Effective October 1, 2021, the Plan adopted a non-standardized pre-approved profit sharing plan, which received an opinion letter from the Internal Revenue Service dated June 30, 2020. The opinion letter states that the Plan document is acceptable and may be relied on by an adopting employer with respect to the qualification of the Plan under Section 401(a) of the Code. Although the Plan has been amended since receiving the latest opinion letter, the Plan administrator believes that the Plan is designed, and currently being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan continues to be qualified, and the related trust tax-exempt.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits for any tax periods in progress.

### 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all contributions to the Plan would cease and all participants would become 100% vested in their accounts.
