Notes to Financial Statements

December 31, 2024 and 2023

Plan Description

The following description of Wahl Clipper Corporation 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, covering all full-time employees of Wahl Clipper Corporation (the Company). Employees who have reached age 18 and have completed 90 days of service are eligible to make elective deferrals and receive Company matching contributions. Participants are eligible for Company profit sharing contributions after completion of one year of service with 1,000 or more hours of service during the year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was restated and amended effective July 31, 2022, to comply with current laws.

Effective January 1, 2023, the Plan was amended and restated to switch trustees of Plan assets from Midland States Bank to Fidelity Management Trust Company.

Effective January 1, 2023, the Plan was amended to increase the automatic enrollment withholding percentage from 3% to 6% for newly eligible participants. Additionally, on November 1 of each year, the withholding rate will automatically increase by 1% to a maximum of 10%, unless the participant makes a separate election.

Contributions

Participants may contribute a percentage of their annual compensation, as defined by the Plan, not to exceed the maximum allowed by the Internal Revenue Service (IRS) as pre-tax or after-tax Roth contributions. Participants who attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Prior to January 1, 2023, automatically enrolled participants have their deferral rate set at 3% of eligible Plan compensation. Subsequent to January 1, 2023, automatically enrolled participants have their deferral rate set at 6% of eligible compensation, increasing by 1% on November 1 of each year.

The Plan has elected a safe harbor Company contribution, under which the Company contributes 100% of the first 3% of base compensation and 50% of the next 2% of base compensation that a participant contributes to the Plan. The Company may also make additional discretionary profit sharing contributions to the Plan, as determined by the Board of Directors, annually provided certain restrictions are met. During the year 2024, the Company's safe harbor matching and profit sharing contributions totaled \$3,637,750.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

December 31, 2024 and 2023

Plan Description (continued)

Vesting

Participants are immediately vested in their voluntary contributions, including rollover contributions, and Company safe harbor contributions plus actual earnings thereon. Vesting in the profit sharing accounts is based on years of continuous service. Participants vest at a rate of 20% per year after the second year of service. Participants become fully vested in profit sharing accounts after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a maximum equal to the lesser of \$50,000 or 25% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Interest rates on existing loans ranged from 3.25% to 9.50% at December 31, 2024, with maturity dates through 2028. Principal and interest are paid ratably through payroll deductions.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's contributions. These forfeitures may be reallocated to participants in the same manner as Company contributions in accordance with the Plan document. At December 31, 2024 and 2023, there were approximately \$122,500 and \$37,000, respectively, of unallocated forfeitures from nonvested accounts. During 2024, participants forfeited approximately \$95,000 of nonvested Company contributions. Approximately \$81,000 of forfeitures were used to reduce the Company contributions for 2024.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in annual installments if the account balance is greater than \$5,000. If the participant's vested account balance does not exceed \$5,000, it can be distributed only in a single lump-sum payment as soon as administratively possible. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½.

Investment Options

A participant may direct contributions in any of the investment funds offered by the Plan. Participants may change their investment options at any time.

Summary of Significant Accounting Principles

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America require the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Fair Value Measurements footnote for discussion of fair value measurements.

Net appreciation in fair value of investments is reflected in the statement of changes in net assets available for benefits and includes realized gains and losses on investments bought and sold and the change in appreciation from one period to the next.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the participant, as provided by the Plan agreement.

Fair Value Measurements

ASC 820, Fair Value Measurements and Disclosures establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Fair Value Measurements (continued)

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Interest-bearing deposits in banks: Valued at fair value based on the amount payable on demand at the reporting date.

Common collective trust fund: Composed primarily of benefit-responsive investment contracts valued at the net asset value (NAV) of shares held by the Plan in the collective trust account at year-end as determined by the third-party administrator based on the market value of its underlying investments. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no significant transfers between Level 1 and Level 2 investments during the years ended December 31, 2024 and 2023.

Investments in the common collective trust can be redeemed immediately at the participant level. The Plan is required to provide a 12 month notice to the fund in order to terminate their entire investment interest at the current net asset value per share based on the fair value of the underlying assets. If the Plan offers a "competing fund," participants are required to invest in a "noncompeting fund" for at least 90 days before transferring into the "competing fund" option. The fair value of investments in this category has been estimated using net asset value per share of the investments.

Notes to Financial Statements

December 31, 2024 and 2023

Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C), pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulation for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following information included in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) as complete and accurate:

- Investments and notes receivable from participants as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments and dividends and interest as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024;
- Investment information included in the Notes to Financial Statements;
- All investment information included in the Supplemental Schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) – As of December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information included in the financial statements and ERISA-required supplemental schedules.

Related Party Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan paid \$129,933 in administrative fees to the Custodian for the year ended December 31, 2024. The notes receivable from participants as of December 31, 2024 and 2023, in the amounts of \$1,874,483 and \$1,786,624, respectively, are party-in-interest transactions. Certain employees of the Company provide administrative services at no cost to the Plan.

Certain Plan investments are shares in accounts that are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Custodian as defined by the Plan and qualifies as a party-in-interest.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions and terminate the Plan. In the event of termination or partial termination of the Plan, all amounts credited to a participants' account, including Company contributions, become fully vested.

Notes to Financial Statements

December 31, 2024 and 2023

Tax Status

The Company adopted a prototype non-standardized profit sharing plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Operational Issues

The Plan experienced operational issues in 2023. The Company did not calculate the employee contributions and Company matching contribution on certain eligible wages during 2023. During 2023, the Company did not remit wages in a timely manner as defined by the Plan. The Company believes that the matters identified for remediation would not cause the Plan to be disqualified by the IRS; therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan used approximately \$1,000 of forfeitures to allocate to the affected participants to self-correct the operational issues.

Subsequent Events

The Plan evaluated subsequent events through July 2, 2025, the date the financial statements were issued.
