Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of The Prison Fellowship Ministries 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Prison Fellowship Ministries 403(b) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of The Prison Fellowship Ministries 403(b) Retirement Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Prison Fellowship Ministries 403(b) Retirement Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2008. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Independent Auditors' Report (continued)

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Prison Fellowship Ministries 403(b) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements



- 1. Description of the Plan** The following description of the The Prison Fellowship Ministries 403(b) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Prison Fellowship Ministries (the "Company"), except for employees who normally work less than 20 hours per week as defined in the Plan document. Eligible employees are required to make contributions to the Plan effective on the first day of the month coincident with or following the date of hire. Employees may enter the Plan immediately upon hire for voluntary contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Under the terms of the Plan, participants are required to make contributions equal to two percent of their pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan provides for automatic enrollment in which any newly eligible employees will be automatically enrolled with a minimum contribution of 2% pretax compensation unless an affirmative alternate election is made. This withholding will increase by one percent each subsequent year until the automatic election reaches a maximum withholding contribution of ten percent of compensation. In addition, the Plan allows for discretionary non-elective contributions and additional discretionary non-elective contributions to a select group of executives. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's discretionary non-elective contributions, if any, and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary non-elective contributions, if any, are based on the participant's compensation or a flat dollar amount at the discretion of the Company. Expenses are allocated based on account balances or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. For loans issued prior to August 1, 2018, principal, interest and administrative charges for participants are paid quarterly by submitting payment in the form of money orders, certified checks or bank checks directly to the Plan's recordkeeper, Transamerica Retirement Solutions, LLC. The administrative charge is equal to 3% per annum of the outstanding loan balance. Principal and interest are paid through payroll deductions.

Payment of benefits: Benefits are payable upon retirement at age 65, early retirement at age 59 1/2, disability, death or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Benefits are payable in lump sum and various annuity payments.

Vesting: Participants hired prior to August 1, 2018 are vested immediately in all contributions, plus actual earnings thereon. For participants hired August 1, 2018 and thereafter, the discretionary non-elective contributions become fully vested after one year of service.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Company.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$15,579 and \$14,498, respectively. These accounts will be used to reduce future Company contributions or to pay Plan expenses. During 2024, no forfeited nonvested accounts were used to reduce Company contributions and \$1,695 were used to pay Plan expenses.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes to Financial Statements

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Contributions: Participant contributions are recognized in the period the participant contribution is withheld from compensation. Company discretionary nonelective contributions are recognized in the period the related compensation is paid to the participant.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through July 14, 2025, which is the date the financial statements were available to be issued.

3. Certified information Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company, Transamerica Life Insurance Company and Transamerica Financial Life Insurance Company, the custodians of the Plan.

4. Fair value measurements The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- 5. Guaranteed investment contract** The Plan participates in a traditional fully benefit-responsive investment contract with Transamerica Financial Life Insurance Company ("Transamerica") under a group annuity contract. The account is credited with earnings under the terms of the contract and charged for withdrawals and administrative expenses. Transamerica is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. This account is utilized to hold unallocated amounts such as forfeitures or other advance employer contributions until utilized to reduce future employer contributions or pay Plan expenses.
- The Plan is invested in the Transamerica Guaranteed Investment Option ("TGIO"). The TGIO is a traditional fully benefit-responsive investment contract with Transamerica Life Insurance Company ("TLIC"). The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. TLIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Participants may elect, in writing, to withdraw all or a portion of their guaranteed investment option balance at contract value for any of the following reasons: (1) disability, (2) death, (3) retirement or severance from employment, (4) hardship, (5) compliance with a qualified domestic relations order, (6) attainment of at least age 59 1/2, (7) in-service withdrawals from the Plan, (8) loans, (9) transfer to a Non-Competing Fund subject to a 90 day equity wash, (10) unforeseen emergency or (11) the purchase of an annuity from TLIC. Approved withdrawals for reasons other than those listed will be subject to a market value adjustment. Withdrawals made due to employer initiated events, as defined in the contract, that exceed 15 percent of the Plan's balance during a 12 month period are also subject to a market value adjustment. There are no events probable of occurring that would limit the ability of the Plan to transact at contract value with participants.
- 6. Risks and uncertainties** The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.
- 7. Plan termination** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

- 8. Tax status** The Plan is a volume submitter plan of Transamerica Retirement Solutions, LLC which received an opinion letter on March 31, 2017, in which the Internal Revenue Service (“IRS”) stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code (“IRC”). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- 9. Party-in-interest transactions** Certain Plan investments are managed by affiliates of State Street Bank and Trust Company, Transamerica Life Insurance Company and Transamerica Financial Life Insurance Company. State Street Bank and Trust Company, Transamerica Life Insurance Company and Transamerica Financial Life Insurance Company are the custodians as defined by the Plan. Expenses paid to Transamerica Retirement Solutions, LLC, the Plan recordkeeper, totaled approximately \$37,000 for the year ended December 31, 2024. These transactions qualify as exempt party-in-interest transactions.

Participants are charged an asset based fee by Transamerica Retirement Solutions, LLC, a portion of which is deposited in an Expense Budget Account to be used for Plan expenses. During the year ended December 31, 2024, \$37,700 was deposited into the account and \$35,263 was paid to investment advisors from the account. At December 31, 2024 and 2023, the unallocated account balance was \$20,760 and \$17,636, respectively, and is invested in the Transamerica contract.

10. Records management In November 2007, the Department of Labor issued amended regulations eliminating an exemption granted to 403(b) plans from the annual Form 5500 reporting and disclosure requirements under Part 1 of Subtitle B of Title I of the Employee Retirement Income Security Act of 1974, as amended. Prior to the amended regulations, the Plan, established February 1, 1991, was not viewed as a separate reporting entity. Historically, the Plan was viewed as a collection of individual contracts through which participants could engage in a range of actions with limited involvement, if any, by the Plan sponsor. Accordingly, various accounting records related to the Plan's 403(b) annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2008 were not sufficiently maintained by the Plan. Consequently, the financial statements have been prepared based on available records analyzed by Plan management. As certain records were not available from the inception of the Plan, the effect, if any, on the completeness or accuracy of the Plan's financial statements related to individual participant account balances accumulated from inception of the Plan, or the propriety of the distributions to participants who terminated and withdrew from the Plan, cannot be determined.
