## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Harding Academy Tax Deferred Annuity Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Harding Academy Tax Deferred Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied

in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Note 1 - Description of plan:

The following description of the Harding Academy Tax Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan sponsor is Harding Academy (the Academy, Plan Sponsor, or Plan Administrator). The Plan is a 403(b) plan covering substantially all employees of the Academy. Employees are eligible to participate in the Plan immediately on their hire date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

#### Administration

The Academy serves as the Plan Administrator. The Plan Administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan, and making determinations regarding questions which may affect eligibility for benefits. The Plan Administrator has engaged the Teachers Insurance and Annuity Association - College Retirement Equities Fund (TIAA-CREF) and American United Life Insurance Company (OneAmerica) as the third-party administrators to assist in the administration of the Plan. TIAA-CREF and OneAmerica collectively hold all Plan assets.

OneAmerica receives all contributions made under the Plan. TIAA-CREF and OneAmerica hold Plan assets and pay benefits as directed by the Plan Administrator. OneAmerica serves as an intermediary for all asset purchases and redemptions and manages all Plan investment options, other than those held by TIAA-CREF.

#### Contributions

Participants are immediately eligible to make pre-tax salary reduction contributions to the Plan. The Plan has an automatic deferral arrangement whereas the participant's deferral percentage will be 4% unless the participant makes a contrary election. The Plan includes an auto-escalation provision whereby deferrals of all participants enrolled in the Plan will increase by 1% per year up to a maximum of 10% of eligible compensation, unless the participant has filed a contrary deferral election.

#### Contributions - continued

Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions up to Internal Revenue Service (IRS) limits. Participants who have completed at least 15 years of service with the Academy may also make qualified organization catch up deferrals which exceed the elective deferral limit. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participants are eligible for Academy matching contributions if they have completed one year of service, as defined in the Plan document, and have reached the age of 21. Academy matching contributions are equal to 150% of participant elective deferrals up to a 6% maximum. Participants exercise control over the assets in their individual accounts. The Plan is funded through one or more investment arrangements selected by the Plan Sponsor including fixed and variable annuity contracts issued by and funds held by TIAA-CREF and OneAmerica.

Contributions are subject to certain limitations under the Internal Revenue Code (the Code).

#### Participant accounts

Each participant's account is credited with the participant's contributions and Academy matching contributions, an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account/investment balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are fully vested at all times in their employee contributions and actual earnings thereon. Vesting in the Academy's contributions and earnings thereon is based on years of continuous service. Participants are 20% vested after two years of service and then 20% more after each additional year of service with 100% vesting after six years of service.

Participants are immediately vested upon termination of the Plan, upon reaching the normal retirement age of 65, or upon disability or death while an employee of the Academy. Forfeitures of terminated participants' non-vested accounts are used to reduce the Academy's contribution or pay Plan expenses for the plan year.

#### Note 1 - Description of plan - continued:

##### Forfeitures

At December 31, 2024 and 2023, there were no balances in forfeited non-vested accounts. During the year ended December 31, 2024, \$5,030 was used to reduce Academy contributions, and no forfeitures were used to pay Plan expenses. During the year ended December 31, 2023, \$7,349 was used to reduce Academy contributions, and no forfeitures were used to pay Plan expenses.

##### Payment of benefits

There are various methods by which vested benefits are distributed to participants in the Plan. The methods depend on marital status, elections made by the participant and the spouse (if applicable), and the size of the vested benefit. A participant is entitled to receive a lump-sum distribution, installments, or rollover the distribution into another eligible retirement plan or individual retirement account upon attainment of age 59½, termination of service, retirement, disability, or death. A participant may also request a withdrawal from the Plan while still under the employment of the Academy for reasons of financial hardship, but the withdrawal is limited to the amount of the participant's pre-tax contributions.

##### Notes receivable from participants

The Plan does not allow participant loans.

##### Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Academy and are excluded from these financial statements. The Academy reserves the right to elect to pay, or have the Plan pay, administrative costs in the future. Participants who invest in certain funds may be charged for certain expenses which are intrinsic to the value of the trust assets such as brokerage commissions. These fees are paid by the participant directly from their account.

#### Note 2 - Summary of significant accounting policies:

##### Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that could be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, TIAA-CREF and OneAmerica.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date.

#### Fixed annuity contracts with TIAA

Investment contracts held by a defined contribution plan are required to be reported at fair value. The Plan invests in guaranteed fixed annuity contracts with TIAA that are non-benefit responsive contracts and are reported at fair value. Fair value for the fixed annuity contracts equals the accumulated cash contributions and interest credited to each Plan's contracts, less any withdrawals.

The TIAA Traditional Non-Benefit Responsive Contract (the Contract) is a guaranteed fixed annuity contract available as an investment option to Plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The Contract is offered through a variety of contract types, including Retirement Annuities (RA), Group Retirement Annuities (GRA), Supplemental Retirement Annuities (SRA), Group Supplemental Retirement Annuities (GSRA), Retirement Choice (RC) annuities, and Retirement Choice Plus (RCP) annuities. The type of contract through which a participant invests in the Contract determines the applicability of certain account features, such as guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement.

#### Payment of benefits

Benefits are recorded when paid.

#### Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

#### Recent accounting pronouncements

The AICPA Financial Reporting Executive Committee (FinREC) approved enhanceive accounting updates related to accounting for revenue sharing arrangements in accordance with Financial Accounting Standards Board (FASB) ASC No. 606, *Revenue from Contracts with Customers*. Revenue sharing amounts are not considered revenue under ASC No. 606 due to the fact that they are intended to reduce administrative costs for the plan and are not paid to the plan for delivering or producing goods, rendering services, or undertaking other activities for the investment manager. A plan should consider all relevant facts and circumstances, including the terms of the agreement to determine the appropriate presentation of revenue sharing amounts. The presentation should be applied on a consistent basis and the plan should consider whether the presentation of revenue sharing amounts is a significant accounting policy that should be disclosed in the notes to the financial statements. If significant, the notes to the financial statements should include a description of revenue sharing arrangements including how such arrangements are presented in the financial statements. The adoption did not have a material impact to the Plan's financial statements.

#### Recent legislative developments

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and is awaiting additional regulatory guidance from the IRS and Department of Labor. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan years ended December 31, 2024 and 2023.

##### Subsequent events

The Plan has evaluated subsequent events through July 21, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

#### Note 3 - Investments and information certified by the trustee:

TIAA-CREF and OneAmerica hold the Plan's investment assets and execute investment transactions. Management has determined that TIAA-CREF and OneAmerica are qualified institutions, and the information prepared and certified by TIAA-CREF and OneAmerica meets the requirements of ERISA Section 103(a)(3)(C). Certain investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held as of December 31, 2024 and 2023 and net appreciation in fair value of investments and dividend/interest income for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by TIAA-CREF and OneAmerica.

#### Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification No. 820 are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- The TIAA insurance company general account contract (TIAA Traditional Non-Benefit Responsive Contract) represents insurance company deposit liabilities. These contracts are reported at fair value. Fair value equals the accumulated cash contributions and interest credited to the contract less withdrawals and administrative expenses.
- Registered investment company funds are valued at the value of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges.
- The TIAA Real Estate Separate Account generally invests in real estate properties and real estate related investments. The value is principally derived from the market value of the underlying real estate holdings or other real estate related investments. Real estate holdings are valued using external appraisals. Real estate related securities are priced using independent pricing sources. Unit values are calculated each day. Accumulated units are available for transactions at the closing accumulation unit value on any date the NYSE is open for business.

- The AUL Stable Value Account generally invests in fixed-income investments. The value is principally derived from the quoted market prices of the underlying investments held in the pooled separate account at year-end.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5 - Related-party transactions:

The Plan invests in fixed annuities in the general account of TIAA, a New York domiciled non-profit legal reserve life insurance company, variable annuities in a separate account of TIAA, and investment portfolios in CREF, a registered open-end management investment company. The Plan also invests in mutual funds and an investment contract managed by an affiliate of OneAmerica. Transactions in such investments qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. Fees incurred by the Plan for investment management services are included in net appreciation.

#### Note 6 - Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 - Tax status:

The underlying volume submitter plan has received an opinion letter from the IRS dated March 31, 2017, stating that the form of the Plan is qualified under Section 403(b) of the Code, and therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS volume submitter opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
