Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Plastic Packaging Technologies, L.L.C. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Summary of Significant Accounting Policies January 2, 2024 and December 31, 2023

Basis of Accounting

The Plastic Packaging Technologies, L.L.C. 401(k) Plan (the Plan) presents its financial statements on the accrual basis of accounting.

Use of Estimates

In preparing financial statements in conformity with accounting principles generally accepted in the United States of America, Plan management is required to make estimates and assumptions that affect the reported amounts of net assets available for Plan benefits and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors. See Note 3 for a discussion of fair value measurements. All Plan assets were transferred to the PPC Plan before the close of business on January 2, 2024.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold during the two-day period ended January 2, 2024, as well as gains and losses on investments held during the period until they were transferred to the New Plan before the close of business on January 2, 2024.

Receivables and Allowances for Credit Losses

Receivables are stated at the amount management expects to collect from balances outstanding at year-end. The allowance estimate, if any, is derived from a review of the Plan's historical losses in relation to the Plan's historical receivable balances as well as management's assessment of current conditions, reasonable and supportable forecasts regarding future events, and any other factors deemed relevant by the Plan. Management has concluded that realized losses on balances outstanding at year-end will be immaterial. Accordingly, no allowance for credit losses has been recorded. There were no write-offs of receivables or recoveries of amounts previously written off during either the two-day period ended January 2, 2024.

Notes Receivable from Participants

Notes receivable from participants include the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant stops making note receivable repayments and the Plan administrator determines that the note is in default, the note receivable balance is reduced, and a benefit payment is recorded. All notes receivable from participants were transferred to the PPC Plan before the close of business on January 2, 2024.

Payment of Benefits

Benefits are recorded when paid.

Expenses

PPC Flexible, LLC (formerly known as Plastic Packaging Technologies, L.L.C.) was acquired by PPC Flexible Packaging, LLC on October 21, 2022. Certain expenses of maintaining the Plan are paid directly by PPC Flexible, LLC (the Company) and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and payment of benefits are charged directly to the participants' accounts when incurred and are included in administrative expenses. Investment-related expenses are included in net depreciation in the fair value of investments.

1. **Description of Plan**

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Merger

Effective January 2, 2024, the Plan was merged into the PPC Flexible Packaging, LLC 401(k) Profit Sharing Plan and all the Plan's assets were transferred into the PPC Plan.

General

The Plan is a defined contribution 401(k) plan covering employees of the Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). As Plan administrator, the Company is responsible for the day-to-day administration and operation of the Plan. The Plan's trustees are responsible for oversight of the Plan.

Each hourly employee is eligible to become a participant in the Plan on the first day of the calendar month coincident with or immediately following the latter of the date the employee completes 60 days of service or attains the age of 18. Each salaried employee is eligible to become a participant in the Plan on the first day of the calendar month coincident with or immediately following the date the employee attains the age of 18.

Contributions

Participants may make elective deferral contributions up to the maximum amount allowed under the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Rollover contributions are not subject to contribution limitations. The Company makes employer matching contributions of 50% of participant deferrals, not to exceed 6% of eligible compensation (maximum matching contribution of 3% of eligible compensation). The total of the annual employee and employer contributions on behalf of each participant cannot exceed certain Internal Revenue Service (IRS) limitations.

Participant Accounts

A participant may direct contributions to any of the available investment options offered by the Plan. Contribution allocation changes and fund transfers can be done daily; however, deferral contribution amounts can only be changed the first day of each calendar quarter. Each participant's directed account is credited/charged with an allocation of the directed investment's earnings/losses and credited with the participant's deferral contributions and rollover contributions, if applicable, as well as the Company's matching contributions.

1. Description of Plan (continued)

Vesting

Upon becoming a participant in the Plan, an individual is fully vested in the portions of his account attributable to participant deferral contributions and rollover contributions. Upon death, disability, attainment of normal retirement age (59½), or plan termination, a participant also becomes fully vested in his accounts attributable to employer matching contributions; otherwise, the participant becomes fully vested in employer matching contributions in accordance with the following schedule:

Notes Receivable from Participants

Participants may borrow from their account up to the lesser of \$50,000 or 50% of their vested account balance. New notes must be for a minimum of \$1,000. A participant may only have one outstanding note at a time. Note terms cannot exceed five years except notes for the purchase of a primary residence which may be for a longer term. For participants with less than five vesting years of service, availability of notes is restricted to the following purposes: (1) tuition for higher education; (2) purchase of primary residence; (3) medical needs; and (4) to prevent eviction or loss of residence. Participants with five or more vesting years of service are allowed to take a loan for any reason. The notes are secured by the vested balance in the participant's account. The interest rate charged on notes is determined by Plan management and ranged from 5.25% to 10.50% at December 31, 2023. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service, if a participant's vested benefit in the Plan exceeds \$5,000, the participant must consent to receive the distribution. If a participant's benefit is \$5,000 or less, the participant will receive a distribution in a lump-sum payment.

Forfeitures

Forfeited nonvested matching contributions may be used to pay Plan expenses or reduce amounts otherwise required to be contributed to the Plan. For the two-day period ended January 2, 2024 and the year ended December 31, 2023, \$0 and \$10,001 of forfeitures, respectively, were used to reduce employer contributions. At January 2, 2024 and December 31, 2023, forfeited nonvested amounts totaled \$0 and \$43,460, respectively. Forfeitures at December 31, 2023 were included in the assets transferred to the PPC Plan.

Administrative Costs

Certain administrative costs, including personnel services, are provided by the Company without a charge to the Plan.

2. Information Certified by the Plan's Custodian

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

3. Fair Value Measurements (continued)

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The money market fund is valued at the amortized cost of securities held in the fund.

The preceding valuation methods described may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the valuation methodologies used at January 2, 2024 and December 31, 2023.

At January 2, 2024, all investments had been transferred out of the Plan; thus, there were no investments to measure at fair value.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. For the two-day period ended January 2, 2024 and the year ended December 31, 2023, there were no transfers.

4. Risks and Uncertainties

The Plan allowed participants to invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuation, and credit risk. Due to the transfer of all Plan assets and investments to the PPC Plan as of January 2, 2024, these risks were also transferred to the PPC Plan.

5. Tax Status

The Plan adopted a nonstandardized pre-approved profit sharing plan with CODA, which received an opinion letter dated March 22, 2021 from the IRS indicating that the Plan, as then designed, was in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter; however, the Plan administrator believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and tax-exempt as of the financial statement date and no provision for income taxes has been recorded in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator analyzed the tax positions taken by the Plan, and concluded that as of January 2, 2024 and December 31, 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

6. Party-in-Interest Transactions

Certain Plan investments are shares of a money market fund managed by Nationwide. Nationwide is the custodian as defined by the Plan and, therefore, transactions in this investment qualify as party-in-interest transactions. Administrative expenses paid by the Plan are also party-in-interest transactions as they are paid to Nationwide, the Plan's third-party administrator, and the Plan's financial advisor. These party-in-interest investments and transactions are exempt from the prohibited transaction rules of ERISA. Notes receivable from participants are also considered party-in-interest transactions exempt from the prohibited transaction rules of ERISA.

7. Subsequent Events

The Plan has evaluated subsequent events through May 27, 2025, the date the financial statements were available to be issued.
