Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Universal Mental Health Services, Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). 

Notes to Financial Statements For the Years Ended December 31, 2024 and 2023

1. Plan Description

The following brief description of the Universal Mental Health Services, Inc. 401(K) Plan (the Plan) is provided for general information purposes only. Participants should refer to the published rules and regulations of the Plan for more complete information.

General - This Plan is a special type of retirement plan commonly referred to as a 401(K) plan. Under the Plan, you may elect to have a portion of your salary deposited directly into a 401(K) account on your behalf. This pre-tax contribution is called a "Salary Deferral." As a pre-tax contribution, you do not have to pay any income tax while your Salary Deferrals are held in the Plan, and any earnings on your Salary Deferrals are not taxed while they stay in the Plan. This Plan is a defined contribution plan, which is intended to qualify under Section 401(a) of the Internal Revenue Code. As a defined contribution plan, it is not covered under Title IV of ERISA and, therefore, benefits are not insured by the Pension Benefit Guaranty Corporation. Membership in the Plan is voluntary. Membership is offered to all employees of the Company. Members who are credited with at least 1,000 hours of service are eligible to participate in safe harbor matching contributions at the end of the first twelve consecutive months of employment.

Contributions - Each year, participants may contribute up to the maximum deferral limit as defined by the IRS. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, common stocks, and bonds, as investment options for participants. Beginning May 1, 2019, this Plan is designed to qualify as a "Safe Harbor 401(K) Plan." As a Safe Harbor 401(K) Plan, we will provide a special safe harbor matching contribution to the Plan for those participants who satisfy the eligibility requirements applicable to such safe harbor matching contributions. If you make Salary Deferrals to the Plan, you will be eligible to receive a safe harbor matching contribution equal to 100% of the amount you contribute to the Plan for each payroll period up to the first 1% of Plan Compensation plus 50% of the amount you contribute between 1% and 6% of Plan Compensation.

Participants Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their elective contributions plus actual earnings thereon. Vesting in the Company's matching contribution is immediate once you have completed two years of service.

Forfeited Accounts - If any of the benefits are forfeited, the plan may decide in their discretion how to use those forfeited amounts. For example, the plan may use such forfeitures to pay Plan expenses. If any forfeitures are not used to pay Plan expenses, such forfeitures may be allocated as additional Employer

contributions or may use the forfeitures to reduce other Employer Contributions under the Plan. The plan will determine each year the amount of any forfeitures for such year and will use those forfeitures in the Plan Year for which the forfeiture occurs or in the following Plan Year. As of December 31, 2024 and 2023, forfeitures were \$22 and \$1,044, respectively.

Participant Loans – The Plan does not permit Participants to take a loan from the Plan.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annuity payments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, installments or any annuity option available under the group annuity contract.

2. Summary of Significant Accounting Policies

Basis of Accounting - Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Statement of Net Assets Available for Benefits presents the fair value of the investment contracts as well as the adjustment of the fully benefit-responsive investment contracts from fair value to contract value, if any. The Statement of Changes in Net Assets Available for Benefits is prepared using contract value basis for the fully benefit-responsive investment contract, if any.

Basis of Presentation - The accompanying financial statements have been prepared on the accrual basis of accounting and present the net assets available for participants.

Notes Receivable From Participants- The Plan does not permit notes receivable from participants.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell as asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Operating Expenses - All expenses of maintaining the Plan are paid by the Company, and are therefore, excluded from these financial statements.

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

3. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables are set forth, by level within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023.

ASC 820, Fair Value Measurements, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The fair values of common stock, corporate bonds, and U.S. Government securities are based on the closing price reported on the active market where the individual securities are traded.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023 are reported in net appreciation (depreciation) in fair value of investments. Unrealized gains/(losses) from the guaranteed investment contract are not reported in the statement of changes in net assets available for benefits as the contract is recorded at contract value for presentation in the net assets available for benefits.

The Plan's policy is to recognize transfers between Level 1 and Level 2 at the end of the reporting period. For the year ended December 31, 2024 and 2023, there were no significant transfers between Level 1 and Level 2.

4. Information Prepared and Certified by Trustee (Unaudited)

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements, which was prepared by the Matrix Trust Company and furnished to the Plan administrator. The Plan administrator has obtained certifications from the Matrix Trust Company that such information was complete and accurate as of and for the year ended December 31, 2024 and 2023.

5. Tax Status

Federal Income Taxes - The Internal Revenue Service has not determined and informed the Company that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified and related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Commitments

Net assets available for benefits at December 31, 2024 and 2023, respectively, include \$120,050 and \$60,632, allocated to the accounts of persons who as of prior to that date had withdrawn from the Plan but had not yet received total distributions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

9. Related Party Transactions

The following transactions qualify as party-in-interest transactions. Fees paid by the Plan administrator, Universal Mental Health Services, Inc., for the investment management services and fees paid for set up of the retirement plan amounted to \$17,220 and \$16,278 during the year ended December 31, 2024 and 2023, respectively.

Audit fees paid by the Plan administrator were \$5,500 and \$5,350 during the years ended December 31, 2024 and 2023, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

10. Contingencies

Uncertain Tax Positions

FASB ASC 740-10, Accounting for Uncertainty in Income Taxes, clarifies the accounting for uncertainty in income tax positions. Based on an evaluation of uncertain tax positions, management is required to measure potential tax liabilities that could have a risk of greater than a 50% likelihood of being realized upon settlement. As of December 31, 2024, management has determined that the Plan has no such risk, and therefore, no liabilities have been recorded for uncertain tax positions.

The Plan is no longer subject to examination by federal authorities for years prior to 2022.

11. Subsequent Events

Management has evaluated subsequent events through July 16, 2025, the date on which the financial statements were available to be issued. During the period from the end of the year and through this date, no circumstances occurred that require recognition or disclosure in these financial statements.
