NOTE A. DESCRIPTION OF THE PLAN

The following description of the Varischetti 401(k) Retirement Plan (“Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a safe harbor 401(k) plan as described under Internal Revenue Code Section 401(k). The Plan covers all employees of Varischetti and Sons, Inc., Phoenix Sintered Metals, LLC, Superior Energy Resources, LLC, and Allegheny Electric Service, LLC (collectively, the “Company”) who have at least 1,000 hours of service in a twelve-month period. Effective February 1, 2024, the Plan was amended to include employees of Phoenix Sintered Metals Galetton, LLC. The Plan allows eligibility for deferrals for non-highly compensated employees following the completion of 60 days of employment. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The administrative committee oversees governance of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

The Plan is funded through employer contributions, pre-tax employee payroll deductions and after-tax Roth contributions. Each year participants can elect to defer a percentage of their pre-tax annual compensation to the Plan to a maximum dollar amount as determined annually by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an unallocated insurance investment contract as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. Contributions are automatically invested in a designated money market fund until changed by the participant. The amount a participant may defer in any tax year is limited by law.

Contributions (Continued)

The Company may make discretionary safe harbor contributions in an amount equal to 3% of compensation for persons who were active participants at any time during the plan year. Also, the Company may make an additional discretionary employer matching contribution for participants who worked at least 1,000 hours during the plan year. There was no additional employer matching contribution in 2024.

Participant Accounts

Each participant's account is credited with the participant's respective deferral, the Company's discretionary safe harbor contribution and plan earnings. Participant accounts are charged with an allocation of certain administrative expenses paid by the Plan. Participants are able to direct the investment of their contributions to the Plan based on investment choices made available to them. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately 100% vested in amounts attributable to employee deferrals, Company safe harbor contributions, and earnings. A participant is 100% vested in their discretionary employer contribution after three years of credited service.

Payment of Benefits

Upon termination of service, if a participant's vested benefit in the Plan does not exceed \$5,000, the participant's benefit will be distributed in a single lump sum payment. If the participant does not consent to a distribution, the vested benefit will be automatically rolled over to an IRA selected by the Plan Administrator. If the vested benefit in the Plan exceeds \$5,000, then the participant must consent to the distribution before it may be made. The participant may elect to receive a distribution in the form of a single lump sum payment or a series of installment payments.

Hardship Withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½.

Forfeitures

The non-vested portion of a terminated participant's account balance remains in the Plan and is called a forfeiture. At December 31, 2024 and 2023, there were no forfeited non-vested accounts. Forfeitures may either be used by the Plan at the discretion of the plan administrator for payment of plan expenses, or allocated to the participants.

NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The administrative committee, in conjunction with the custodian, determines the Plan's valuation policies. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Reclassification

Amounts in the prior period's financial statements are reclassified whenever necessary to conform to current period presentations.

Date of Management's Review

Management has evaluated subsequent events through the date of the report, which is when the financial statements were available to be issued.

NOTE C. CERTIFICATION OF FINANCIAL INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ameritas Life Insurance Corp., the custodian of the Plan.

NOTE D. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value, in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D. FAIR VALUE MEASUREMENTS (CONTINUED)

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There were no Level 1, Level 2 or Level 3 inputs available to the Plan.

The fair value of the pooled separate accounts is measured at the NAV of each account on the last day of the plan year. The NAV is based on the market value of the underlying assets.

In accordance with Subtopic 820-10, certain investments that are measured at fair value using the NAV per share practical expedient have not been categorized in the fair value hierarchy. See Note E for discussion of investments measured at NAV.

Gains and losses included in the change in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

NOTE E. INVESTMENTS MEASURED AT NAV

The following table summarizes investments for which fair value is measured using the NAV per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

**NOTE F. UNALLOCATED INVESTMENT CONTRACT WITH INSURANCE
COMPANY**

In 2006, the Plan entered into a fully benefit-responsive investment contract with Ameritas Life Insurance Corp. (Ameritas). Ameritas maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by Ameritas, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$1,058,350 and \$854,659, respectively. At December 31, 2024 and 2023, the weighted average interest crediting rate was 3.91% and 4.11%, respectively. Such interest rates are reviewed on a quarterly basis for resetting.

NOTE F. UNALLOCATED INVESTMENT CONTRACT WITH INSURANCE COMPANY (CONTINUED)

Certain events limit the Plan's ability to transact at contract value with Ameritas. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE G. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The plan sponsor, Varischetti and Sons, Inc., provides the Plan with accounting and administrative services for which no fees are charged. In addition, certain plan investments are shares of pooled separate accounts managed by Ameritas Life Insurance Corp. Ameritas is the custodian as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services amounted to \$1,850 for the year ended December 31, 2024.

Members of the management team are currently participants in the Plan, and one member serves as the plan administrator. Additionally, an officer serves as the trustee of the Plan.

Finally, the plan sponsors directly pay most administrative expenses for the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE H. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE I. TAX STATUS

The Internal Revenue Service has determined and informed the custodian by a letter dated June 30, 2020, that the Plan is qualified and the trust established under the Plan is tax exempt, under the appropriate sections of the Internal Revenue Code (IRC). The plan administrator and its qualified tax counsel do not anticipate that changes in the Plan after the date of the amendments covered by the Internal Revenue Service determination letter will affect the qualified and tax-exempt status of the Plan and the Trust, respectively.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE J. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
