Note (1) Description of the plan

The Flavor & Fragrance Specialties, Inc. 401(k) Plan (the “Plan”) was established and became effective on April 1, 1992. The amended and restated provisions to the Plan became effective on January 1, 2020. Flavor & Fragrance Specialties (the “Company” and “Employer”), has general responsibility for the administration of the Plan, including, but not limited to complying with reporting and disclosure requirements, establishing and maintaining Plan records, and adopting amendments to the Plan. The custodian has the responsibility under the Plan for the management and control of the assets of the Plan. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The following description provides only general information about the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

(a) General

The Plan is a defined contribution 401(k) plan covering substantially all qualifying employees of the Company. An employee is eligible to participate in the Plan upon completing six months of service for elective deferrals. For non-elective deferrals, an employee is eligible upon completing one year of service and must be 21 years of age. An eligible employee can enter the Plan on the participation day and on the first day of the month. The employee may modify the election at any time during the Plan year.

(b) Contributions

There are four types of contributions that can be made to the Plan. They are voluntary pre-tax salary reductions, voluntary Roth salary reductions, employer contributions, and rollover contributions. The Plan permits eligible employees to make voluntary salary reductions not to exceed an amount set by law. The maximum salary deduction allowed for the calendar year 2024 and 2023 was \$23,000 and \$22,500, respectively. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. The maximum catch up contribution for the calendar year 2024 and 2023 was \$7,500.

The Plan provides for a Safe Harbor Matching Contribution for each plan year. The Employer will make matching contributions equal to 100% of the

amount of the employee's elective deferrals that do not exceed 6% of the employee's compensation. The employer may make a discretionary additional matching contribution. The total amount of this discretionary additional matching contribution will not exceed 4% of the employee's compensation.

In addition, the Plan provides for a discretionary profit sharing contribution that can be made by the Company. For the year ended December 31, 2024 and 2023 the profit sharing contribution was \$0. To receive a profit sharing contribution the individual must be an eligible employee as defined by the Plan documents and must have completed 500 hours of service during the plan year or be employed on the last day of the Plan.

Eligible employees may transfer or rollover contributions of a benefit from another qualified retirement plan. These contributions are 100% vested and will be placed in a separate account known as the "participant's rollover account" and investments are participant directed.

(c) Participant's accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Payment of benefits

On termination of service due to retirement, death, disability or other reasons, a participant may elect to receive a single lump sum distribution of 100% of their account balance. Participants may also elect to receive the benefits in the form of an annuity. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account

as a lump-sum distribution. The Plan permits distributions in the event of a hardship, as defined in the Plan, which are taxable and subject to a tax penalty equal to 10% of the hardship amount if the participant is younger than 59 ½. Hardship withdrawals are limited to the participant's contributions.

(e) Participant loans

Participants may borrow from their fund accounts to a maximum amount of \$50,000 or 50 percent of their vested account balance. Principal and interest are paid by periodic level payments at least as frequent as quarterly over a reasonable period of time not to exceed five years.

The loan term for the purchase of a primary residence is not to exceed thirty years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Sponsor.

(f) Vesting

Participants are immediately vested in their voluntary contributions, safe harbor matching contributions, and rollover contributions plus actual earnings thereon. A participant's vested percentage in their account balance attributable to employer discretionary matching, which includes profit sharing contributions, is based on vesting years of service as set forth below:

Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

(g) Forfeitures

When a participant withdraws from the Plan and has a non-vested balance in their account this amount is forfeited. Forfeited accounts can be used to reduce future employer contributions or offset plan expenses. At December 31, 2024 and 2023 forfeited non-vested account totals were \$157.

Forfeiture balances cannot be carried over to subsequent years therefore the Plan Sponsor has to ensure that current year forfeiture amounts, if any, are used promptly in the succeeding year.

Note (2) Summary of accounting policies

(a) Basis of presentation

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

(b) Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investments

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is determined by the custodian, using market quotations and other available information. Securities are valued at the last reported sales prices on the last business day of the Plan's year. Net appreciation or depreciation of investments is reported in the statement of changes in net assets available for benefits and consists of the realized gains or losses and the unrealized appreciation or depreciation of these investments. Participant loans are valued at cost, which approximates fair value.

The Plan provides for participant-directed investment programs. The significant changes in net assets are detailed in the statement of changes in net assets available for benefits.

(d) Payment of benefits

Benefit payments are recorded when incurred.

(e) Operating expenses

Certain administrative expenses of the Plan are paid for by the Plan Sponsor. These fees include contract and third party administration fees.

(f) Subsequent events

Management has evaluated subsequent events through June 30, 2025, which is the date the financial statements were available to be issued.

(g) Risks and uncertainties

The Plan provides for participant directed investments in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

(h) Investments and fair value measurements

The Plan has adopted FASB ASU 2015-12, Plan Accounting: Defined Benefit Pension Plans, in which Part I eliminates the requirements to measure the fair value of fully benefit-responsive investment contracts but will continue to provide certain disclosures that help users understand the nature and risks of fully benefit-responsive contracts. In addition, Part II eliminates the requirements to disclose individual investments that represent 5 percent or more of net assets available for benefits and the net appreciation or depreciation in fair value of investments by general type. Part II also simplifies the level of disaggregation of investments that are measured using fair value. The Plan will continue to disaggregate investments that are measured using fair value by general type; however, the Plan is no longer required to also disaggregate investments by nature, characteristic, and risks.

Note (4) Fair value measurement

Financial Accounting Standards Board FASB ASC-820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement).

The three levels of the fair value hierarchy under FASB ASC-820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Inputs to the valuation methodology are unobservable and significant to the fair value measurement. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (NAV) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts.

Note (6) Tax status

The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2022.

Note (7) Party-in-interest transactions

Certain Plan investments are shares of mutual funds managed by John Hancock Life Insurance Company, the Plan's asset custodian. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Loans receivable from plan participants and the related interest income are also considered party-in-interest transactions. Fees paid by the Plan Sponsor for administrative services amounted to \$96,321 and \$88,268 for the years ended December 31, 2024 and 2023, respectively.

Traphagen & Traphagen CPAs, LLC provides audit services to the Plan; fees are absorbed by the Company.

Note (8) Reconciliation of financial statements to Schedule H of Form 5500

Net assets available for benefits per the financial statements agree to net assets available for benefits, per Form 5500.
