- The information in the financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Extend, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan established on January 1, 2021 to provide benefits to eligible employees of Extend, Inc. (the "Company"). The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

B. Administration and Expenses

The Company designated Empower Trust Company, LLC to serve as directed trustee and custodian of the Plan. Fund administrative expenses are charged directly by the funds and factored into each fund as a reduction in investment return. Participant withdrawal and administration fees are charged directly to participants. Other costs incurred for administering the Plan were paid by the Company in 2024.

C. Eligibility

Substantially all employees of the Company are eligible to enter the Plan on the first day of the month following their date of hire. There are no age requirements. The Plan specifically excludes leased employees, non-resident aliens, and employees covered under a collective bargaining agreement.

D. Participant Contributions

Participants may elect to contribute up to 100% of their pre-tax compensation to the Plan and/or elect to make Roth after-tax contributions. Each participant's pre-tax deferrals and Roth contributions are subject to applicable Code limits. Participants of age 50 or older may elect to make up to \$7,500 of additional catch-up contributions for 2024. Employees who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled in the Plan at a deferral rate of 5% of compensation.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's investment directions.

E. Employer Contributions

Employer contributions are not permitted under the Plan.

F. Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, and an allocation of the participant's share of investment earnings or losses and expenses. The accounts of participants who decline to make an affirmative investment election are invested in the IndexSelect Moderate Fund Class I that is appropriate for a participant's age and projected retirement date.

G. Vesting

Participants are immediately 100% vested in their accounts.

H. Payment of Benefits

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability, retirement or attainment of age 59½, a participant or beneficiary may maintain his or her account balance in the Plan or elect to receive benefits in a lump sum. Hardship withdrawals are permitted from participants' vested accounts under limited circumstances, as defined in the Plan and approved by the plan administrator. Benefits are recorded when paid.

I. Notes Receivable from Participants

Effective November 27, 2023, the Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participants vested account balance, bears interest at a rate equal to 1% above the prime rate and must be repaid to the Plan within a five-year period, unless a loan is used for the purchase of a principal residence in which case the term can be extended. Principal and interest are paid ratably through payroll deductions. Outstanding notes receivable at December 31, 2024, carry interest rates ranging between 8.75% and 9.50% with maturities through December 2029.

J. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. Accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on the trade-date basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes realized and unrealized gains and losses on investments bought and sold as well as held during the year.

D. Risks and Uncertainties

Plan investments are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of plan investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - INCOME TAX STATUS

The Company adopted a prototype plan that has received an opinion letter from the Internal Revenue Service stating that the form of the plan qualifies under applicable provisions of the Code. The Company believes the Plan is operated in accordance with and qualifies under the applicable requirements of the Code and related state statutes and that the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation of investments, dividends and interest for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Empower Trust Company LLC.

NOTE 5 - FAIR VALUE MEASUREMENTS

ASC 820 provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value as follows: Level 1 refers to securities valued using unadjusted quoted prices in active markets for identical assets; Level 2 refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3 refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified based on the lowest level of input that is significant to the fair value measurement.

^A In accordance with ASC 820, investments measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

Plan investments consist of mutual funds which are valued at closing market prices. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded. The investments measured at net asset value consists of collective investment trusts. Shares may be redeemed any time at net asset value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares.

NOTE 6 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through July 18, 2025, the date on which the financial statements were available to be issued. There are no material subsequent events that require recognition or additional disclosures in the Plan's financial statements.
