1. Description of Plan

The following description of the Children's Services of Roxbury 401(k) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for more complete information of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Children's Services of Roxbury, Inc. (the Organization). Employees must be at least age 21 and have completed three months of service to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The board of directors of the Organization coordinates and manages the administration of the Plan. The Plan's trustee/custodian for the periods presented was Reliance Trust Company. The Plan's record keeper for all periods presented was ADP Retirement Services, Inc. (ADP).

Participant Contributions

Each year, participants may contribute up to 80 percent of pretax annual compensation, as defined in the plan, up to limited allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the plan. The plan currently offers various mutual funds and common/collective trust funds as investment options for participants. Profit sharing amounts may be contributed at the option of the Organization's board of directors and are invested in a portfolio of investments as directed by the Organization. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Organization's contributions, and an allocation of Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Fund allocation and contribution rates are determined by the participant and may be changed or discontinued at any time. In addition, a participant may make transfers between fund accounts daily.

Employer Contribution

The Organization may decide to make a nonelective contribution to the Plan, although the Organization is not required to do so. The nonelective contribution will be allocated to all employees eligible to participate in the Plan. During 2024, no contributions were made by the Organization.

Forfeitures

Forfeitures of non-vested Organization contributions are used to reduce future Organization contributions. At December 31, 2024, there were no forfeited nonvested accounts.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of continuous service. Organization contributions and earnings thereon allocated to participant accounts vest and become nonforfeitable in accordance with the following schedule:

<i>Years of Service</i>	<i>Vesting Percentage</i>
Less than 2 years	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 years or more	100%

A participant also becomes fully vested in the Organization's contributions upon death, disability, or retirement at age 65 or later.

Notes Receivable from Participants

Participants may borrow from their respective accounts a minimum of \$500, up to a maximum equal to the lesser of \$50,000, or 50% of their vested adjusted account balance. Loan proceeds are obtained by liquidation of investment company shares attributable to the participant's account. Loans must be fully repaid through payroll deductions within five years unless the loan is used for the purchase of a primary residence. Loans used to purchase a primary residence may be repaid within a period of no more than 30 years. If employment is terminated, any remaining payments are due immediately unless the participant is a party in interest. A party in interest may continue to repay the loan after termination of employment. If the loan is not repaid, the outstanding loan balance will be included in the participant's gross income for Federal income tax purposes as if it were distributed to them. If a participant dies with an outstanding loan balance, their death will cause the loan to be in default, and the outstanding loan balance will be regarded as if it were distributed to them. The loans are secured by the balance in the participant's account and bear interest at the prime rate as published in The Wall Street Journal on the 14th of each month plus two percentage points. This interest rate is effective for any loan processed as of the 16th day of the month. The interest rate on loans currently outstanding range from 5.25% to 10.50%.

Payments of Benefits and Withdrawals

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may make either hardship or discretionary withdrawals from certain funds within the Plan, while still employed. Both types of withdrawals have specific limitations and conditions. Withdrawal elections may be made at any time, and a minimum withdrawal of \$500 is required. There is no limit on the number of hardship or discretionary withdrawals a participant may make during employment with the Organization.

Administrative Expenses

The Organization pays substantially all administrative expenses of the Plan. Administrative expenses, which relate to the servicing of participant loans and certain investment fees, are paid via a reduction of participant account balances.

Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their accounts.

2. *Significant Accounting Policies*

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for common collective trusts, which are measured at their respective net asset value (NAV)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. *Information Certified by Trustee/Custodian (Unaudited)*

At December 31, 2024 and 2023, the Plan's investments were held by Reliance Trust Company, the trustee/custodian. The following is a summary of the Plan's financial information that is included in the financial statements based on information certified by the trustee/custodian as complete and accurate in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

4. *Fair Value Measurements*

The Financial Accounting Standards Board Accounting Standards Codification "Fair Value Measurements and Disclosures" Topic (the Fair Value Topic) defines fair value as the price that would be received from the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Fair Value Topic requires disclosure of the extent to which fair value is used to measure financial and non-financial assets and liabilities, the inputs utilized in calculating valuation measurements, and the effect of the measurement of significant unobservable inputs on earnings, or changes in net assets, as of the measurement date. The Fair Value Topic establishes a three-level valuation hierarchy based upon the transparency of inputs utilized in the measurement and valuation of financial assets or liabilities as of the measurement date:

- Level 1 - unadjusted, quoted prices for identical assets or liabilities in active markets;
- Level 2 - quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, and inputs other than quoted market prices that are observable or that can be corroborated by observable market data by correlation;
- Level 3 - unobservable inputs based upon the reporting entity's internally developed assumptions that market participants would use in pricing the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies

The Plan has investments in registered investment companies (mutual funds). These investments are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

6. *Income Tax Status*

The Plan adopted a prototype plan offered by the Plan administrator on September 1, 2009. The Plan is relying on a letter dated March 31, 2008 from the Internal Revenue Service (IRS) to the Plan administrator stating that the Plan is designed in accordance with applicable sections of the IRC, and an employer that adopts the plan may rely on it with respect to the qualification of the plan under the IRC. As a result, the Plan has not requested a separate determination letter from the IRS. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Organization believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
