**INDEPENDENT AUDITOR'S REPORT**

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of JPL Video Productions, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of JPL Video Productions, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in NOTE 3 to the financial statements, is complete and accurate.

## **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024

1. DESCRIPTION OF PLAN

The following description of the JPL Video Productions, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

A. GENERAL

The Plan was established by JPL Video Productions, Inc. effective March 1, 1998. The Plan is a qualified defined contribution plan covering all eligible employees of JPL Video Productions, Inc. and d'Vinci Interactive, Inc. (Employers) not covered by a collective bargaining agreement who are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

B. CONTRIBUTIONS

Participants may contribute up to 100% of annual compensation, as defined in the Plan. These elective deferrals may not exceed the annual dollar limits established by the Internal Revenue Service. These salary reductions can be pretax 401(k) Plan deferrals or Roth 401(k) Plan deferrals. Participants may also contribute, with the employer's written consent, cash or property in a rollover contribution from another qualified plan.

Additional contributions are made at the discretion of the Employers. Participants must complete thirty days of service to be eligible for employer contributions. Contributions are in the form of matching contributions and profit sharing. Matching contributions are equal to a percentage of each participant's deferral contributions. Profit sharing contributions are allocated based on participant compensation for the plan year. In order to be eligible for a profit sharing contribution, an employee must be actively employed on the last day of the plan year, unless employment was severed due to death, disability, or retirement and have completed a full year of service during the plan year.

Participants may direct all of the contributions to their accounts in any ratio desired into any of the available investment options. Participants may change their investment allocation at any time during the plan year.

C. PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution, employer matching contribution, an allocation of the profit sharing contribution, and an allocation of the Plan's earnings (losses). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. VESTING

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service, upon death, disability, or reaching full retirement age.

E. PAYMENT OF BENEFITS

The Plan provides for in-service distributions of vested accounts to employees who have reached age sixty (60). Additionally, Roth 401(k) deferrals and earnings thereon can be distributed after the expiration of the five year participation period. The Plan also provides for hardship withdrawals that may be requested for medical expenses, the purchase of a home, educational expenses, payments to prevent participant's eviction from a principal residence or foreclosure, payments for certain burial or funeral expenses, or repairs to a principal residence that would qualify for the casualty deduction under the Internal Revenue Code. The distribution can be taken from eligible funds in the participant's account balance.

Upon termination of service, a participant is entitled to receive the vested portion of his/her account. If the value of a participant's nonforfeitable account balance is \$7,000 or less, the Plan Administrator has the ability to force a distribution of the account balance out of the Plan. The participant may elect to receive the distribution in cash or roll it over into an individual retirement account (IRA) or the qualified plan of a new employer. However, if the participant does not return election forms in a timely manner, the balance will be automatically rolled over into an IRA in the name of the participant or distributed in cash. If the value of the participant's nonforfeitable account exceeds \$7,000, the account balance will only be distributed upon receipt of consent from the participant. The distribution can be by way of cash or rollover into an IRA or the qualified plan of a new employer. Absent consent of the participant, the account will be held by the Plan until which time the participant reaches the age where required distributions must occur.

F. FORFEITED ACCOUNTS

Forfeited nonvested accounts may be used to satisfy employer contributions or pay administrative expenses. As of December 31, 2024 and 2023, the Plan held forfeitures of \$1,218 and \$191, respectively. For the years ended December 31, 2024 and 2023, \$37,722 and \$22,945 of forfeitures were utilized to offset employer contributions and expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. BASIS OF ACCOUNTING

The financial statements of the Plan are prepared using the accrual method of accounting.

B. ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to see an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (NOTE 4). Management determines the Plan's valuation policies utilizing information provided by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. PAYMENT OF BENEFITS

Benefits are recorded when paid.

E. SUBSEQUENT EVENTS

Management has evaluated subsequent events through June 16, 2025, the date which the financial statements were available to be issued.

3. CERTIFIED INVESTMENTS

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustee of the plan, has certified the following information, which has not been subject to audit by independent auditors, to be complete and accurate:

- Investment balances included in the statements of net assets available for benefits as of December 31, 2024 and 2023, and in the notes to the financial statements.
- Investment income balances included in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and in the notes to the financial statements.
- Information included in the accompanying schedule of assets held for investment purposes at end of year.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurement* are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

5. GROUP ANNUITY CONTRACT

The Plan has a fully benefit-responsive group annuity contract with an insurance company called the Key Guaranteed Portfolio Fund. This investment is measured at contract value which is the net assets available for benefits based upon the group annuity contract, \$15,300 and \$281,227 as of December 31, 2024 and 2023, respectively. Contract value consists of participant contributions, plus earnings, less participant withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include: (1) premature termination of the contracts by the Plan, (2) Plan termination, (3) bankruptcy. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value.

The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The average yield earned by the Plan for the group annuity contract is derived by averaging the quarterly gross interest rates for the fund over the year. The crediting interest rate is reset quarterly. The average for the years ended December 31, 2024 and 2023 was 1.41% and 1.23%, respectively.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan has a number of service providers. Such providers are parties-in-interest under ERISA. The plan was involved in several permitted related party and party-in-interest transactions during the years ended December 31, 2024 and 2023. Empower Trust Company was the custodian of Plan investments and therefore is considered a party-in-interest. The Company paid \$4,227 and \$5,399 of administrative expenses for the years ended December 31, 2024 and 2023, respectively.

8. TAX STATUS

The Plan document was written using a volume submitter plan developed by its third-party administrator. The Internal Revenue Service has determined and informed the third-party administrator by advisory letter dated June 30, 2020, that their volume submitter plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax exempt. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
