Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cross Manufacturing, Inc. Employees' 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The following description of Cross Manufacturing, Inc. Employees' 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

The Plan is a defined contribution plan sponsored by Cross Manufacturing, Inc. (the Sponsor) for the benefit of its employees. Participants are required to attain age 18, have six months of credited service and must complete 500 hours of service within their first six consecutive months of employment or one year of service. To be eligible for matching and nonelective contributions, the participant must be employed on the last day of the plan year. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

In 2022, Newport Group was acquired by Ascensus. For the year ended December 31, 2023 and from January 1, 2024 through November 13, 2024, Newport Trust Company, an Ascensus company, was the Trustee of the Plan. Effective November 14, 2024 and through December 31, 2024, Ascensus, LLC became the Trustee of the Plan. During the recordkeeping system migration from Newport Trust Company to Ascensus, LLC, there was a brief blackout period from November 11, 2025 through November 22, 2025. During this time participants were unable to direct or diversify investments, obtain a loan or distribution.

Contributions

The Plan permits eligible employees to have the Sponsor contribute, through salary deferrals, a percentage of their eligible annual compensation, not to exceed the maximum limits established by the Internal Revenue Code. The Plan allows for certain rollover contributions.

The Plan utilizes an automatic deferral feature for all new hire eligible participants whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant makes an affirmative election otherwise.

Additionally, the Sponsor may contribute to the Plan an amount of matching contributions determined by the Sponsor at its discretion. The Sponsor may choose not to make matching contributions for a particular plan year. The Sponsor elected to match 100% of each salary deferral contribution up to 1% of the eligible participant's gross earnings for the years ended December 31, 2024 and 2023. The Plan also permits the Sponsor to contribute a discretionary amount for a plan year, which the Sponsor may designate as qualified nonelective contributions. There were no such qualified nonelective contributions for the years ended December 31, 2024 and 2023. The participant must be employed on the last day of the Plan year to receive matching and qualified nonelective contributions. These employment conditions are waived if the participant is terminated due to death, disability, or termination of employment after normal retirement age.

Participant Investment Account Options

Upon enrollment in the Plan, each participant has the option of directing contributions into any of the various investment options offered by the Plan and may change the allocation to the extent permitted by the individual agreements.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Sponsor's contribution, Plan earnings and forfeitures of terminated participants' nonvested accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Sponsor's matching and nonelective contributions plus earnings thereon is based on years of continuous service. A participant will vest evenly over five years and is fully vested after five years of continuous service or normal retirement age as defined in the Plan Document. The nonvested balance is forfeited upon termination of service. Forfeitures are used to reduce Sponsor contributions.

Payment of Benefits

Upon termination of continuous employment, participants are entitled to their vested interests of their account balances. Terminated employees are considered fully vested in the case of normal retirement at age 65, death or disability.

Benefits are payable in lump sum amounts to participants.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,405 and \$2,610, respectively. These accounts will be used to reduce future employer contributions. No forfeitures were used to reduce employer contributions during the years ended December 31, 2024 and 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

Administrative Expenses

Administrative expenses may be paid by the employer or the Plan, at the Sponsor's discretion.

Note 3. Certification by Plan Trustees

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Newport Trust Company, a qualified institution, has certified the following information from January 1, 2024 through November 13, 2024 and Ascensus, LLC, an agent for Ascensus Trust Company and Newport Trust Company, qualified institutions, has certified the following information from November 13, 2024 through December 31, 2024, included in the accompanying financial statements and ERISA-required supplemental schedule are complete and accurate.

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee associations or relatives of such persons.

The Plan incurs quarterly expenses related to general administration and recordkeeping, which are paid by the Sponsor. The Sponsor paid \$33,507 and \$36,893 of recordkeeping and trustee fees during the years ended December 31, 2024 and 2023, respectively. The Sponsor also pays for auditing fees related to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities

- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan has no Level 2 or Level 3 securities.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan operates under an adoption agreement in connection with a volume submitter 401(k) profit sharing plan document sponsored by The Newport Group, Inc. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through July 11, 2025, which is the date the financial statements were available to be issued.
