The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following brief description of the Oliver Technologies, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**A. General**

The Plan was adopted effective February 1, 1999, by Oliver Technologies, Inc. and affiliates (collectively, the Company) is the sponsor of the Plan. The Plan is a defined contribution plan covering full time (defined as 1,000 hours in the plan year) employees of the Company who have completed one year of service and are at least age 21. The following employees are excluded from the Plan: employees covered by a collective bargaining agreement, non-resident aliens, and employees of J & E Trucking Services, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**B. Contributions**

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan up to the maximum salary deferral dollar limit set by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company contributes a safe harbor matching contribution whereby the Company contributes 100 percent of the first 3 percent of the participant's elective deferral and 50 percent of the deferral percentage over 3 percent but does not exceed five percent of the participant's compensation. The Company may make a discretionary employer profit sharing contribution as a percent of eligible compensation. During 2024 and 2023, the Company profit sharing contribution was 2 percent and 3 percent of eligible compensation, respectively.

The Company may also make a non-elective discretionary contribution (profit-sharing contribution) to the Plan. Participants must have performed one year of service (defined as 1,000 hours of service during the Plan year) and be employed on the last day of the plan year, except in the event of death, disability or retirement during the year, to be eligible for any company profit sharing contribution. No non-elective discretionary contribution was made for the years ended December 31, 2024 and 2023. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

**C. Participants' Accounts**

Each participant account is credited with the participant's contribution and allocation of (a) the Company's contributions and (b) plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**D. Vesting**

Participants are immediately vested in their contributions plus actual earnings on them. Vesting in the Company contributions portion of their accounts plus earnings is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

**E. Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$22,883 and \$26,187, respectively. These accounts will be used to reduce plan Company matching contributions. The

amounts of forfeitures used to offset contributions in 2024 and 2023 were \$3,304 and \$34,676, respectively.

**F. Payments of Benefits**

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. A participant may elect to receive a lump-sum or partial amount equal to the vested portion of the participant's account. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA. Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, their vested balance may be automatically rolled into an IRA unless otherwise elected. Participants may also withdrawal an amount at age 59½ if certain criteria are met.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements are prepared on the accrual basis of accounting.

**B. Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**C. Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee and Plan Administrators determine the Plan's valuation policies utilizing information provided by its investment advisors and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are reported on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**D. Contributions**

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/Profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

**E. Payment of Benefits**

Benefits are recorded when paid.

**F. Plan Expenses**

Certain Plan expenses including third party administration fees and the audit fee are paid by the employer. All investment fees are deducted from Plan assets.

**G. Revenue Credits**

The Plan's agreement with Transamerica provides for a revenue credit arrangement whereby Transamerica allocates quarterly deposits into an interest-bearing checking account which is used

to pay administrative expenses. Revenue credits are presented in other income in the statements of changes in net assets available for benefits. During the plan years ended December 31, 2024 and 2023, the Plan received credits of \$93,977 and \$85,954, respectively. The administrative expenses paid via the revenue credit arrangement was \$214,307 and \$44,762 for the years ended December 31, 2024 and 2023, respectively

**H. Subsequent Events**

Management has reviewed subsequent events through July 17, 2025, the date the financial statements were available to be issued.

**NOTE 3 – CERTIFIED INVESTMENT INFORMATION**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, and interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trusts (CCTs):* Common/collective trusts are valued at the net asset value (NAV) of units held. The NAV, as provided by the trustee of the CCTs, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CCT less its liabilities. This practical expedient is not used when it is determined to be probable that the CCTs will sell for an amount different than the reported NAV. The CCTs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments. These are direct filing entities.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Transamerica Retirement Solutions, LLC. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transactions rules.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, the interests of all participants would become 100 percent vested in their employer contributions.

**NOTE 7 – TAX STATUS**

The Company has adopted the Transamerica Retirement Solutions, LLC non-standardized pre-approved profit sharing plan. That Plan received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document as then designed satisfies the applicable provisions

of IRC. Although the Plan has been amended since receiving this opinion letter, Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.
