Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Farmers Mutual 401(k) Savings Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plans, financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Farmers Mutual 401(k) Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

(1) Plan Description

The following description of the Farmers Mutual 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

(a) Organization

The Plan is a defined contribution savings plan sponsored by Farmers Mutual Insurance Company of Nebraska (the Company or Plan Sponsor or Employer). Employees who are at least 21 years of age are eligible to join the Plan the first day of the month following their date of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Employee Benefits Committee of the Board of Directors is responsible for oversight of the Plan. The Employee Benefits Committee has retained an ERISA Section 3(21) investment advisor to assist in identifying, recommending, monitoring, and (as necessary) replacing Investment Options. Principal is the Custodian of the Plan.

(b) Contributions

Each participant may elect to make basic contributions of not less than 1% and up to 100% of their pretax annual compensation subject to the annual limits of the Internal Revenue Code. Participants may also roll over amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company makes matching contributions equal to 100% of each participant's contribution up to a maximum of 3% of each participant's pretax annual compensation and 50% of each participant's contribution over 3% and up to a maximum of 5% of each participant's pretax annual compensation. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions and the Company's matching contributions into various investment options offered by the Plan. Total contributions are subject to limitations set by the Internal Revenue Service (IRS).

(c) Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

(d) Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions and plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(e) Vesting

Participating employees become 100% vested in employee and employer contributions plus actual earnings thereon immediately.

(f) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans are charged interest and are secured by the balance in the participant's account. Loans can have a maximum term of five years. Interest rates are 3.75% to 9.00%. Principal and interest are paid ratably through normal biweekly payroll deductions.

(g) Payment of Benefits

On termination of employment due to death, disability, or retirement at the normal retirement date (age 65), a participant may elect to receive an amount equal to the value of the participant's vested interest in the participant's account as a lump-sum amount, periodic installments over a fixed period of time, or the option of various life annuities. For termination of employment due to other reasons, a participant may receive the value of the vested interest in the participant's account as a lump-sum distribution or leave the balance in the account to share in investment gains and losses. Withdrawals prior to termination of employment or retirement are prohibited unless elected by the participant under the following conditions: establishing permanent and total disability or demonstrating financial hardship.

(h) Plan Expenses

Certain administrative expenses, including record-keeping and advisor expenses, are paid from the Plan. The recordkeeping and advisor expenses are netted against participant accounts. The Plan will also pay transaction fees (e.g., loan fees, withdrawal fees, and qualified domestic relations order (QDRO) fees). Such Plan transaction fees will be charged to applicable Plan participants' accounts as allowed by the Plan. The Plan will pay all other Plan-related expenses, provided such payments do not violate the terms of the Plan or ERISA. The Company will pay Plan expenses, including legal and audit fees and other expenses that relate to the formation, design, or termination of the Plan. The Company will also pay for the distribution of required Plan notices.

(2) Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan.

(a) Basis of Accounting

The financial statements of the Plan are prepared in accordance with U.S. generally accepted accounting principles and under the accrual method of accounting.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) *Investment Valuation and Income Recognition*

Investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 5 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) *Contributions*

Contributions from plan participants and the matching contributions from the employer are added in the year in which the employee contributions are withheld from compensation.

(e) *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as Plan expenses and are expensed as incurred. Any delinquent participant loans would be reclassified as distributions based upon the terms of the Plan Document.

(f) *Payment of Benefits*

Benefits are recorded when paid.

(g) *Subsequent Events*

The Plan has performed an evaluation of subsequent events through July 17, 2025, the date the financial statements were available to be issued and determined there are no other items to be disclosed.

(h) *Risks and Uncertainties*

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and changes in economic conditions, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(3) *Certification of Plan Custodian*

The Plan Sponsor has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and Principal Trust Company, both qualified institutions, have certified, that all of the information provided by the custodians are complete and accurate. Information included in the accompanying financial statements as to investments, interest, dividends, net appreciation/depreciation in fair value of investments, and all information in the supplemental schedule is presented in reliance solely upon these certifications.

The Plan's independent auditor did not perform auditing procedures with respect to this certified information, except for comparing such information to the related information included in the financial statements and ERISA-required supplemental schedule.

(4) Investment Contract with Insurance Company

The Plan entered into Guaranteed Interest Accounts with Principal Life Insurance Company, which maintain the contributions in a general account. The Guaranteed Interest Accounts are credited with earnings on the underlying investments and are charged for plan withdrawals and administrative expenses charged by the custodians. The Guaranteed Interest Accounts are included in the financial statements at fair value because they are not fully benefit responsive. Fair value is the amount plan participants would receive currently if they were to withdraw or transfer funds with the Plan prior to their maturity for an event other than death, disability, termination, or retirement. The Guaranteed Interest Accounts promise to pay contract value for a benefit event (e.g., death, disability, termination, and retirement). However, there is a possible surrender charge when funds are withdrawn prior to their maturity. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

(5) Fair Value Information

FASB ASC Topic 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual funds: These securities have observable Level 1 quoted market prices that are available on an active market.

Guaranteed interest accounts: This account represents investment contracts with Principle Life Insurance Company. Fair value is the amount plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity for an event other than death, disability, termination, or retirement. This fair value represents contract value adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates.

Pooled separate accounts: Pooled separate accounts (other than Principal Core Plus Bond pooled separate account) invest primarily in domestic and international stocks, bonds, commercial paper, and mutual funds. The fair values of the Plan's interest in these pooled separate accounts are based on each account's daily NAV as determined by the custodian and are primarily based on the readily determinable quoted market prices for the underlying securities or similar instruments.

Collective Trust Funds: The investment in the Stable Value Fund is valued at its NAV at contract value. The Fund's interests in the Stable Value Fund may be redeemed as of any valuation date. The Trustee may elect withdrawals in cash, ratably in-kind, a combination of cash and ratably in-kind, or in any other manner the Trustee determines to be appropriate. The investment in Stable Value Fund is valued using NAV as a practical expedient and is excluded from the fair value hierarchy.

There were no redemption restrictions on these investments during 2024 and 2023.

The Principal Core Plus Bond pooled separate account invests primarily in fixed securities such as asset backed securities, residential and commercial mortgage-backed securities, and corporate bonds. The fair value of the underlying assets is estimated by using a pricing service which uses various models, quotes, benchmark yields, reported trades and other techniques to value the securities. This pooled separate account is redeemed at NAV on a daily basis which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(6) Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan is sponsored by the Company. Certain Plan investments include shares in a Guaranteed Interest Account and unit investments in pooled separate accounts of the custodians. Principal Life Insurance Company and Principal Trust Company are the custodians, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Investment expenses paid by the Plan to the custodians amounted to \$114,423 and \$103,106 for the years ended December 31, 2024 and 2023, respectively. All the above transactions are exempt from prohibited transaction provisions of ERISA and the Internal Revenue Code.

The Company provides certain administrative services at no cost to the Plan.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

(8) Tax Status

For the years ended December 31, 2024 and 2023, the Company has adopted a nonstandardized prototype 401(k) plan. The IRS has issued a favorable opinion letter, dated June 30, 2020, regarding the prototype plan. The Company is relying on this determination letter. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan was qualified and the related trust was tax exempt as of the financial statement date.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.
