Report on the Financial Statements

Opinion

We have audited the accompanying financial statements of National Food NW, LLC Group Health Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (modified cash basis) and of benefit obligations (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) and of changes in benefit obligations (modified cash basis) for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits (modified cash basis) and the benefit obligations (modified cash basis) of National Food NW, LLC Group Health Benefit Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits (modified cash basis) and the changes in benefit obligations (modified cash basis) for the years ended December 31, 2024 and 2023, in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statement in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

NOTE 1 DESCRIPTION OF PLAN

The following description of National Food NW, LLC (the Company) Group Health Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of the Plan's provisions.

General

The Plan was established in January of 2022 to provide self-funded medical and prescription benefits to eligible employees of the Company and their families. Full-time employees who work 30 or more hours per week, are eligible to participate in the Plan after 60 days of continuous service. An eligible employee's coverage is effective, subject to timely enrollment, upon the first of the month following completion of a waiting period of 60 days of continuous active employment in an eligible status. The Plan also provides health benefits to eligible dependents of each participant. As required by the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA), the Plan includes a continuation of coverage option to certain terminated, retired, and totally disabled participants and their covered dependents for a period not to exceed 18 months. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2023, the Company executed a Wrap Plan Document, which added dental and vision benefits that were previously considered separate plans from the National Food NW, LLC Group Health Benefit Plan. Plan assets (deficits) and Plan benefit obligations from both the National Food NW, LLC Group Dental Benefit Plan and the National Food NW, LLC Group Vision Benefit Plan transferred into this Plan on January 1, 2023.

Benefits

The Plan provides health benefits including medical, major medical, hospital, surgical, and prescription drug, dental and vision to full-time employees of the Company and to their covered dependents. Claims for these benefits are subject to various deductible and co-payment amounts. The Plan provides these benefits on a self-funded basis, subject to a stop loss limit.

Contributions

The Plan is a self-funded health and welfare plan. The Company makes weekly contributions to the Plan for claims, administrative fees, and insurance premiums. The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis. Company contribution funding at year end were not needed to fund claims therefore are shown as Employer deposit at December 31, 2024 and 2023. In addition to deductibles and copayments, active participants contribute monthly amounts, determined periodically by the Company's management, to extend coverage to themselves and to their eligible dependents. These contributions are deducted bi-weekly from the employees' wages.

Terminated, retired, and totally disabled participants electing continued coverage contribute monthly amounts as provided by the Plan.

Plan Administrator

A Plan administrator is engaged under a fee-based contract, which is based on the number of participants in the Plan. The contract may be cancelled with thirty days notice by either the Plan administrator or the Plan trustees.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. That basis differs from generally accepted accounting principles in that contributions, premiums, and expenses are recorded when received or paid rather than when earned or incurred.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the trustees to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein and disclosures in the financial statements. Actual results could differ from those estimates.

Concentration of Credit Risk

The Plan's cash balance is held at one financial institution. Accounts at this institution are insured by a government agency up to \$250,000. At times the balance in this account may exceed the insured limit.

Payment of Benefits

Claims paid by the Plan are recorded as claim payments, respectively, in the accompanying statements of changes in net assets available for benefits (modified cash basis). Benefits are recorded when paid. No refunds of amounts accrued from the third-party administrator for adjustments, denied claims, and other disallowable claims included in payments for health claims for the years ended December 31, 2024 and 2023.

Administrative Expenses

All administrative expenses are paid out of the Plan unless paid by the Company. During the years ended December 31, 2024 and 2023, the Plan paid for substantially all administrative expenses, which consisted of administrative fees paid to third-party administrators and provider access fees.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Income Taxes

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from Washington or federal income taxes. The Plan is required to pay federal and state taxes on unrelated business income as defined by Internal Revenue Code Section 512(e)(3)(E). Unrelated business income consists of the investment income earned on the excess of the net assets available for benefits over the required reserve balance allowable under the Internal Revenue Code. The Plan administrator believes the Plan does not have any net taxable income for the years ended December 31, 2024 and 2023.

Subsequent Events

The Plan has evaluated subsequent events through June 27, 2025, the date the financial statements were available to be issued.

NOTE 3 FUTURE BENEFIT OBLIGATIONS

The Plan administrator estimated that future benefit obligations for active participants' existing health conditions covered by the Plan amounted to \$145,289 and \$117,751 as of December 31, 2024 and 2023, respectively. This amount was estimated by the Plan's third-party administrator using claims trends and actual lag patterns of the Plan. These amounts are paid by the Plan only if claims are submitted and approved for payment. There have been no changes in the methodology used during the years ended December 31, 2024 and 2023.

NOTE 4 TAX STATUS

The Plan administrator believes that the Plan is operating in conformity with the Internal Revenue Code and ERISA. The Trust is a taxable trust, subject to federal income taxes. For the years ended December 31, 2024 and 2023, there was no federal income tax expense.

In accordance with the modified cash basis of accounting, Plan management is required to evaluate if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS).

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there is no uncertain tax position taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, they are currently no audits for any tax periods in progress.

NOTE 5 STOP LOSS COVERAGE

During the years ended December 31, 2024 and 2023, the Plan maintained a stop loss insurance policy with Sun Life Financial. Benefit payments are paid directly from the Trust for any covered individual per year. The Plan contains excess loss insurance covering participants' claims in excess of \$145,000 per participant per Plan year are reimbursed to the Plan. There is no limit per Plan year or total lifetime coverage that is provided to participants. There were \$43,523 and \$0 stop loss recoveries during the years ended December 31, 2024 and 2023.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 7 RISKS AND UNCERTAINTIES

The liability for claims payable and claims incurred but not reported (IBNR) was estimated using Plan provisions, the number of eligible participants, and the actual lag patterns of the Plan. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
