## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees  
Bakers Union and FELRA  
Health and Welfare Fund

### Opinion

We have audited the accompanying financial statements of the Bakers Union and FELRA Health and Welfare Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and of benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and of benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

#### NOTE 1. DESCRIPTION OF THE PLAN

The Bakers Union and FELRA Health and Welfare Fund (the Plan) is a multi-employer collectively bargained health benefit plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The following description of the Plan provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan's provisions.

**General** - The Plan covers employees in jobs covered by collective bargaining agreements between participating employers and the BCTGM Local 68 and 118. The Plan also covers eligible dependents of active employees. There is no retiree coverage under this plan. Under the provisions of the Consolidated Omnibus Budget Reconciliation Act (COBRA), unemployed participants can continue their eligibility for a certain period after they cease employment by paying their own contributions.

**Benefits** - The Plan covers employees working in jobs covered by the collective bargaining agreements, for which contributions are required to the Plan. The Plan provides benefits such as medical, hospitalization, surgical, mental health/substance abuse, life and accidental death and dismemberment insurance, accident and sickness, prescription drug, dental and optical benefits. The Plan provides these benefits through either insurance or indemnity arrangements with the following companies:

CIGNA  
Delta Dental  
Group Vision  
Life Insurance and Accidental Death and Dismemberment (Boston Mutual)  
Optum Rx

**Insured Benefits** - The Plan fully insures the life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits, dental and optical benefits.

**Self-Insured Benefits** - All other fund benefits are self-insured. The claims from self-insured benefits (other than short-term disability) are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims are paid directly by the Plan.



## NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

**Stop Loss** - Premiums for stop loss insurance are included in the benefits paid to participants in the accompanying statements of changes in net assets available for benefits. The stop loss insurance held by the Plan pays on claims over \$350,000 per person per year. During the years ended December 31, 2024 and 2023, the Plan paid \$140,919 and \$138,070, respectively, in stop loss premiums. The plan received stop loss reimbursements of \$-0- and \$-0- in the years ended December 31, 2024 and 2023, respectively.

**Contributions** - Employer contributions by participating employers are determined subject to the provisions of collectively bargained agreements.

**Plan Modifications** - The Plan's Board of Trustees (Trustees), as Sponsor, has the right under the Plan to change, modify or eliminate any of the benefits offered by the Plan at any time, subject to the provisions set forth in ERISA.

## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Employer Contributions Receivable** - Accounts receivable are stated at the amount the management expects to collect from balances outstanding at year end. Based on a review of historical losses, current economic conditions and supportable and reasonable forecast assumptions, management has concluded that any expected credit losses on balances outstanding at year end will be immaterial.

Contributions due from contractors are accrued at year end and only as to those amounts applicable to contribution periods which ended on or before the financial statement dates and are based on subsequent period cash collections. The Fund considers receivables to be fully collectible; accordingly, no allowance for credit losses is deemed necessary.

**Investment Valuation and Income Recognition** - Investments are carried at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.



## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Purchases and sales of securities are reported on a trade-date basis. Interest income is reported on the accrual basis. Dividends are reported on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses** - Administrative expenses are paid by the Plan.

**Benefit Expenses** - Benefits are expensed when paid.

**Reclassifications** - When applicable, certain reclassifications may have been made to conform to current year financial statement presentation. These reclassifications had no effect on the net assets available for benefits.

## NOTE 3. CLAIMS PAYABLE AND CLAIMS INCURRED BUT NOT PAID

Amounts currently payable to or for participants, beneficiaries, and dependents represent actual and estimated amounts paid or payable after year end for all reported claims for benefits occurring during respective accounting periods, days lost due to disabilities that began during those periods, payments to benefit providers for benefits in those respective periods, and other miscellaneous benefits related to services performed in those respective periods.

## NOTE 4. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3).

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.



## NOTE 4. FAIR VALUE MEASUREMENTS (CONTINUED)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Short-term investments:* Valued at amortized cost, which approximates fair value.

*U.S. Government and agencies obligations:* Valued using pricing models maximizing the use of observable inputs for similar securities.

*Registered investment companies:* Valued at the daily closing price as reported by the company. Registered investment companies held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## NOTE 5. INCOME TAX STATUS

The Plan obtained its determination letter dated July 9, 2004, in which the Internal Revenue Service stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan is a qualified trust under Section 501(a) of the IRC and is exempt from federal income taxes under Section 501(c)(9).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan administrator is not aware of any uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements as of December 31, 2024 and 2023.

## NOTE 6. PLAN TERMINATION

It is the present intent of the Trustees to continue the Plan in full force and effect. However, in order to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

## NOTE 7. LITIGATION

Based on advice of the Plan's counsel there is no litigation either pending or threatened which would have a material adverse effect on the Plan's financial position.



## NOTE 8. CONCENTRATIONS OF CONTRIBUTION SOURCES

Only two active employers remain, comprising all of the Plan's employer contributions.

## NOTE 11. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

As disclosed in Note 2, the Plan pays certain administrative, investment and professional fees to various service providers. These transactions are party-in-interest transactions under ERISA.



## **NOTE 12. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through July 17, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
