- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Leupold & Stevens Employees' Pension Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Leupold & Stevens Employees' Pension Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Leupold & Stevens Employees' Pension Plan's internal control. Accordingly, no such opinion is expressed.

- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Leupold & Stevens Employees' Pension Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter - Plan Termination

As further discussed in Notes 1 and 9 to the financial statements, the Plan Management of Leupold & Stevens Employees' Pension Plan terminated the Plan, effective September 30, 2023, and changed its basis of accounting to liquidation basis as of that date. Additionally, the Plan's final distribution of plan assets occurred during 2024 and the Plan was terminated. Our opinion is not modified with respect to this matter.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4(j) – Schedule of Reportable Transactions for the year ended December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 – Description of Plan

The following brief description of the Leupold & Stevens Employees' Pension Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined benefit pension plan which covers eligible employees of Leupold & Stevens, Inc. (the Company), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's sponsor and serves as the plan administrator. As discussed in Note 9, Plan management approved termination of the Plan as of September 30, 2023. Final distributions of plan assets were completed during December 2024, and as of December 31, 2024, the Plan had no remaining net assets available for benefits.

Participant eligibility – The Plan was amended to close plan participation to any employees hired after February 1, 2016, which also excludes any employees rehired on or after February 1, 2016, even if they have had previous eligible time with the Company. Prior to this amendment, all regular employees working one year with 1,000 hours of service and who were 21 years of age and older were eligible to participate in the Plan. Regular employees included all employees except weekend security guards, employees covered under a collective bargaining agreement that did not provide for participation under the Plan, and anyone employed by an outside firm that provides temporary assistance.

Effective July 1, 2019, the Company froze the Normal Retirement Basic Benefits of each participant in the Plan. Each participant's accrued benefit shall be the amount of Normal Retirement Basic Benefit, determined as of June 30, 2019, and no additional amounts will be added to the participant's basic benefit after June 30, 2019. Participants who were not fully vested as of June 30, 2019, will become fully vested when they have met the Plan's service requirements. With this amendment, the Plan's service requirements were also amended as follows: for service years ending prior to January 1, 2019, service during the service year in which a participant is hired or rehired or employment ends by retirement or death shall be counted whether or not the participant has 1,000 hours of service in the service year. The foregoing also applies to the service year beginning on January 1, 2019, as long as the hire, rehire, or termination of employment due to retirement or death occurred on or before June 30, 2019.

Payment of benefits

Pension benefits and vesting – Employees with five or more years of service, who have accumulated Plan benefits greater than \$5,000 are entitled to monthly pension benefits beginning at normal retirement age of 65. The Plan permits early retirement at ages 55 to 64 if the employee has completed five or more years of eligible service. Employees who retire from the Company at age 62 or later are eligible for full retirement benefits. Employees who have separated from the Company prior to age 55 are not eligible to receive full benefits until they reach normal retirement age of 65. If employees separate before rendering five years of service, they forfeit the right to receive the portion of their accumulated plan benefits attributable to the Company's contributions. An employee who becomes eligible for normal retirement while employed by the Company is fully vested in their accumulated plan benefits, regardless of their years of service.

The monthly pension amount payable to employees is the greater of: (1) the basic benefit, if any, accrued at December 31, 2007 and 1/12 of 1% of compensation for each benefit year after December 31, 2007; (2) \$50; or (3) the greatest early retirement benefit the employee is entitled to receive. If an employee requests payment of his or her benefit before reaching the age of 62, the monthly benefit will be reduced since the benefits will be paid over a longer period of time. Employees with less than \$1,000 in accumulated Plan benefits will receive a lump-sum distribution upon retirement or termination of employment. Employees with accumulated Plan benefits from \$1,000 to \$5,000 may choose a lump-sum distribution or a monthly pension.

Early retirement benefits can be deferred until the normal retirement date but no later. Normal retirement benefits can be deferred subject to Plan limitations.

Effective July 3, 2023, the Plan was amended to expand the group of eligible individuals who may elect a lump sum form of payment under the Plan during the period from September 20, 2023 through October 24, 2023, during which participants who have not begun receiving payment of their Plan benefit may elect to receive an amount equal to the present value of the eligible participant's accrued benefit, as defined, based on a full actuarial reduction from the participants' normal retirement date in the form of the a single lump sum payment.

Death and disability benefits – If a fully vested participant dies at age 55 or older, and had been married for at least one year prior to death, the surviving spouse shall receive a lifetime monthly benefit equal to 50% of the benefit the employee would have received if he or she had retired and chose the 50% Contingency Annuity Option. If there is no surviving spouse but there are surviving dependent children, an actuarially equivalent benefit will be divided equally among all of the children entitled to receive a benefit. If the actuarially equivalent lump sum value is not over \$5,000, a lump sum shall be paid as soon as practicable.

If an employee terminates employment with the Company because of total disability, the employee will be entitled to continue to accrue benefit service and eligibility service until retirement age as long as they remain totally disabled. The rate of accrual of service is calculated as though the participant continued to work at the rate they were working before disability. Benefits under the Plan will begin at normal retirement age of 65, unless the participant applies for early retirement benefits.

Administration of Plan assets – The Plan's assets are held by the trustee, Bank of America, N.A., and Company contributions are held and managed by the trustee, which invests cash received, interest and dividend income, and makes distributions to participants. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 2 – Summary of Accounting Policies

Basis of accounting – The accompanying financial statements have been prepared in accordance with generally accepted accounting principles. As discussed in Note 9 to the financial statements, the Company terminated the Plan effective September 30, 2023. As a result, the Plan changed its basis of accounting subsequent to September 30, 2023, from the ongoing basis of accounting to the liquidation basis of accounting.

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

Use of estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation – The investments are stated at fair value. The Plan's trustee certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation or depreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

Payment of benefits – Benefit payments to participants are recorded upon distribution.

Expenses – The Plan's expenses are paid by the Plan or the Company, as specified in the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are deducted from investment earnings, as disclosed in the investment prospectus, and thus are not separately disclosed in the accompanying financial statements.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of net assets available for benefits but arose after the statements of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through July 21, 2025, which is the date the financial statements were available to be issued.

Note 3 – Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees' compensation during their last five years of credited service. The accumulated plan benefits for active employees are based on their average compensation during the five years ending on the date as of which the benefit information is presented (the valuation date). Benefits payable under all circumstances (retirement, death, disability, and termination of employment) are included, to the extent they are deemed attributable to employee service, rendered to the valuation date.

In lieu of obtaining an actuarial valuation as of January 1, 2024, the present value of accumulated plan benefits was estimated by management based in the total premium cost of annuity contracts purchased by the Plan, which were based on Milliman's actuarial assumptions and benefits expected to be paid directly to participants prior to Plan closure.

Note 4 – Funding Policy

Employee contributions – Contributions by participants are not required or permitted by the Plan.

Employer contributions – The Company's contributions for 2023 exceeded the minimum funding requirements of ERISA. Employer contributions receivable recorded as a result of the liquidation basis of accounting were \$3,872,990 as of December 31, 2023. No contributions were required in 2024.

Note 5 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) and exchange traded funds (ETF's) – Valued at the daily closing price as reported by the fund. Mutual funds and ETF's held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7 – Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated January 28, 2016, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Party-in-Interest Transactions

The Company is the Plan sponsor and administrator. Trustees who serve on the Plan's administrative committee are also participants of the Plan. The Plan pays PBGC Insurance, investment management fees, actuary fees, and other administrative expenses to several organizations that provide services to the Plan. During the year ended December 31, 2024, the Plan paid Bank of America, N.A., \$13,684 and Merrill Lynch \$22,676 for trust or investment services. During the year ended December 31, 2023, the Plan paid Bank of America, N.A., \$34,831 and Merrill Lynch \$122,369 for trust or investment services.

Note 9 – Plan Termination

On July 3, 2023, a Plan termination was initiated effective September 30, 2023. As a result, the net assets of the Plan were allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Benefits attributable to employer contributions, taking into account those paid out before termination.
- b. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
- c. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. government agency) up to the applicable limitations (discussed below).
- d. All other vested benefits (that is, vested benefits not insured by the PBGC).
- e. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC when the Plan terminated. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees. The Plan terminated with final distributions occurring during December 2024, and that ceiling was \$7,108 per month. That ceiling applied to those annuitants who elected to receive their benefits in the form of a single-life annuity and were at least 65 years old at the time of retirement or Plan termination (whichever comes later). For younger annuitants or for those who elected to receive their benefits in some form more valuable than a single-life annuity, the corresponding ceilings were actuarially adjusted downward.
