INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Speech Language 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Speech Language 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. General

The Plan is a defined contribution plan established September 1, 2001 for the benefit of all eligible employees of Speech and Language Pathology Associates, Inc. (the “Employer”) under the provisions of Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is administered by the Employer and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the Employer executed a good faith amendment to expand distribution options for participants and to also allow certain long-term part-time employees to participate in the Plan (see Notes A.2. and A.7., respectively). The good faith amendment also included various regulatory updates to the Plan. The amendment was formally adopted effective April 2, 2025.

2. Eligibility

An employee is eligible to participate in the Plan upon attainment of age 18 and completion of one year of service (with at least 1,000 hours), subject to quarterly entry dates. In addition, effective January 1, 2024, part-time employees with three consecutive years of service after December 31, 2020 during which at least 500 hours of service were worked in each computation period (plan years 2021 to 2023) are also eligible to participate in the Plan, subject to the Plan’s age and entry date requirements. Union employees, non-resident aliens, and leased employees are not eligible to participate in the Plan.

3. Contributions

Participants may elect to contribute pre-tax contributions up to the maximum deferral limit per Section 402(g)(1) of the IRC. Participants who attain age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows rollover contributions from other qualified plans, as defined in the plan document.

The Employer makes safe harbor matching contributions equal to 100% of deferrals up to 4% of compensation. In addition, the Employer may make qualified non-elective contributions, discretionary non-elective contributions, or additional discretionary matching contributions to the Plan. For the year ended December 31, 2024, safe harbor matching contributions and qualified non-elective contributions totaled \$234,807 and \$6,198, respectively (see Note G). During 2024, no discretionary non-elective or additional discretionary matching contributions were made to the Plan.

4. Investment Options

Upon enrollment in the Plan, a participant may direct employee and Employer contributions, as desired, in any of a variety of options held by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, custodians (collectively as “Empower”) of the Plan, as chosen by the Employer. Participants may change their investment options daily.

5. Participant Accounts

Each participant’s account is credited with the participant’s contributions, Employer safe harbor matching contributions, Employer discretionary matching contributions, and allocations of the discretionary non-elective or qualified non-elective contributions (if any) and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

6. Notes Receivable from Participants

The Plan permits participants to borrow from their account a minimum of \$1,000 up to 50% of their vested account balance not to exceed \$50,000, reduced by the participant’s highest outstanding loan balance during the prior twelve-month period. Loans shall bear an interest rate of one percentage point higher than the prime lending rate. Loans must be repaid within five years in accordance with terms established by the plan administrator. Loans for the purchase of a principal residence may be repaid over a longer period of time. Participants may have up to two loans outstanding at a time.

7. Benefit Payments

Upon termination of service, normal retirement, permanent disability, or death while employed, a participant or a participant’s beneficiary is entitled to the total value of the participant’s account balance. Distributions of such benefits are made in lump sum, partial, or installment form. In addition, in-service distributions, hardship distributions, and, effective January 1, 2024, distributions for expenses related to the birth or adoption of a child are permitted, if certain criteria are met.

8. Forfeitures

Forfeitures of terminated participants’ non-vested accounts may be used to pay allowable administrative expenses of the Plan and to reduce future Employer contributions. Unallocated forfeiture balances at December 31, 2024 and 2023 were not material.

9. Vesting

Participant contributions, rollovers, Employer contributions and actual earnings on all such contributions are fully vested at all times.

10. Plan Termination

While the Employer has not expressed any intent to terminate the Plan, the Employer reserves the right to terminate the Plan at any time subject to the provisions of ERISA. Upon termination, plan assets are distributed among the participants of the Plan in accordance with the provisions of the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

2. Plan Administration

The Employer is the plan sponsor and plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

3. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

4. Payment of Benefits

Benefits are recorded when paid.

5. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note D for discussion of fair value measurements.

5. Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes gains and losses on investments bought and sold as well as held during the year.

6. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

7. Administrative Expenses

Administrative expenses incurred by the custodians and other service providers in performance of their duties are paid from the assets of the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

8. Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

NOTE C - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower (the custodians of the Plan).

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the quoted net asset value (NAV) of shares held by the Plan at year end. These funds are required to publish their daily NAV and to transact at that price. The NAV for mutual funds is a publicly available quoted price in an active market.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds an investment that meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus credited interest, less participant withdrawals, and administrative expenses. The following represents the traditional investment contract held by the Plan:

The EI Account held by the Plan is backed by Empower’s general account. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The crediting interest rate may not be less than 0% and is reset quarterly. Although plan participants generally may withdraw assets from the EI Account without restrictions, the custodian may impose a hold period up to 36 months or a market value adjustment on payments due to certain plan-level events. As of December 31, 2024, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the custodian and that also would limit the ability of the Plan to transact at contract value with the participants.

The Employer is not allowed to offer competing funds unless mutually agreed upon by Empower and the Employer, in which case amounts withdrawn from the EI Account must be transferred to a noncompeting fund and remain there for at least 90 days before transferring to a competing fund.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Empower Annuity Insurance Company of America and Empower Trust Company, LLC are the custodians of the Plan’s assets, and Empower Retirement, LLC is the recordkeeper. As a result, transactions with these entities qualify as party-in-interest transactions. Notes receivable from participants and the related interest income are also considered party-in-interest transactions.

The Employer adopted a non-standardized pre-approved profit sharing plan with CODA (“non-standardized plan”) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the non-standardized plan, as then designed, was in compliance with applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and operated in compliance with applicable requirements of the IRC with the exception of the operational error noted below. Administration errors, if any, which are insignificant or operational in nature, are handled by the administrator in accordance with applicable IRS correction policies. During 2024, the Employer discovered that there was a failure to implement deferral election changes for seven participants going back to plan year 2021. To correct this operational error, plan management elected to make a QNEC contribution to affected participants’ accounts. The QNEC contribution relating to plan years 2021 to 2023 totaled \$45,686 and was included in the prior year financial statements. The QNEC contribution relating to plan year 2024 totaled \$6,198 and is reflected in the accompanying financial statements for the year ended December 31, 2024. The combined total for all years, \$51,884, was remitted to the Plan in May of 2024. Therefore, the plan administrator believes that the Plan is currently designed and operated in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur, in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE I - SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to allow Roth deferral contributions and to discontinue Safe Harbor Match contributions.

Plan management has evaluated subsequent events through July 15, 2025, the date the financial statements were available to be issued.
