Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's responsibilities for the audit of the financial statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with US GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter – supplemental schedules required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from

the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Haleon Puerto Rico 401(k) Plan (formerly the Consumer Healthcare Puerto Rico 401(k) Plan) (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions, including definitions of key terms.

General

The Plan was established on June 16, 2022, as part of a Corporate de-merger transaction whereby Haleon was formed. Assets from the GSK Puerto Rico 401(k) Plan were transferred into this Plan relating to participants of the Consumer Healthcare division. Participants whose balances transferred to this newly established Plan who were previously invested in the GSK Stock Fund received shares in the Haleon Stock Fund upon the de-merger. The portion of this Plan that consists of the Haleon Employer Stock Fund is intended to be an employer stock ownership plan under the definition of the Internal Revenue Code (“IRC”).

The Plan is a defined contribution plan covering all full-time and part-time employees of PF Consumer Healthcare B.V. (Puerto Rico Operations) LLC, a subsidiary of Haleon, (the “Company” and “Plan Sponsor”) who are bona fide residents of Puerto Rico effective on the date on which they first complete an hour of service.

The assets of the Plan are held in the Trust (the “Trust”) and Banco Popular de Puerto Rico (the “Trustee”), a Puerto Rico banking corporation, is the trustee. The Trustee, as instructed by Haleon, has appointed State Street Bank and Trust, as agent of the Trustee and custodian of the Plan assets. Under this agreement, State Street has agreed to provide custodial, investment trading services for the Plan. Alight Solutions serves as the Plan’s recordkeeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

On August 1, 2023, the Plan closed the GSK Stock Fund. This Fund, at Plan inception was frozen to contributions. Any Plan assets invested in the GSK Stock Fund on August 1, 2023 were sold and reinvested in a participant’s existing investment elections. Prior to August 1, 2023, participants could voluntarily transfer any existing balance out of the Fund and reinvest them in one or more of the other options available in the Plan.

Contributions

Each year, participants may elect to defer up to 50% of their total eligible compensation, as defined in the Plan, not to exceed the maximum allowable contribution as permitted by the Puerto Rico Treasury Department, which is \$15,000 for the calendar year ended December 31, 2024. If a participant is age 50 or older, he/she may make additional contributions of up to \$1,500 for the tax year ended 2024.

Participants may also elect after-tax 401(k) contributions from 1% to 10% of their eligible compensation. Participants may also contribute pre-tax amounts representing distributions from other qualified plans into the Plan.

The Company contributes 100% of participants’ contributions up to 4% of eligible compensation that a participant contributes to the Plan. In addition to the matching contribution, the Company will make a core contribution equal to 7% of a participant’s eligible compensation regardless of whether a participant contributes to the Plan. Matching contributions and core contributions are determined each payroll period and are recalculated based on the ratio of participant contributions to eligible compensation, and “true-up” contributions are made accordingly with respect to all participants who are eligible to receive a matching contribution during the Plan year.

Participants' Accounts

The Plan permits each participant to allocate his or her deferral in 1% increments to the various investment funds offered by the Plan. Each participant's account is credited with the participant's contributions, allocations of the Company's matching contribution, Company core contribution and Plan earnings, and charged with any expense relating to the participant's fund selection and/or transaction activity and Plan losses. These allocations are based on each participant's relative interest in the fair value of the assets held in each fund, except for dividends and unrealized appreciation and depreciation on the GSK American Depository Receipts, as held in the GlaxoSmithKline Stock Fund (the "GSK Stock Fund"), which were allocated based upon the number of units held in the individual accounts of participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and Company contributions (match and core) plus or minus actual earnings (losses) thereon.

Payment of Benefits

Upon termination of service, retirement, death or disability, the vested portion of a participant's account balance may be distributed to the participant or beneficiary by transfer to another qualified plan or individual retirement account, through a lump-sum distribution or in annual installment payments. Alternatively, participants may also take partial distributions up to 4 times each calendar year. If a participant's account balance is less than \$5,000 upon termination, a lump-sum distribution of the participant's account balance may be made automatically.

Distributions shall be made in cash provided that a participant whose distribution is in the form of a lump-sum, may elect to receive the portion of their account invested in the GSK (prior to August 2023) or Haleon Stock Funds either in cash or shares (ADSs) which will be electronically credited to an individual account established.

In-service withdrawals of a participant's after-tax contributions, rollovers or prior employer contributions may be made by participants. Upon attainment of age 59½, in-service withdrawals of a participant's after-tax contributions, rollovers, prior employer contributions and pre-tax deferrals may be made by participants. Hardship withdrawals from a participant's pre-tax deferral contribution account are permitted when certain criteria are met. Minimum required distributions for participants who have reached age 73 also apply. In certain circumstances, qualified disaster distributions up to \$100,000 may also be made upon declaration of a governmental disaster by the Puerto Rico Secretary of the Treasury. The Plan does not permit participant loans.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accounts of the Plan are maintained, and the financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's trustee. See also Note D for discussion of fair value measurements and investment valuation.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. The investment management fees and operating expenses charged to the Plan are deducted from investment income earned on a daily basis and are included in net appreciation in fair value of investments.

NOTE C - INVESTMENTS AND INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, State Street Bank, the custodian of the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are actively traded open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price.

Common Stock: Valued at the closing price reported on the active market on which the individual securities are traded.

Collective Trust Funds: Valued at the NAV of units of a bank collective trust. The NAV as provided by the trustee is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

NOTE E - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by subsidiaries of State Street Bank. State Street Bank is the Plan's custodian and, therefore, these transactions qualify as party-in-interest transactions.

As part of the corporate de-merger transaction participants of the former GSK Puerto Rico 401(k) Plan who were previously invested in the GSK fund received Haleon shares. The Haleon stock fund is closed to participation post transfer. As of December 31, 2024 and 2023, the Plan owned 45,719 shares and 46,969 of Haleon common stock, and the fair value of this common stock was \$436,159 and \$386,555, respectively. The Plan Sponsor did not pay dividends on its common stock during the years ended December 31, 2024 and 2023. All of these related party and party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE G - TAX STATUS

The Treasury of Commonwealth of Puerto Rico has determined by letter dated January 29, 2024 that the Plan is qualified under section 1165(a) of the Puerto Rico IRC of 1994, and therefore the Trust would be exempt from local income taxes. The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Puerto Rico IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax

positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subjected to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I - SUBSEQUENT EVENTS

The Plan has evaluated all subsequent events through July 16, 2025, which represents when the financial statements were available for issuance, to ensure that the Plan's financial statements include appropriate disclosure of events both recognized in the financial statements as of December 31, 2024, and events which occurred subsequent to December 31, 2024, but were not recognized in the financial statements.

Effective July 1, 2025, the Vanguard Target Retirement 2070 Fund was added to the Plan investment lineup.

On December 15, 2025, the Plan will close the HALEON Stock Fund. Any Plan assets remaining in the Fund will be sold and reinvested in existing participant investment elections. Prior to this date, participants can elect to transfer any existing balance out of the Fund and reinvest it in one or more of the other options available in the Plan.
