**Note 1 – Description of the Plan**

The following description of the Alaska Central Express, Inc. 401(k) Salary Reduction Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers all eligible employees of Alaska Central Express, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC). The Plan originated January 1, 2000 and was amended and restated effective January 1, 2021.

The custodian and trustee of the Plan is Empower Trust Company, LLC. The administrator of the Plan is the Company. The custodian holds all assets of the Plan in accordance with the service provider contract with the Company. The administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022(Secure 2.0 Act)

On December 29, 2022, the SECURE 2.0 Act was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Key provisions that may affect plan participants currently and/or in the future include increasing the age for Required Minimum Distributions and provisions relating to catch-up contributions. Applicable provisions outlined in the SECURE 2.0 Act will be adopted if elected and/or required. Plan amendments for these changes are not yet required. The deadline for adopting plan amendments has been extended, most recently to no later than December 31, 2026.

Eligibility

Employees are eligible to participate in the Plan after attaining 21 years of age without any service requirements. In order to share in the employer profit sharing contribution, employees must be either employed on the last day of the Plan year or must be credited with at least 1,000 hours of service during the Plan year and employed on the last day of the Plan year. Participants enter into the Plan the first day of the month coinciding with or next following the date when they became eligible for the Plan.

**Note 1 – Description of the Plan (Continued)**

Contributions

Each year, participants may contribute up to 90% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company contributes 100% of the first 4% of base compensation that a participant contributes to the Plan as a safe harbor contribution. Participants direct the investment of their contributions and company matching contributions into various investment options offered by the Plan. Additional non-elective contributions may be made at the option of the Company's board of directors. During the year ended December 31, 2024, the Company did not make any non-elective contributions to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and company matching contributions, as well as allocations of the Company's non-elective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed five years except for the purchase of a principal residence. The loans are secured by the participant's account balance and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid to the Plan through payroll deductions.

Vesting

Participants are vested immediately in their own contributions and company safe harbor contributions, plus actual earnings thereon. Vesting in the Company's non-elective contribution portion of their account is based on years of continuous service. A participant is 100% vested after three years of credited service.

Forfeited Accounts

Forfeitures occur when participants terminate employment before becoming 100% vested with respect to Company contributions. Forfeitures may be used to reduce employer contributions or pay for plan expenses. At December 31, 2024 and 2023, the total unallocated forfeitures were \$58 and \$69, respectively. \$11 of forfeitures were utilized by the Plan to reduce Company contributions for eligible participants in 2024.

Payments of Benefits

Vested benefits will normally be distributed to the participant or the participant's beneficiary upon death, disability, or retirement. Financial hardship withdrawals as well as early retirement withdrawals are permitted, as defined in the Plan agreement. On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested account in either a lump sum amount or in installments.

**Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the guaranteed interest account, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expense and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Management has evaluated subsequent events for disclosure in the financial statements through July 7, 2025, which is the date the financial statements were available to be issued.

**Note 3 – Information Certified by Empower Trust Company, LLC**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- (a) Investments, at fair value, and guaranteed interest account, at contract value, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- (b) Total investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024; and
- (c) All information included in the Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown in the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, *Fair Value Measurements* are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include –

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* Valued at their fair value which represents the Plan's proportionate share of the total fair value of the net assets of the underlying mutual funds. In determining the total fair value of the net assets of the investment funds, the issuer has valued investments at the quoted closing net asset value (NAV) per share, as reported in active public markets.

In accordance with the fair value measurement guidance, investments in pooled separate accounts that are measured at fair value using the NAV per share (or its equivalent) practical expedient are not required to be classified in the fair value hierarchy. All of the investments held by the Plan at December 31, 2024 and 2023, except for the Guaranteed Interest Account (see Note 5), are pooled separate accounts measured at fair value using the NAV practical expedient and, accordingly, are excluded from the fair value hierarchy.

**Note 5 – Guaranteed Interest Account**

Through the group annuity contract, the Plan offers a guaranteed interest account (GIA) as a stable value investment option. GIA guarantees are subject to the terms and conditions of the group annuity contract and the claims-paying ability of Empower Annuity Insurance Company of America (EAICA). There are no reserves against the contract value of this account for the credit risk of EAICA.

Participant accounts invested in the GIA are paid out at contract (or “book”) value for participant-initiated transactions such as transfers to other investment options, loans, and other distributions.

The GIA is credited with earnings at an interest rate which, by contract, cannot fall below 1%. The rate is subject to quarterly adjustments. The guaranteed interest rate was 2.80% and 1.65% as of December 31, 2024 and December 31, 2023, respectively.

As described in Note 2, because the guaranteed interest account is fully benefit-responsive, contract value is the relevant measurement for that portion of the net assets available for benefits attributable to this asset. Contract value represents participant contributions made under the contract, plus credited interest earnings, less participant withdrawals and administrative expenses. Contract value also includes the effects of market value adjustments required in the event of a full or partial plan or contract termination.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete termination or merger with another plan), (2) changes to the plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

The guaranteed interest account does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 6 –Tax Status**

The IRS has determined and informed the Plan’s volume submitter sponsor by an opinion letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase, CODA Plan sponsored by Nova 401(k) Associates, Inc., which has been adopted by the Plan, is acceptable pursuant to Section 401 of the IRC and in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 – Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are shares of investments managed by Empower Trust Company, LLC, the custodian and trustee of the Plan. Therefore, investment transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. Empower Retirement, LLC and Nova 401(k) Associates, Inc. provide certain administrative services to the Plan pursuant to service agreements between the Company and Empower Retirement, LLC and Nova 401(k) Associates, Inc. Notes receivable from participants also qualify as exempt party-in-interest transactions.

**Note 8 – Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination all account balances become fully vested and all remaining assets in the affected participants’ accounts shall be distributed to the participants and beneficiaries of the Plan in the order provided by ERISA.

**Note 9 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. The Plan’s exposure to a concentration of risk is dependent upon funds selected by participants. The following table shows details on investments that represent a concentration of greater than 10% of the Plan’s investments in either years:
