Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Associated Volume Buyers, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1 - Description of Plan

The following description of the Associated Volume Buyers, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan qualifying under Section 401(k) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was established on January 1, 1995, and covers eligible employees of Associated Volume Buyers, Inc. (the “Company”) who have completed 6 months of service and are aged 21 or older. Richard Kasperowicz and James Ristow are the trustees of the Plan.

The Plan was amended and restated effective March 1, 2022.

Contributions

Each year, participants may make Pre-Tax or Roth Elective deferrals to the Plan up to 100% of compensation, as defined by the Plan, subject to limitations as provided in the Internal Revenue Code (the “IRC”) (up to \$23,000 in 2024 and \$22,500 in 2023). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to limitations as provided in the IRC (up to \$7,500 in both 2024 and 2023). Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Roth in-plan rollovers are not permitted. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make safe harbor non-elective contributions, in an amount not less than 3% of compensation, to participants who have completed one year of service and are age 21 or older, but only if the Plan Sponsor amends the Plan and provides a supplemental notice. The Company may make discretionary matching contributions on Pre-Tax, Roth, and Catch-Up Elective deferrals in a discretionary amount and percentage of matched employee contributions to employees who have completed one year of service and are age 21 or older. The Company may make profit sharing contributions in a discretionary amount as determined by the Company using the New Comparability allocation formula to employees who have completed one year of service and are age 21 or older.

Participant Accounts

Each participant's account is increased or reduced by the participant's contributions and Company contributions, an allocation of Plan earnings and losses, net of reasonable investment related fees, and any distributions and withdrawals. Participant accounts are charged with an allocation of expenses that are paid by the Plan. Allocations may be made using any reasonable method that does not violate Title I of ERISA and does not discriminate in favor of highly compensated employees in accordance with the provisions of Code section 401(a)(4). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions is based upon years of credited service. Participants vest 100% immediately in safe harbor non-elective contributions, discretionary matching contributions, and profit sharing contributions.

Payment of Benefits

Upon separation of service as defined by the Plan, a participant may elect to receive a distribution of their vested account balance. Benefits will be paid as a lump sum distribution. If a participant's vested benefit is \$5,000 or less, a distribution from the Plan will be made regardless of whether the participant requests a distribution. Minimum distributions will be made no later than April 1 following the later of the calendar year in which the participant attains age 70 ½ or retires. Withdrawals may also be made at attainment of age 59 ½ and upon disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50 percent of their vested account balance or \$50,000 (reduced by the Participant's highest outstanding loan balance during the prior 12 months). Loans generally are to be repaid within five years; however, if the loan is used to acquire a principal residence, the loan term may extend beyond five years. The loans are secured by no more than ½ of the vested portion of the participant's account (determined immediately after the origination of the loan) and bear interest at a rate determined by the plan administrator based on interest rates currently being charged on similar commercial loans.

Forfeitures

A participant's non-vested balance is forfeited at the time of termination of employment. Such forfeitures can be used to restore forfeitures, pay plan expenses or reduce Company contributions. As of December 31, 2024 and 2023, remaining forfeited non-vested accounts totaled \$75 and \$74, respectively.

SECURE Act and CARES Act

On August 3, 2022, the IRS released Notice 2022-33, which extends the deadline for adopting any SECURE Act plan amendments until December 31, 2025, to provide relief for plan sponsors waiting for final IRS guidance on many of the SECURE Act's provisions. The Notice also extends the deadline for the 2020 waiver in the CARES Act of required minimum distributions until December 31, 2025. These amendments can be retroactively adopted; therefore, the Plan can implement the amendments prior to amending the plan instrument. Similarly, plans may have voluntarily adopted provisions under the CARES Act by placing them in operation without amending the plan as long as the plan management makes the required amendments to plan documents by December 31, 2025.

SECURE 2.0 Act of 2022: The SECURE 2.0 Act of 2022 ("SECURE 2.0 Act") was signed into law on December 29, 2022, to increase retirement savings, improve retirement rules, and lower employer costs of setting up a retirement plan. Plan amendments required by the SECURE 2.0 Act generally need not be made until the end of the first plan year beginning on or after January 1, 2025; however, plans must be operated in accordance with the effective date of each new provision. There is no current impact to the Plan and these provisions did not have an impact on the financial statements. Since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment adviser and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 - Fair Value Measurements (continued)

The categorization of an investment within the fair value hierarchy is based upon the pricing transparency of the investment and does not necessarily correspond to Plan management's perceived risk of that investment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. While Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Related-Party and Party-in-Interest Transactions

Certain Plan investments are managed by Empower Annuity Insurance Company of America. Management believes that fees paid during the year for administrative, recordkeeping, and managerial services provided by Empower Trust Company, LLC, the custodian as defined by the Plan, Empower Annuity Insurance Company of America, the recordkeeper as defined by the Plan, and Premier Plan Consultants, Inc. the third-party administrator as defined by the Plan, were based on customary and reasonable rates for such services. Therefore, these transactions qualify as exempt party-in-interest transactions. Notes receivable from participants are also considered exempt party-in-interest transactions.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7 – Tax Status of the Plan

The Plan uses a Prototype Non-standardized Profit Sharing Plan With CODA plan document sponsored by CCH INCORPORATED DBA FTWILLIAM COM, which obtained an opinion letter on June 30, 2020 in which the IRS stated that the Prototype Non-standardized Profit Sharing Plan With CODA plan document adopted by the Plan, as then designed, qualifies under Internal Revenue Code (“IRC”) Section 401. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include risks related to pandemics and international conflicts. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 – Subsequent Events

The Plan has evaluated subsequent events through July 10, 2025, the date which the financial statements were available to be issued.
