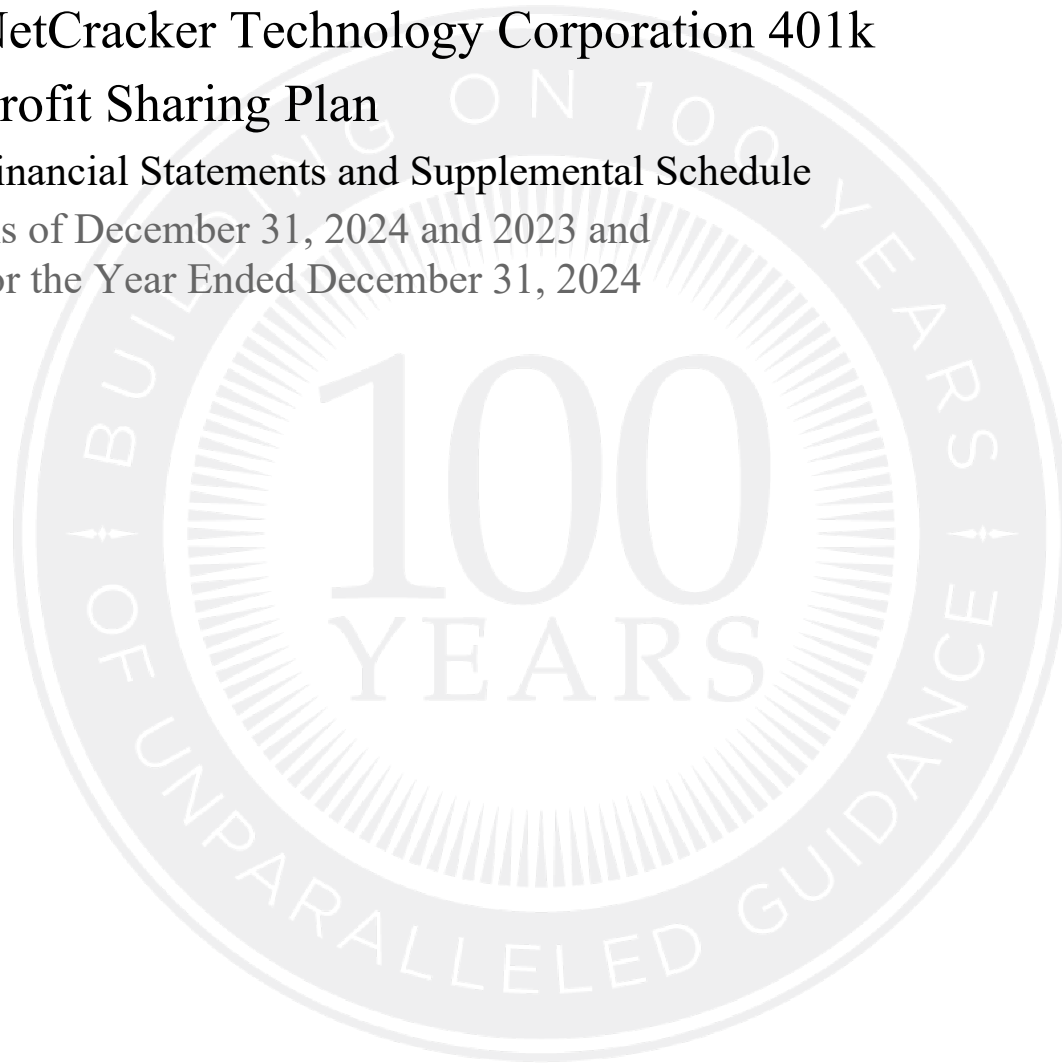

Independent Auditor's Report

Notes to Financial Statements

As of December 31, 2024 and 2023 and for the Year Ended December 31, 2024

1. DESCRIPTION OF PLAN

The following description of the NetCracker Technology Corporation 401k Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Summary Plan Description and the Plan Document for a more complete description of the Plan’s provisions. These documents can be found on the participant website.

General

The Plan is a defined contribution plan. The purpose of the Plan is to provide a savings and investment vehicle for all eligible United States employees of NetCracker Technology Corporation and adopting subsidiaries (the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility

All employees are eligible to participate in the Plan upon employment, with the exception of (i) non-US citizens transferred from an affiliate company participating in said Company’s sponsored plan, (ii) employees whose retirement benefits are covered by collective bargaining agreements, and (iii) leased employees.

Contributions

Under the provisions of Section 401(k) of the Internal Revenue Code (“IRC”), participants in the Plan may elect to contribute up to 90 percent of their base pre-tax compensation, as defined by the Plan. Participants may elect to contribute catch-up contributions on a pre-tax or after-tax basis if they will attain age 50 by the end of the calendar year. The Plan allows participant Roth 401(k) contributions. Effective September 1, 2023, the Plan was amended to include an automatic enrollment provision whereby all eligible employees who become participants in the Plan after September 1, 2023, are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation. Participants may also make rollover contributions from other qualified plans if the contributions satisfy the tax law requirements for a qualified rollover. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan does not allow for Company contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of Plan earnings. Participant accounts are charged with administrative expenses for those participants with outstanding notes receivable from participants' balances and those requesting a benefit payment. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. A participant may elect to change the amount of their authorized payroll deduction at any time. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100 percent vested in their account balance.

Notes Receivable from Participants

Notes receivable from participants are permitted, subject to current IRC statutes and regulations. The term of a loan used for the purchase of a principal residence may not exceed thirty years. The term of a loan used for any other reason may not exceed five years.

The loans are secured by the balance in the participant's account. The interest rate on loans is the prime rate as published in The Wall Street Journal on the 14th day of each month, plus two percentage points at the time of the loan. The rate is fixed for the term of the loan. Participants may borrow from their account a minimum of \$500 up to a maximum of \$50,000 reduced by the highest outstanding loan balance during the preceding 12 months or 50 percent of a participant's total account balance at the time of the loan request, whichever is less. In addition, a participant may not have more than two loans outstanding at any time. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

Retirement, Disability or Death

Participants who retire or become disabled will be entitled to 100% of their account balance. The Plan provides for normal retirement at age 65 and an early retirement age of 59½. Upon death, a participant's beneficiary will be entitled to 100% of the vested account balance, payable in accordance with the Plan Document.

Other Termination of Employment

Upon termination of employment for any reason other than retirement, disability, or death, participants shall be entitled to receive the vested amount of their account balance.

In-Service Withdrawals

While employed, participants may withdraw their contributions under the Plan upon attainment of age 59½ or in the event of financial hardship.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make assumptions and estimates that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determined the Plan's valuation policies utilizing information obtained from the Plan's Trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA and the IRC.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

3. CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, other income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the "Trustee"), qualified institution.

The Trustee also certified the information included in the Schedule of Assets (Held at End of Year).

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Funds: Represents investments in State Street Bank and Trust Company Investment Funds for Tax Exempt Retirement Plans. The investment manager of the funds is State Street Global Advisors, a division of State Street Bank. Units held in these funds are valued using the net asset value of the fund. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of a fund is calculated based on a compilation of primarily observable market information. The number of units of the fund that are outstanding on the calculation date is derived from observable purchase and redemption activity in the fund.

Stable Asset Trust: Issued by Invesco Ltd. that is composed primarily of group annuity contracts that are valued daily at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments consist of collective investment funds managed by State Street Bank and Trust Company which is the Custodian, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid for investment management services are included as a reduction of the return earned by each collective investment fund or mutual fund. Fees paid to ADP Retirement Services, the Plan's record keeper, for record keeping services amounted to \$43,668 for the year ended December 31, 2024 and are recorded in administrative expenses. Notes receivable from participants also qualify as party-in-interest transactions.

ADP provides certain administrative services to the Plan pursuant to an Administrative Services Agreement ("ASA") between the Company and ADP. ADP receives revenue from mutual fund or collective trust service providers for services ADP provides to them. This revenue is used to offset certain amounts owed to ADP for its administrative services to the Plan.

If the revenue received by ADP from such mutual fund or collective trust service providers exceeds the amount owed under the ASA, ADP remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. As of December 31, 2024 and 2023, the plan expense account balance was \$44,929 and \$32,274, respectively. During 2024, the Plan received \$71,303 under this arrangement and paid administrative fees of \$61,029.

6. TAX STATUS

The Plan adopted an ADP Prototype 401(k) and Profit-Sharing Plan, in which the Internal Revenue Service (“IRS”) stated in a letter dated July 8, 2014 that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has subsequently been amended since receiving the letter, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor (“DOL”). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to tax examinations for years prior to December 31, 2021.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

8. SUBSEQUENT EVENTS

Management has evaluated subsequent events through July 14, 2025, which is the date the financial statements were available to be issued. There were no subsequent events that require adjustment to or disclosure in the financial statements.
