Note 1. Description of the Plan

The following description of the Radiology Associates of North Texas, P.A. Cash Balance Pension Plan (Plan) provides only general information. Participants should look at the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a cash balance defined benefit plan established effective January 1, 2019 by Radiology Associates of North Texas, P.A. (Company) for the benefit of its eligible partners and specified employees of the Company. The finance committee as advised by Three Bell Capital (Three Bell), is responsible for oversight of the Plan, as well as determining the appropriateness of the Plan's investment strategy and monitoring investment performance. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Charles Schwab (Schwab) is the custodian of the Plan. FuturePlan by Ascensus is the third-party administrator.

Participant's Accounts

Under the Plan provisions, amounts are credited by the Company to each participant's hypothetical account. The accounts are allocated contribution credits each Plan year that a participant is active in the Plan, is over 21 years of age, and complete at least 1,000 hours of service while being an eligible person. Contribution credits for a Plan year are credited to the participant's hypothetical account as of the last day of the Plan year. If the participant terminates service with the Company and begins to receive retirement benefits from the Plan before the end of the Plan year, the contribution credit will be earned through the date of distribution.

Participants will be credited with the actual return for Plan investments (net of expenses) but not to exceed 6%. The rate is applied to the sum of the beginning balances and one-half of the total contributions credited during the year.

Contribution Credits

Contribution credits range from \$12,000 to \$229,000 per participant, not to exceed certain percentages of plan compensation ranging from 3% to 65%. Plan compensation is defined as W-2 wages. The plan does not permit voluntary employee contributions or rollover from other plans.

The Plan's actuaries use an applicable mortality table and an interest rate of 4% to calculate the participants cash balance account as of the valuation date projected to his or her normal retirement date. Normal retirement age is defined as the later of age 62 (not to exceed 65) or the 3rd (not to exceed 5th) anniversary of the first day of the plan year in which the employee commenced participation in the Plan.

Vesting

Vesting is measured on a plan year basis with years of service less than three years having no vesting and years of service of three or more years vesting at 100%. Participants accounts will be fully vested in the event of death, disability, or reaching normal retirement age.

Payment of Benefits

Plan participants are entitled to receive a distribution of the full amount credited to their hypothetical accounts after the participant reaches age 59½. Participants who terminate, including for reasons of death or disability, or their beneficiaries are entitled to receive up to 100% of their hypothetical account balance determined at the most recent valuation date. Payments are made in lump-sum distributions or through an annuity, as permitted by the plan.

The Plan does not permit rollovers out of the Plan and has a cashout threshold of \$1,000.

Notes Receivable from Participants

The Plan does not permit loans to participants.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds and the self-brokerage account are valued at the net asset value (NAV) of shares held by the plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. For the years ended December 31, 2024 and 2023 substantially all expenses were paid by the Company.

Note 3. Related Party Transactions and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Company provides certain administrative services at no cost to the Plan.

Certain plan investments are shares of mutual funds, managed by Charles Schwab. Charles Schwab is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. The plan sponsor pays directly any other fees related to the Plan's operations. The Plan invests in certain funds of the Plan custodian.

Note 4. Accumulated Plan Benefits

Accumulated plan benefits are those future benefit payments that are attributable under the Plan's provisions to employees' service and compensation rendered to the benefit valuation date below. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits payable under all circumstance - retirement, death, disability, and termination of employment are included, to the extent they are deemed attributable to employee service rendered through the benefit valuation date.

The actuarial present value of accumulated plan benefits is determined by an independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuation as of January 1, 2025, was (a) average-assumed retirement age (65), (b) life expectancy of participants (RP-2014 combined Mortality tables for males and females projected to 2025), and (c) assumed interest credit rate 4% per annum.

The computations of the actuarial present value of accumulated plan benefits have been made as of the beginning of the year, January 1, 2025. Had the valuation been performed as of December 31, there would be no material differences.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value.

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan held no Level 3 securities at December 31, 2024 and 2023.

Note 6. Tax Status

The Plan has received a determination letter from the Internal Revenue Service dated September 22, 2020, stating that the Plan and the Trust established under the Plan, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax. There have been no major subsequent amendments that would cause a change in determination.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances, and the amounts reported in the accompanying statements of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 9. Subsequent Events

Subsequent events have been evaluated through July 15, 2025, which is the date the financial statements were available to be issued.
