Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the financial statements of Veenstra & Kimm, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (Financial Statements).

(1) Description of Plan

The following description of the Veenstra & Kimm, Inc. Profit Sharing Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, covering employees of Veenstra & Kimm, Inc. (the Employer), who have completed three months of service as defined by the Plan agreement. The plan sponsor appointed trustees are responsible for the oversight of the Plan. The plan sponsor appointed trustees determine the appropriateness of the Plan's investment offerings and monitor investment performance. The Plan is subject to the provisions of ERISA.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation as defined in the Plan agreement, subject to qualified limitations. Participants who have attained age 50 before the end of the Plan year, are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts, mutual funds, common / collective trusts and guaranteed interest contracts as investment options for participants. The Plan contains an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6 percent of eligible compensation and the deferral rate will annually increase by 1 percent of eligible compensation up to a maximum of 15% unless the participant designates otherwise. Automatically enrolled participants will have their contributions invested in a designated balanced fund until changed by the participant.

The Employer contributes 50% of the first 6% of eligible compensation that a participant contributes to the Plan. Additional profit-sharing amounts may be contributed at the option of the Employer's board of directors. Participants are eligible for the Employer's profit-sharing contribution if they are active participants at the end of the Plan year and have 700 or more hours of service as defined by the Plan agreement. Employer profit sharing contributions are allocated to eligible participants' accounts based at 3.0% of eligible participant's compensation as defined by the Plan agreement. The Employer made profit sharing contributions of \$679,382 and \$674,123 for the years ended December 31, 2024 and 2023, respectively. Participants may change their investment options daily. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant

transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vesting in their own contributions plus any earnings (losses) thereon. Vesting in the Employer's contribution portion of their accounts is based on continuous years of service. A participant is 50% vested after one year of service, as defined, and continues to vest 10% each consecutive year until 100% vested after six years of service.

Notes Receivable from Participants

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account, mature through November of 2029, and bear interest at 5%, which is commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably monthly through payroll deductions.

Payment of Benefits

Participants or their beneficiaries are eligible for benefits upon retirement (age 65) or early retirement (age 55), termination of employment, death or disability. Participant account balances totaling \$5,000 or less are distributed in a lump-sum payment amount equal to the vested balance in the participant's account.

Participants with vested account balances greater than \$5,000 will be paid under one or more of the optional forms available under the Plan, which include a lump sum payment or the purchase of an annuity contract. The amount of payment from an annuity contract will depend on the participant's vested account balance, the participant's age, the age of the participant's survivor, and the payment option selected.

Forfeited Accounts

During the year ended December 31, 2024, forfeited non-vested accounts totaling \$20,527 were reallocated to participant accounts in the same manner as the Employer's discretionary contributions. As of December 31, 2024, and 2023 the Plan's forfeiture account balance was \$351 and \$5, respectively.

(2) Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported

amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by investment advisers and Principal. See note 9 for discussion of fair value measurements.

The Plan has investment contracts with Principal Life Insurance Company. Principal Life Insurance Company maintains the Plan's deposits in an unallocated fund, to which it adds interest at the contract rates ranging from .83% to 5.68% as of December 31, 2024 and 2023. Deposits into these contracts are guaranteed the contract rate of return. The average interest rate earned for the year ended December 31, 2024 was approximately 4.76%.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan management has evaluated subsequent events through July 16, 2025, the date the financial statements were available to be issued.

(4) Fixed Income Guaranteed Option Contract with Principal

The Plan has entered into a fully benefit-responsive investment contract with Principal Life Insurance Company (PLIC). PLIC maintains the contributions in a general account. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of contract. Contract value represents

contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The contract value of the Principal Fixed Income Guaranteed Option investment contract at December 31, 2024 was \$1,493,968.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its contractual obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events, such as the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code, premature termination of the investment contract by the Plan or termination of the Plan, would limit the Plan's ability to transact at contract value with Principal. The Plan Administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value with participants is unlikely.

(5) Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of common / collective trusts, pooled separate accounts and guaranteed interest contracts managed by Principal Life Insurance Company (Principal). Principal is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments to Principal of approximately \$143,200 for the year ended December 31, 2024, which was not covered by revenue sharing. The Plan Sponsor pays directly other fees related to Plan operations.

(6) Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the Employer contributions portion of their account.

(7) Tax Status

The Plan is based on a prototype plan which has received a letter from the Internal Revenue Service stating that the prototype Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue (IRC). Although the Plan has been amended since receiving the letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of these investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(9) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are shown as Level 1.

Common/Collective Trust Funds: Common/collective trust funds are composed of investment contracts that are valued at the net asset value of the units of the common/collective trusts. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur immediately. If the Plan initiates a full redemption of the collective trust, no notice to the issuer is required. Investments in common/collective trust funds are not classified according to fair value hierarchy, in accordance with ASU 820, as the net asset value is used as a practical expedient to value the investment.

Pooled Separate Accounts: The net asset value is used as a practical expedient to determine fair value for all pooled separate accounts. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Each pooled separate account provides for redemptions by the Plan at the net asset value per share, with no advance notice requirement. Investments in pooled separate accounts are not classified according to fair value hierarchy, in accordance with ASU 820, as the net asset value is used as a practical expedient to value the investment.

Guaranteed Interest Contracts: Guaranteed interest contracts are valued at fair value by Principal by using the discontinuance value, which is the value Plan participants will receive if they transfer or surrender their funds out of the guaranteed interest contracts. This can be in the form of account value less either a market value adjustment which moves with market interest rates or a flat discontinuance charge. In determining the reasonableness of the methodology, the Plan's trustees evaluate a variety of factors including review of existing contracts, economic conditions, industry developments, and overall credit ratings. Certain unobservable inputs are assessed through review of the contract terms while others are substantiated utilizing available market data.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
