### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of John Boos & Co. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

**Note 1 - Plan Description**

The following description of John Boos & Co. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering all eligible employees of John Boos & Co.; John Boos & Co. Nevada; and BK Resources, Inc. (collectively, the "Company") who have completed six months of service. Prior to January 1, 2024, the Plan also covered all eligible employees of Diversified Woodcrafts, Inc. Effective January 1, 2024, the Plan was amended to remove Diversified Woodcrafts, Inc. as a participating employer.

Participation in the Plan may begin on the first day of each calendar quarter after satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

The Plan provides for employee salary 401(k) contributions on a pretax basis from 3 to 50 percent of employees' eligible compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions in addition to their regular deferral contributions. Participants may designate all or a portion of their contributions as Roth deferral contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provided for employer matching contributions equal to 100 percent of the first 3 percent (in relation to compensation) of each participant's deferral contribution.

Effective January 1, 2024, the Plan was amended to adopt employer safe harbor matching contributions. Under the amendment, the Company provides for safe harbor matching contributions equal to the sum of 100 percent of the participant's elective deferrals that do not exceed 3 percent of the participant's compensation, plus 50 percent of the amount of the participant's elective deferrals that exceed 3 percent of the participant's compensation but do not exceed 5 percent of the participant's compensation.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, plan earnings, and forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

***Benefit Payments***

Distributions are generally payable upon retirement, death, disability, hardship, or termination of employment in the form of a partial payment, installment payment, annuity contract, or lump-sum amount equal to the vested balance of a participant's account. Vested account balances less than \$1,000 are paid in a single lump sum upon termination. However, participants with a balance greater than \$1,000 may elect to defer commencement of distributions until April of the calendar year after they attain the age of 70½. Benefits may also be paid directly to an eligible retirement plan as an eligible rollover distribution. In-service distributions are allowed once a participant attains age 59½.

Participants may request that all or a portion of their accounts be distributed in the case of severe financial hardship, as defined in the plan document. The Company must approve any such hardship withdrawals.

**Note 1 - Plan Description (Continued)**

***Vesting***

Participants are immediately 100 percent vested in their employee salary contributions, rollover contributions, employer safe harbor matching contributions, and any income or loss thereon. In the event of a participant's death, permanent disability, or cessation of employment on or after the normal retirement date, the participant's share in the Plan becomes fully vested and nonforfeitable.

Vesting in the Company's non-safe harbor matching contribution portion of the participants' accounts is determined in accordance with the following schedule:

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. At December 31, 2024 and 2023, unallocated forfeited account balances were insignificant. The Company may use forfeitures to pay administrative expenses. Remaining forfeitures are allocated to participants based on compensation, as defined. Allocations of forfeitures are considered additional company contributions and are subject to the vesting provisions above.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Company.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Transfers***

Effective January 1, 2024, the Company sold substantially all assets of Diversified Woodcrafts, Inc. to an entity under common control. As discussed in Note 1, the Plan was amended effective February 1, 2024 to remove Diversified Woodcrafts, Inc. as a participating employer in the Plan. All assets, participants, and related account balances totaling \$5,169,682 were transferred from the Plan, which is presented as a separate line item on the accompanying statement of changes in net assets available for benefits.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including July 17, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Reliance Trust Company (the "Trustee") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Note 4 - Fair Value Measurements (Continued)**

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

**Common/Collective Trust Fund**

The common/collective trust fund is valued at net asset value (NAV) per share or its equivalent of the fund, which is based on the fair value of the fund's underlying assets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
