#### 1. DESCRIPTION OF PLAN AND SUMMARY OF ACCOUNTING POLICIES

The following description of the ThoughtSpot, Inc. 401(k) Profit Sharing Plan and Trust provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Plan was adopted by ThoughtSpot, Inc. (the “Company”) on January 1, 2013. The Plan was most recently restated on June 1, 2022 and amended on November 1, 2023. The Plan is defined as a contribution retirement plan of the profit-sharing type containing a cash or deferred arrangement described in Internal Revenue Code (“IRC”) Section 401(k). The following employees are not eligible to participate in the Plan: Collective Bargaining Employees, Non-Resident Aliens, IRC Section 410(b)(6)(c) Transaction Employees. All other employees of the Company are eligible to participate in the Plan upon employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and certain provisions of the IRC.

**Basis of Accounting** – The Plan’s financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

**Administration** – The Company is the Plan Administrator and controls the operation and administration of the Plan. The Company also utilizes the services of an independent third party administrator and independent investment advisor to determine the investment options available to Participants and to monitor the performance of those investments. Reliance Trust Company (“Reliance”) is the Plan’s investment custodian and trustee.

**Participant Contributions** – Each year, participants may contribute a portion of pretax annual compensation, as defined in the Plan, up to the maximum allowed by law. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

**Employer Contributions** – The Company may elect to make discretionary profit sharing contributions to the Plan. Participants must be over the age of 21, complete a minimum of 1,000 hours of service during the year and be employed on the last day of the Plan year to share in Company profit sharing contributions. Profit sharing contributions, if any, are allocated to participants based on their age and compensation. The Company made no discretionary matching or profit sharing contributions for the year ended December 31, 2024.

***Participant Accounts*** – A separate account is maintained for each participant. Each participant’s account is credited with the participant’s voluntary contributions, employer contributions and an allocation of Plan earnings, less withdrawals, distributions and administrative expenses, if any. Participants direct the investment of their contributions into the various investment options offered by the Plan. Investment income allocations are made daily based on participant account balances. The benefit to which a participant is entitled is limited to the benefit that may be provided from the participant’s vested account balance.

***Vesting*** – Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting with respect to employer profit sharing contributions, if any, plus actual earnings thereon, is based on years of service. Participants generally become fully vested ratably over a six-year period. Participants become fully vested in all accounts upon retirement, death, disability or Plan termination.

***Forfeited Accounts*** – Forfeited non-vested accounts may be used to reduce future employer contributions or to pay expenses of the Plan. At December 31, 2024 and 2023, the Plan had no unallocated forfeitures. During 2024, no forfeitures were used to reduce employer contributions or to pay administrative expenses of the Plan.

***Notes Receivable From Participants*** – The Plan provides a provision that allows a participant to borrow up to the lesser of \$50,000 or 50% of their vested account balance subject to a minimum of \$1,000. Participants may have two outstanding loans at a time. Such loans shall bear interest at rates at commercially reasonable rates, which are generally equivalent to available market financing rates. The specific terms and conditions of such loans will be established by the Plan Administrator. The loans are secured by the participant’s vested account balance. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are stated at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are reported as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement.

***Investments*** - Investments of the Plan are held by the Plan’s custodian and are invested in mutual funds and a money market fund based solely upon instructions from participants. Investments of the Plan consist of the following:

***Mutual funds*** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are valued at fair value as of the last day of the Plan year, as measured by quoted market prices on an established exchange.

***Money market fund*** – Money market funds are valued based on redemption values on the last business day of the Plan Year.

The Plan's investments are valued at fair value in accordance with U.S. GAAP, which establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

**Investment Income** – Realized gains or losses on investment transactions are recorded as the difference between the proceeds received and the fair value of the investment at the beginning of the Plan year, or cost of acquired during the Plan year. Net unrealized appreciation or depreciation consists of both realized and unrealized gains and losses and is included in the statement of changes in net assets in the period in which the market change occurs. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

***Payment of Benefits*** – Benefits are recorded when paid. Participant account balances can be distributed prior to termination or retirement age for hardship claims, death or disability as defined in the Plan agreement. On termination or service due to death, disability or retirement, a participant will receive an amount equal to the value of the vested interest in their account. For termination of service due to other reasons, a participant may also receive the value of the vested interest in their account as a lump sum distribution. On termination of service for account balances less than \$5,000, a lump-sum distribution may be made at the employer's discretion. For account balances, greater than \$5,000, written consent by the employee is required before distributions can be made.

The normal retirement age under the Plan is age 65. Participants who have reached age 59 ½ may take an in-service distribution subject to Plan provisions.

***Excess Contributions Payable*** – Excess contributions payable represent excess salary deferral contributions to be refunded by the Plan to participants in order to satisfy the relevant non-discrimination provisions of ERISA.

***Administrative Expenses*** – All reasonable expenses of administering the Plan may be paid out of the Plan assets or directly by the Company. The majority of Plan expenses were paid by the Plan for the year ended December 31, 2024.

***Use of Estimates*** - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reported period. Actual results could differ from these estimates.

***Subsequent Events*** – The Plan's management evaluates events or transactions occurring after the statement of net assets available for plan benefits date but before the financial statements are available to be issued for potential recognition or disclosure. The financial statements include all subsequent events considered necessary for a fair presentation. Events or transactions occurring subsequent to year end through the date the financial statements were available to be issued, July 11, 2025, have been evaluated in the preparation of the accompanying financial statements.

## **2. INCOME TAX STATUS**

The Internal Revenue Service has determined and informed the Company in writing by a letter dated October 6, 2020 that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has been restated and amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

#### 4. PRIORITIES ON TERMINATION

The Company has established the Plan with the intention and expectation that the Plan will continue indefinitely. However, the Company reserves the right at any time to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, distributions will be made to participants as described in the Plan agreement, and participants would become 100% vested in their employer contributions.

#### 5. RELATED PARTY TRANSACTIONS

Certain Plan investments in mutual funds and a money market fund are managed by Reliance, the investment custodian and trustee of the Plan, or their affiliates. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan, and are specifically exempt the prohibition of party-in-interest under ERISA.

#### 6. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination of mutual funds offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**7. NONEXEMPT TRANSACTION**

During 2023, an employee salary deferral contribution of \$7,588 was not remitted to the Plan in a timely manner. The Plan Sponsor corrected the delinquent contribution by remitting the salary deferral plus lost earnings to the account of the affected participant in 2024.
